Overview from an Independent Perspective



The Province of Ontario is currently under a Liberal government headed by Premier Dalton McGuinty. The present government, first elected in 2003, was re-elected on October 10th, 2007. It is affectionately called the **McGuinty-Ontario-Environmental-Terror-Regime**. This regime is the POLITICAL SHIELD for the Environmental-Terror-Movement, and is its LEGISLATIVE INSTRUMENT of PROHIBITION POLICY. The actions of this government are viewed as a form of TERROR against the Green Space Industry.

The McGuinty-Ontario-Enviro-Terror-Regime passed legislation implementing a « *cosmetic pesticides ban* » that took effect April 22nd, 2009. The requirements of the prohibition are detailed in **Ontario Regulation 63/09** and the Pesticides Act, which was amended by the Cosmetic Pesticides Ban Act.

The RAPE, ASSAULT, and TERROR against the Green Space Industry by the McGuinty-Ontario-Enviro-Terror-Regime **DID NOT** stop here.

Next ... the implementation of DESTRUCTIVE program of FEES and TAXES for **ALL** types of fertilizers. In 2010, the McGuinty-Ontario-Enviro-Terror-Regime imposed the Municipal Hazardous or Special Waste Program Plan (M.H.S.W.) and Harmonized Sales Tax (H.S.T.).

Under the NEEDLESS, SENSELESS, and MALICIOUS M.H.S.W. program, the fertilizer companies are being COERCED into paying the entire cost of so-called FERTILIZER WASTE. This cost will then be PASSED ON to the end-users in the Green Space Industry. Consequently, the Green Space Industry is being forced to spend even more of its limited financial resources on fertilizers.

M.H.S.W. is NOT a program for protecting the environment. M.H.S.W. is a PLOY that ensures money and employment for Coercive-Enviro-Maniac-Government-Officials. With M.H.S.W., these Enviro-Maniac-Basterds have guaranteed themselves SAFE, SECURE, GUARANTEED, and WELL-PAYING ENVIRO-TERROR-JOBS **at the expense of the Green Space Industry**. The RAPE, ASSAULT, and TERROR against the Green Space Industry by the McGuinty-Ontario-Enviro-Terror-Regime continues to be ENDLESS.

John Gerretsen is the Minister responsible for the M.H.S.W. He is the Master-Basterd-Enviro-Maniac-Minister who imposed the prohibition of pest control products through the concoction of FEAR-MONGERING, FRAUDULENT LIES, MIS-CONCEPTIONS, COERCION, THREATS, DECEPTIONS, TERROR, and PARANOID CONSPIRACIES. The same strategies are now being used AGAINST fertilizers.

There are serious issues with Gerretsen, who has been INDISCREET with his close public ties with Enviro-Maniac-Activists, raising the question about the radical interests of the Enviro-Lobby taking precedence.

In January 2010, the Green Space Industry outlined the LIST OF CHARGES against the McGuinty-Ontario-Enviro-Terror-Regime and the Ministry of the Environment. Additionally, individual Enviro-Maniac members of Environmental-Terror-Organizations are also facing FRAUD CHARGES under the Canadian Criminal Code. The legal challenge is being organized by Jeffrey Lowes and M-REP Communications.

Municipal Hazardous or Special Waste Program Plan (M.H.S.W.) specifically targets small businesses, as well as home-owners. M.H.S.W. is an extension of the consumer blue box/municipal hazardous waste collection programs. Moreover, **M.H.S.W. imposes DESTRUCTIVE FERTILIZER FEES.**

M.H.S.W. IMPOSES DESTRUCTIVE FEES on products such as ... Aerosols. Anti-Freeze. Batteries. Corrosives. Domestic Class Pesticides. **Fertilizers.** Flammables or Toxic Materials. Oils. Paints. Solvents.

M.H.S.W. program costs are funded by those industries that produce and use the materials.

The BLOATED budget of the Municipal Hazardous or Special Waste Program Plan (M.H.S.W.) is **1.7-million-dollars** per year, which will be covered by **an increase in the cost of fertilizer paid by the end-users.**

M.H.S.W. IMPOSES DESTRUCTIVE FEES on ALL PACKAGED FERTILIZER PRODUCTS (including manure/compost), in **30-kilogram-packages and under**, that make a PLANT NUTRIENT CLAIM, whether federally-registered or not.

The DESTRUCTIVE M.H.S.W. FEE will increase the cost by at least **FIFTY-EIGHT CENTS per 25-kilogram-bag** of fertilizer and manure/compost sold in Ontario. This DESTRUCTIVE FEE WILL BE INCREASED over time.

It should be noted that since the Coercive-Enviro-Maniac-Government-Officials at Stewardship Ontario have **NO REAL DATA** to base this cost to handle fertilizer, the M.H.S.W. program is leaving the cost as entirely open ended. They will collect this **FIFTY-EIGHT CENTS** from the end-user or manufacturer, and will « *adjust* » (i.e. increase) the cost later.

M.H.S.W. IMPOSES DESTRUCTIVE FEES on a WIDE number of groups, including the HATED Golf Industry.

The Coercive-Enviro-Maniac-Government-Officials wanted to SPECIFICALLY ENSURE that the HATED Golf Industry was NOT excepted from this program.

Since the prohibition of pest control products in Ontario, Coercive-Enviro-Maniac-Government-Officials understand full well that **THERE IS NO UNITY** within the Green Space Industry.

Soon after the taste of victory with the obliteration the Professional Lawn Care Industry through the prohibition of its pest control products, the HATED Golf Industry is now specifically targeted in the next round of attacks.

Now, the Golf Industry is totally alone, and devoid of **ANY** allies to help defend itself.

H.S.T. WILL INCREASE THE COST OF FERTILIZER BY
ONE-DOLLAR-AND-TWENTY-FIVE-CENTS
PER 25-KILOGRAM-BAG OR MORE

HARMONIZED SALES TAX (H.S.T.).

In addition to the DESTRUCTIVE M.H.S.W. FEE imposed by the Municipal Hazardous or Special Waste Program, the McGuinty-Ontario-Environmental-Terror regime has also targeted the Green Space Industry with its **Harmonized Sales Tax (H.S.T.)**.

Previously, a Professional Lawn Care company or golf course would pay **8 per cent** PROVINCIAL SALES TAX (P.S.T.) on fertilizer. However, there was **NO** FEDERAL GOODS AND SERVICES TAX (G.S.T.) of **5 per cent** on bags **25-kilograms or larger**, if over **500 kg** was purchased. This essentially provided an **EXCEPTION** to most professional end-users.



Now, with Harmonized Sales Tax (H.S.T.), professional end-users will be paying **5 per cent more** for their fertilizer. A **25-kilogram-bag** of fertilizer will now cost an **EXTRA \$1.25** ... all because of the McGuinty-Ontario-Environmental-Terror-Regime's Harmonized Sales Tax (H.S.T.).

The Exceptions to the H.S.T. Program ...

Several professional end-users that originally benefitted from an EXCEPTION STATUS on tax will face additional hardships. The exception status will be **REVOKED** from several groups, in particular the **Golf Industry**.

Just like it did with the prohibition of pest control products, the Government of Ontario and the McGuinty-Environmental-Terror-Regime have unfairly discriminated by providing Harmonized Sales Tax (H.S.T.) EXCEPTIONS to certain end-user groups —

- AGRICULTURE — Exception maintained.
- FORESTRY — Exception maintained.
- **Golf courses** — Exception **REVOKED**.
- GREENHOUSE PRODUCTION — Exception **REVOKED**.
- HOMEOWNERS — **NO** Exception since they ALWAYS paid BOTH taxes.
- LAWN BOWLING — Exception **REVOKED**.
- NURSERY PRODUCTION — Exception **REVOKED**.
- **Professional Lawn Care** — **NO** Exception.
- SOD GROWERS — Exception maintained.
- SPORTS FIELDS — **NO** Exception.

Summary of the repercussions of the Municipal Hazardous and Special Waste Program Plan (M.H.S.W.) and Harmonized Sales Tax (H.S.T.).

The Ontario Municipal Hazardous and Special Waste Program Fee (M.H.S.W.) will increase the cost of fertilizer by at least **FIFTY-EIGHT CENTS** per 25-kilogram-bag.

The Ontario Harmonized Sales Tax (H.S.T.) will increase the cost of fertilizer by at least **ONE-DOLLAR-AND-TWENTY-FIVE-CENTS** per 25-kilogram-bag.

Beginning in 2010, fertilizer sold in Ontario to the Green Space Industry may be subject with an increase of at least **50 TO 75 DOLLARS PER METRIC TON**.

In the Golf Industry, an 18-hole-golf course requiring **30 metric tons** per year will need to increase its fertilizer budget by **OVER TWO THOUSAND DOLLARS**.

⊗ **PREDICTION** : The Government of Ontario and the McGuinty-Ontario-Enviro-Terror-Regime will have to face **LEGAL CHALLENGES** from the Fertilizer Industry that will be seeking damages because of **NEEDLESS, SENSELESS, and MALICIOUS** Special Waste Program Plan (M.H.S.W.) and Harmonized Sales Tax (H.S.T.) !

Mr. Gathercole has supervised, consulted, programmed, and/or overseen the execution of HUNDREDS OF THOUSANDS of pest control applications in the urban landscape. For many years, Mr. Gathercole was a contributing columnist for TURF & Recreation Magazine, Canada's Turf and Grounds Maintenance Authority. Mr. Gathercole followed the evolution of ENVIRONMENTAL TERRORISM for over a quarter century.
