# Ontario Fertilizer Terror

## Part 1



### Background Information from an Independent Perspective

Ontario ( pronounced /ɒnˈtæəri.əs/ ) is a province located in east-central Canada, the largest by population[ and second largest, after Quebec, in total area. ( Nunavut and the Northwest Territories are larger but are not provinces. ) Ontario is bordered by the provinces of Manitoba to the west and Quebec to the east, and the U.S. states (from west to east) of Minnesota, Michigan, Ohio and Pennsylvania ( both across Lake Erie ), and New York to the south and east. Most of Ontario's borders with the United States are

natural, starting at the Lake of the Woods and continuing through four of the Great Lakes: Superior, Huron ( which includes Georgian Bay ), Erie, and Ontario, then along the Saint Lawrence River near Cornwall. Ontario is the only Canadian province that borders the Great Lakes. For analytical purposes, Ontario is often broken into two regions, Northern Ontario, and Southern Ontario.

The capital of Ontario is Toronto, Canada's most populous city and metropolitan area. Ottawa, the capital of Canada, is located in Ontario as well. The 2006 Census counted 12,960,282 residents in Ontario, which accounted for 38.5% of the Canadian population.

The province takes its name from Lake Ontario, which is thought to be derived from Ontari:io, a Huron ( Wyandot ) word meaning " great lake ", or possibly skanadario which means " beautiful water " in Iroquoian. Along with New Brunswick, Nova Scotia and Quebec, Ontario is one of the four original provinces of Canada when the federal nation was created July 1, 1867, when the British North America Act, 1867 ( or ' BNA ' ) came into force. Upon achievement of full independence from the United Kingdom in 1982, the BNA was re-christened the Constitution Act, 1867.

Ontario is Canada's is currently a HAVEN for the Environmental-Terror-Movement. Ontario passed legislation implementing a " Cosmetic Pesticides Ban " that took effect APRIL 22<sup>nd</sup>, 2009. The requirements of the prohibition are detailed in Ontario Regulation 63/09 and the Pesticides Act, which was amended by the Cosmetic Pesticides Ban Act, 2008. The legislation generally prohibits the sale and use of pesticides for cosmetic ( i.e. " non-essential " ) purposes — excluding golf courses, some sports fields, specialty turf, forestry and agriculture

Ontario is currently under a Liberal government headed by Premier **Dalton McGuinty**, a former biologist. The present government, first elected in 2003, was re-elected on October 10<sup>th</sup>, 2007. It is affectionately called the McGuinty-Ontario-Enviro-Terror-Regime.

In JANUARY 2010, the Green Space Industry outlined the list of charges against the McGuinty-Ontario-Enviro-Terror-Regime and Enviro-Maniac-Government-Officials working in the Ministry of the Environment. Additionally, individual Enviro-Maniac-Activist-Members of known Environmental-Terror-Organizations are also facing charges of FRAUD under the Canadian Criminal Code. These Enviro-Maniacs conspired with Government Officials by using DISGRACEFULLY FALSE and MISLEADING information in order to impede access to Health-Canada-Approved products through FRAUDULENT MEANS. 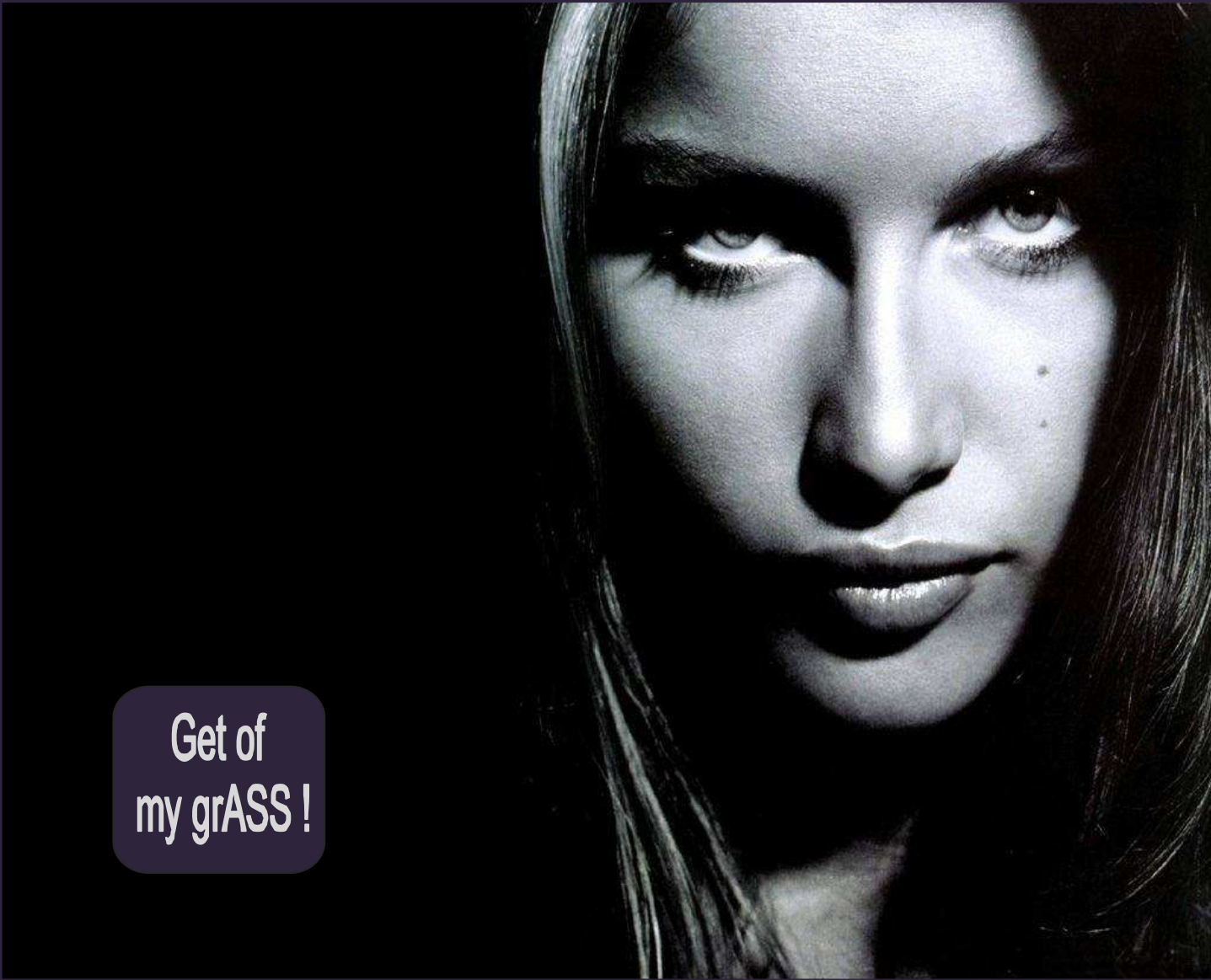
