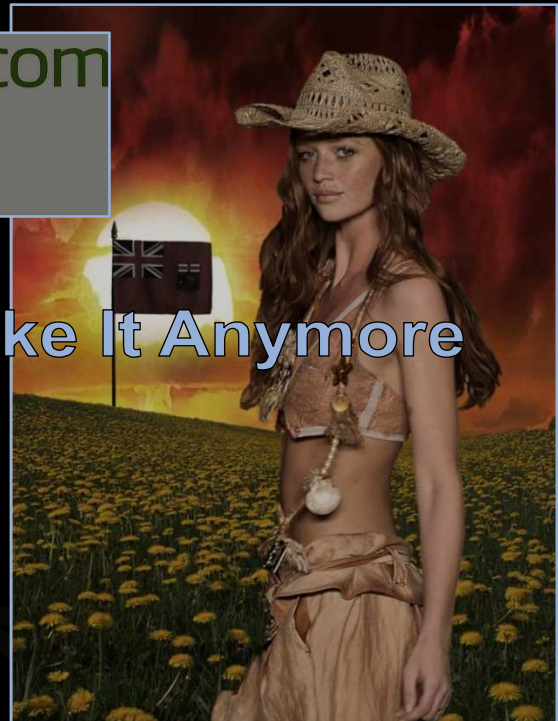

This is because NO ONE within the Government of Manitoba has ANY recognized training, background, or experience in matters concerning pest control products.

Children At Risk ?!?! ---

Gord Mackintosh, Manitoba's Anti-Pesticide Conservation and Water Stewardship Minister, said a decision on a long-discussed ARBITRARY PROHIBITION against pest control products is IMMINENT.

According to Mackintosh on June 4th, 2013 —

We have to move now in the next few weeks to announce publicly what we plan to do.

There certainly is a range of options available to help reduce synthetic chemical pesticide exposure, particularly in CHILDREN. [?!?!]

FALSE REASSURANCES About Alternatives

Manitoba's Anti-Pesticide Political Leaders, like Gord Macintosh, ATTEMPT TO FALSELY REASSURE EVERYONE that so-called safe and effective Green Alternative Pesticides were/are already available to replace conventional pest control products. [WRONG !]

According to Gord Mackintosh, Manitoba's Anti-Pesticide Conservation and Water Stewardship Minister, concerning so-called Green Alternative Pesticides (a.k.a. organic pesticides or bio-pesticides) —

There is a blossoming market of what is called bio-pesticides.

Clearly, the market is changing very rapidly.

Alternatives Are DISMAL FAILURES

Despite claims to the contrary, overall, there are NO viable, efficacious, economical, or low-risk alternatives to replace conventional pest control products.

It is **WRONGLY ASSUMED THAT ALTERNATIVES** are somehow safer and work as well as conventional products.

Since 2009, in the Province of Ontario, home-owners and professionals have been **FORCED TO RELY UPON INFERIOR GREEN ALTERNATIVE PESTICIDES** because of the **ARBITRARY PROVINCIAL PROHIBITION** against conventional pest control products.

There is little debate about the fact that Ontario's 2009 **PROVINCIAL PROHIBITION** is a **DISMAL FAILURE**, and converted communities into **SHABBIER AND DANGEROUS PEST-INFESTED GARBAGE DUMPS**.

It was/is **IMPOSSIBLE** to control **DAMAGING PESTS OF TURF AND ORNAMENTALS** without conventional pest control products.

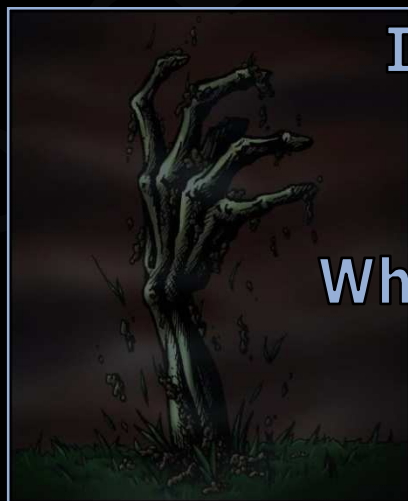
