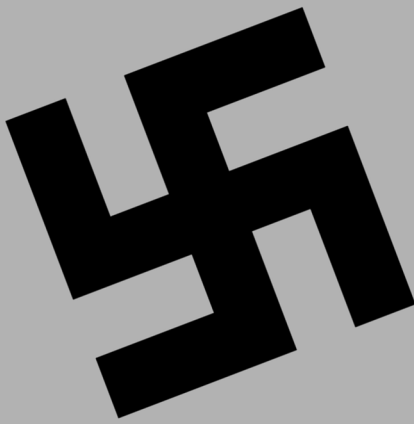

# The Pesticide Spray Advisory ... Enviro-Lunatic Nazi Informant Service Designed to Rat-Out and Terrorize Lawn Care Companies



In Saint John's, whenever a pest control product is to be applied, the applicator must give verbal or written notification to all neighbouring properties within 15 meters 24 hours in advance of the spray activity.

The notification must include the common name/trade name of the pest control product, the active ingredient ( s ), and the type of pest controlled.

*<< If you see a company or individual applying pesticides in violation to any regulations, you can immediately call the pesticide control department to try and stop the activity and file a report to the Department of Environment & Conservation.
