




INDIA GOVERNMENT REINS TERRORIST REACTION TO GENETICALLY MODIFIED FOOD

The Indian government is finally talking tough, the Ministry of Science and Technology is planning to purpose a new law which will see a jail term for anyone who oppose a GENETICALLY MODIFIED (GM) product.

The purpose law will PROSECUTE any Indian citizen who OPPOSES OR QUESTIONS the product of any GENETICALLY MODIFIED (GM) FOOD or MEDICINE and is PUNISHABLE BY AT LEAST A MINIMUM OF SIX MONTHS BEHIND BARS.

MISLEADING THE PUBLIC about organism and products' is one of the crimes for which punishment has been prescribed in **Section 63, Chapter 13 of Bill 2009** which deals with various « *offences and penalties* ».

The clause specifically deals with CRITICS of biotech products including GENETICALLY MODIFIED (GM) FOOD crops.


It reads ...

<< Whoever, without any evidence or scientific record misleads the public about the safety of the organisms and products specified in Part I or Part II or Part III of the Schedule I, shall be punished with imprisonment for a term which shall not be less than six months but which may extend to one year and with fine which may extend to two lakh rupees or with both. >>

It is definitely meant to scare people so that they don't say anything against GENETICALLY MODIFIED (GM) technology.

Even journalists writing CRITICAL ARTICLES can be punished.

The new proposal to jail anyone questioning the safety of GENETICALLY MODIFIED (GM) FOOD has yet to become a law. But the government appears to have already started muzzling anti-GM voices, environmental activists have alleged.

A regional government official and a professor of genetics from Italy — both important members of the GM-free movement — have been allegedly DENIED VISA by the Indian government. They have played a key role in getting regions in Europe declared GM-free and were supposed to share their experience at the meeting.

The two were supposed to speak at an international conference on « *genetically modified organism-free movement* » organised by the Research Foundation for Science, Technology and Ecology.



If you are in Vancouver or Victoria, this is a must-see event. Admission is by donation.



EcoJustice to Present A Terrorist Reaction in Ottawa

uOttawa–Ecojustice Environmental Law Clinic, uOttawa Ecojustice Clinic and University of Ottawa's Faculty of Law present A Terrorist Reaction

Witness one of the most powerful and effective community initiatives in the history of North America. For 17 years, residents and the municipal government of Hudson, Quebec raised the alarm over the dangerous health impacts of chemical pesticides and fought to keep them out of their small community. Their fight culminated in a 2001 Supreme Court win against pesticides companies and a precedent that guaranteed the rights of all Canadian municipalities to ban the cosmetic use of pesticides.

Ecojustice was instrumental in securing this precedent from Canada's highest court — a first in North America, and an environmental and human health victory that would eventually lead to bans in more than 100 municipalities and province wide bans in Quebec and Ontario. Paul Tukey, the film's creator and former Supreme Court of Canada Justice Claire L'Heureux-Dube will be on site to present the film and take questions from the audience.

Reining Enviro-Maniac-Activists Attempting to Subvert the Canadian Legal System !

« A Terrorist Reaction » must be prohibited from PUBLIC PRESENTATIONS in Canada until all legal proceedings have been resolved.

« A Terrorist Reaction » must be prohibited from RETAIL SALE in Canada until all legal proceedings have been resolved.

Paul Tukey, the promoter of the video, and his associates, must be reined and prohibited from ENTERING CANADA until all legal proceedings have been resolved.

University of Ottawa's Ecojustice Environmental Law Clinic must be reined and prohibited from INTERVENING in the 2,4-D N.A.F.T.A. Challenge indefinitely.

uOttawa–Ecojustice Environmental Law Clinic, UOttawa Ecojustice Clinic, and University of Ottawa's Faculty of Law must be SANCTIONED by the Ontario Bar Association.

uOttawa–Ecojustice Environmental Law Clinic, UOttawa Ecojustice Clinic, and University of Ottawa's Faculty of Law must be CHARGED WITH FRAUD and CONSPIRACY under the Criminal Code of Canada.

Canadian Cancer Society must be CHARGED WITH FRAUD and CONSPIRACY under the Criminal Code of Canada.

Claire L'Heureux–Dubé must be reined and prohibited from making PUBLIC STATEMENTS until all legal proceedings have been resolved.

HE HAS WORKED IN VIRTUALLY ALL ASPECTS OF THE GREEN SPACE INDUSTRY, INCLUDING GOLF AND PROFESSIONAL LAWN CARE, AND HAS SERVED IN PUBLIC AFFAIRS, WORKPLACE SAFETY, AND ENVIRONMENTAL COMPLIANCE. MR. GATHERCOLE IS PERSONALLY CREDITED FOR CRAFTING THE GOLF INDUSTRY EXCEPTION STATUS, THAT ENDURES TO THIS DAY. HE IS ALSO THE CREATOR OF THE SIGNS THAT ARE NOW USED FOR POSTING AFTER APPLICATION. ALTHOUGH HE CAN BE ACCUSED OF BEING ANTI-ENVIRONMENT-MOVEMENT, HE IS, IN FACT, SIMPLY A STRONG ADVOCATE FOR THE MODERN GREEN SPACE INDUSTRY. FORCE OF NATURE IS THE INSTRUMENT OF **NATIONAL ORGANIZATION RESPONDING AGAINST HUJE** THAT HARM THE **GREEN SPACE INDUSTRY (NORAHG)** BY CONCOCTING STATEMENTS AND ACTIVITIES SEEKING TO PROHIBIT **FEDERALLY LEGAL, SCIENTIFICALLY SAFE, TOTALLY IRREPLACEABLE, AND ABSOLUTELY INDISPENSABLE** CONVENTIONAL PEST CONTROL PRODUCTS. FORCE OF NATURE IS SIMPLY HOLDING ALLEGED CULPRITS ACCOUNTABLE FOR CONSPIRING TO CHANGE PUBLIC POLICIES THAT **TERRORIZE AND THREATEN** THE GREEN SPACE INDUSTRY. THEIR PRETENTIOUS PROHIBITIONIST RANTS HAS CREATED **LOSS OF REVENUES, BUSINESS FAILURES, BANKRUPTCY, AND UNEMPLOYMENT, INFLECTING DESPAIR AND DESTITUTION** FOR THOUSANDS OF HAPLESS VICTIMS THROUGHOUT THE GREEN SPACE INDUSTRY. THE ACTIONS OF MANIAC-CULPRIT-TERRORIST-BASTERDS ARE VIEWED AS A FORM OF **TERROR** AGAINST THE GREEN SPACE INDUSTRY.
