Bell is an « *expert* » in the CONCOCTION of IMAGINARY DANGER concerning pest control products !

Additionally, Bell has NO recognized expertise, training, or background in matters concerning pest control products, or the maintenance of sports turf.

The prohibition of pest control products promoted by Bell and his buddies has resulted in public green spaces and sports fields that look like GARBAGE DUMPS.

The prohibition of pest control products has also created DANGEROUS SURFACES for children to play on.

In some jurisdictions, the IMAGINARY DANGER concocted by Bell and his buddies has succeeded in COERCING and DECEIVING Government Officials to PROHIBIT pest control products that are FEDERALLY LEGAL, SCIENTIFICALLY SAFE, and TOTALLY IRREPLACEABLE.

The prohibition of pest control products promoted by Bell and his buddies has been DEVASTATING for the maintenance of public green spaces and sports fields since there are NO valid economical Green Alternatives to replace prohibited products.

VIRTUALLY ALL Green Alternatives are almost TOTALLY INEFFECTIVE, except under very specific circumstances.

The Green Alternatives promoted by Bell and his buddies are BOGUS.

In jurisdictions where PROHIBITION-TERRORISM has been successful, public green spaces and sports fields have become weed-infested and insect-infested.

They have been OVER-RUN by dandelions and other weeds, and have been DESTROYED by damaging insect pests.

THE PROHIBITION OF PEST CONTROL PRODUCTS REPRESENTS A HAZARD TO ANYONE USING THESE PLAYING SURFACES, ESPECIALLY CHILDREN.

When it rains, pest-infested playing surfaces are SLIPPERY MUD BOGS.

When dry, pest-infested playing surfaces are AS HARD AS CONCRETE.

Pest-infested playing surfaces not only look like GARBAGE DUMPS, they are also DANGEROUS !

Our [Enviro-Terror] organization, Canadian Association of Physicians for the Environment, conducted a survey of the medical and sports literature, and found only one reference to injuries caused by poor playing field maintenance.

That was a study carried out twenty-six years ago at Pennsylvania State University, in which injuries were associated with a loss of turf cover, and nothing else. [What about loss of turf cover caused by uncontrolled pest damage !?!]

Weeds were not mentioned once, nor were pesticides. [Big deal !]
