Their LIES have created a TRAIL OF ECONOMIC DESTRUCTION with THOUSANDS OF PEOPLE OUT OF WORK.

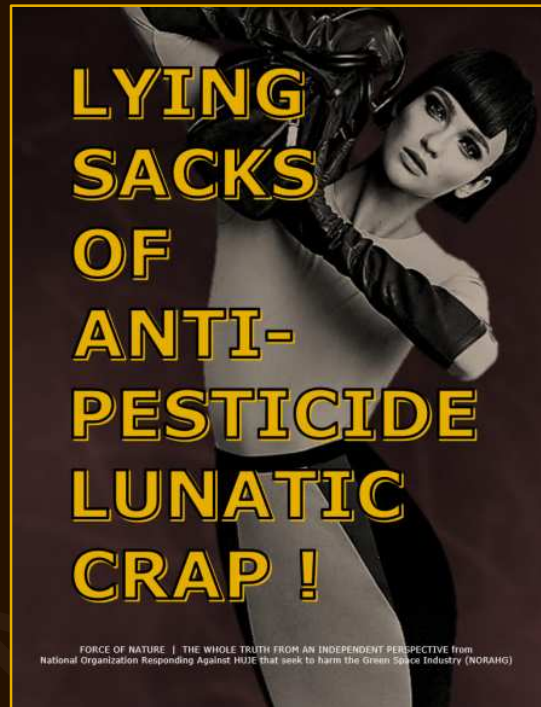

CAPE is also a **FUND-RAISING, PROFIT-SEEKING, and LOBBYING** organization, and it is **NOT** a science, research, or health organization.

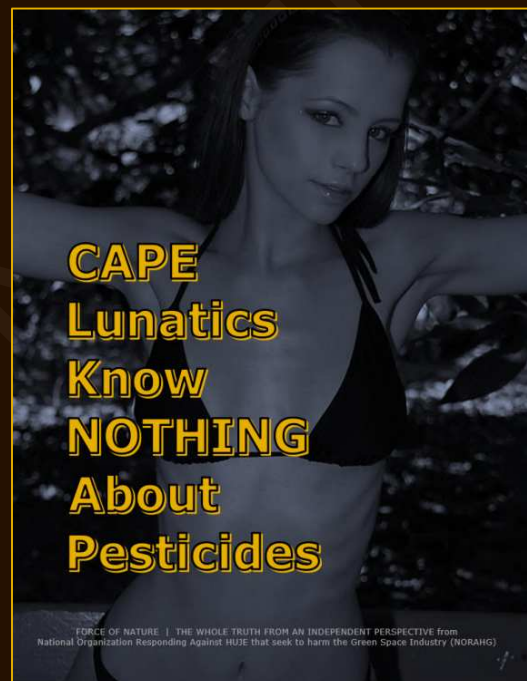
