Paul Tukey is an American Journalist, Environmental-Terrorist, and Non-Registered Lobbyist.

Tukey operates the organization called SafeLawns, which functions as the PUBLIC AFFAIRS SHIELD for Beyond Pesticides, another larger U.S. Environmental-Terror-Organization.

Tukey is also a FAILED and BANKRUPT lawn care operator who was apprehended by authorities for applying pest control products WITHOUT THE NECESSARY LEGAL LICENSING.

Tukey became embittered and vengeful, and unable to accept his obvious incompetence. To this day, he refuses to take responsibility for the utter and inexplicable demise of his company. Instead, he prefers lashing out and defaming former competitors, and the pest control product industry.

Overall, Tukey is blatantly and consistently WRONG with his opinions and recommendations.

Overall, Tukey's expertise cannot be valid, otherwise, he would NOT have managed an unlicensed lawn care business into inexplicable failure and bankruptcy.

Overall, the opinions of Tukey are VALUELESS and WORTHLESS in matters concerning the maintenance of turfgrasses.

His opinions are equally VALUELESS and WORTHLESS in matters concerning pest control products.

He is NOT COMPETENT to give advice !

Tukey even dresses himself to look like « *trailer-park-enviro-trash* » to deceive people into believing that he is not rich, while collecting tens of thousands of dollars, preferably IN CASH, and TAX-FREE.

Books and videos are also SOLD-FOR-PROFIT on-line through a « *Shopping Cart* ».

Tukey also recommends several BOGUS Green Alternatives that are SOLD-FOR-PROFIT by his own Enviro-Terror-Suppliers, who pay HUGE SUMS OF MONEY FOR ADVERTISING with SafeLawns in what is called a « *Resource Directory* » ( a.k.a. FOR-PROFIT-ADVERTISEMENT ).

Tukey is also PAID-FOR-PROFIT for his SPEECHES and PRESENTATIONS in what are called « *honorariums* ». In Canada, AN HONORARIUM IS CONSIDERED AS SALARY, and thus, TAXABLE income under the Income Tax Act.

Tukey is also PAID-FOR-PROFIT for his UNREGISTERED LOBBYING of local Government Officials wherever he travels. In Canada, this is a VIOLATION of the Lobbying Act.

Tukey also SLITHERS into Canada with a bunch of lies, scare tactics, and innuendos, and allegedly collects TENS OF THOUSANDS OF DOLLARS, with his Canadian co-conspirators, in the SALE-FOR-PROFIT of videos, books, presentations, and unregistered lobbying — WITHOUT PAYING TAXES to the Canadian government — preferably collected IN CASH.

Tukey still does not take his legal responsibilities seriously.

It is alleged that Tukey is being PAID-FOR-PROFIT by his Canadian co-conspirators to interfere with the court challenges against his Enviro-Maniac friends and their Environmental-Terror-Organizations in the Provinces of Ontario and Quebec.

It is believed that Tukey ought to be banned from entry into Canada, since he is clearly trying to SUBVERT the Canadian justice system, as well as trying to AVOID the payment of taxes.

When Paul Tukey was talking to a radio interviewer about his lawn care business, he admitted to spraying pest control products without a license for several years until he was apprehended by local authorities.

*<< I actually owned my own lawn care company. I sprayed for a couple of years just unabatedly **WITHOUT A LICENCE**, and I got **FINED** by the Maine Board of Pesticide Control.*

*So I ... with my tail between my legs ... I went and got my pesticide applicator licences.*

*For the next three years, I sprayed about 800 lawns a year myself.*

*I made more money than I've ever made any year since ...*

*... and wound up [ allegedly ] in the hospital with something called acute chemical sensitivity from a **MULTIPLE CHEMICAL SENSITIVITY**. [ !?! ]*

*And it was ... the doctor [ allegedly ] said basically if you keep using all of those lawn chemicals, you are going to be dead. [ !?!?! ]*

*I got out of that business, and I've been looking for alternative solutions ever since. >>*

# TUKEY'S DISGRACEFUL KU KLUX KLAN VIDEO

« *A Terrorist Reaction* » is a foreign AMATEUR HOME-MADE VIDEO that was concocted to GLORIFY Environmental-Terrorism, and DEFEND the NEED-LESS, SENSELESS, and MALICIOUS PROHIBITION of pest control products.

Prohibition is ANNIHILATING the Modern Green Space Industry.
