In November 2010, Halifax Regional Municipality ( HRM ), in the Province of Nova Scotia, IMPLEMENTED the PROHIBITION of the Green Alternative product called Fiesta ( FeHEDTA ) —

*<< HRM Council REJECTED THE USE of Chemical FeHEDTA as an addition to permitted uses in the Pesticide By-Law. [ Non-Expert ] Council decided there was INSUFFICIENT EVIDENCE on this chemical's environmental and human impacts, and the UNKNOWN POTENTIAL RISKS of applying this chemical as a herbicide outweigh the benefits. >>*

Councillor Steve Adams is asking his fellow-councillors to RECONSIDER their recent PROHIBITION of FeHEDTA, a so-called Green Alternative to conventional pest control products.

Halifax Regional Municipality PROHIBITED products containing the active ingredient Fe HDTA, sold in Nova Scotia stores as Fiesta Lawn Weed Killer Solution, as well as Scotts EcoSense, and Weed B Gon, from its list of acceptable products by an 11-10 vote on May 24<sup>th</sup>, 2011.

HYPOCRITICAL city employees recommended that council ALLOW Fiesta, and include it on its permitted pesticides list.

Fiesta is currently ALLOWED by the Province of Nova Scotia and Health Canada.

These same HYPOCRITICAL city employees CONVENIENTLY FAILED to observe, in 2000, that CONVENTIONAL pest control products, like 2,4-D, were also ALLOWED by the Province of Nova Scotia and Health Canada.

In 2000, the Enviro-Lunatic-Infested Halifax Regional Municipality IMPOSED, over a three-year period, the PROHIBITION of CONVENTIONAL pest control products used in the Urban Landscape.

These products were otherwise HEALTH-CANADA-APPROVED, FEDERALLY-LEGAL, SCIENTIFICALLY-SAFE, and TOTALLY-IRREPLACEABLE.

In public debates leading up to council's May 24 vote on Fiesta, local Enviro-Lunatics CONCOCTED the same FEAR-MONGERING issues that were used to PROHIBIT CONVENTIONAL pest control in 2000.

Furthermore, PROHIBITION INFLICTED HORRENDOUS CARNAGE IN HALIFAX.

Because of PROHIBITION in Halifax Regional Municipality, REVENUES PLUMMETED BY 40 PER CENT with most Professional Lawn Care companies, and it took these companies five years to « *recover* » from the hardship and losses.

Because of PROHIBITION in Halifax, CUSTOMERS DISINTEGRATED BY 50 PER CENT, even after a so-called « *recovery* » period of several years !

And now, under the PRETEXT of CONCERNS about Fiesta, Enviro-Lunatics are AGAIN CONCOCTING IMAGINARY DANGER, MYTHS, DECEPTIONS, FEAR-MONGERING, FRAUDULENT LIES, MISCONCEPTIONS, COERCION, THREATS, TERROR, and PARANOID CONSPIRACIES.

As usual, these Enviro-Lunatics are attempting to SCAM and DECEIVE the public and government officials into believing there is some IMAGINARY DANGER with Fiesta.

These Enviro-Lunatics are now CONCOCTING concerns about Fiesta's ALLEGED effects on human health, and ALLEGED risks to ground water or drinking water and local wildlife the ENVIRO-TERRORISM NEVER ENDS !

A staff report submitted to Halifax council states that there have been four incidents reported to Health Canada, including a cat that died, two dogs that suffered different reactions from two separate incidents, and grass killed by the product. [ Big deal ! ]

After comparing the product to other landscaping products on the municipality's allowable product list, « *staff did not feel there was a reasonable health risk present* ».

Councillors were advised that even if the municipality PROHIBITED the product's usage, it would still be available in stores because ONLY THE PROVINCE CAN PROHIBIT SALES.

Professional Lawn Care companies using Fiesta as a spot-treatment for weed control « *would be the primary groups restricted* » by any municipally-imposed PROHIBITION, the report states.

When councillors were told that the city doesn't use Fiesta, « *the implication is, well, it's good enough to approve but not good enough for the municipality, there must be something wrong with it* ».

In a TWISTED SENSE OF REVERSED AND PERVERSED LOGIC, the Enviro-Lunatic-Infested Halifax Regional Municipality that IMPOSED the 2000 PROHIBITION is now ATTEMPTING TO SAVE a Green Alternative that is NO SAFER and NO BETTER than CONVENTIONAL pest control products like 2,4-D.
