Health Canada requires each new pest control product to go through about TWO-HUNDRED SEPARATE TESTS to examine health and environmental impacts as well as value.

However, some activists have often been compelled to make public appearances in a WHITE LABORATORY COAT to give the public the impression that they are, somehow, researchers or scientists.

TWO-HUNDRED SEPARATE TESTS represents two-hundred MORE tests than activists EVER used to back up ANY of their statements AGAINST pest control products.

And the cost to manufacturers to get a pest control product from the lab to store shelves is about 250 MILLION DOLLARS.
