Growing conditions have been very good for a growing problem in Winnipeg this year.

City boulevards and parks appear to be overrun with dandelions and other weeds.

The city says ideal weather conditions have allowed the weeds to flourish.



It also says the problem will likely get worse down the road now that the province's pesticide ban is in effect.

The city says it's testing an organic spray at a few locations to see if it can be used in the future.

But the new product may never be used city wide as it can cost eight times as much as the chemicals that were used in the past.

To help offset the growing blooms this year, city officials say they're mowing more often.
