Prohibition Inflicted Garbage Dump Green Spaces

The green spaces in the city of Greater Sudbury look like pest-infested garbage dumps.

There is little debate about the fact that Ontario's 2009 provincial prohibition against pest control products converted communities like Sudbury into shabbier and dangerous pest-infested garbage dumps.

Ontario parks, sports fields, and home lawns became wholly infested with dandelions and a variety of other weeds, and there was no practical way to remove them, other than by hand-pulling or by replacing the entire lawn with sod.

The sod grower industry clearly profited from prohibition.

There is also little debate about the fact that the only businesses that profited from Ontario's 2009 provincial prohibition were sod growers.

Because of needless, senseless, and malicious prohibition, Ontario greens spaces became weed-infested and insect-destroyed garbage dumps.

And sod growers became richer.

The sod growers probably represent the only industry that has actually benefited from the garbage dump green spaces that were inflicted by anti-pesticide prohibition.

Greater Sudbury, with a population of almost 160,000, is a city in the province of Ontario.

Ontario's Arbitrary Prohibition

On April 22nd, 2009 — a date which will live in the period of environmental infamy — the full force of the Ontario Cosmetic Pesticides Ban Act was arbitrarily implemented, and destroyed the professional lawn care industry.

Ontario's 2009 provincial prohibition was imposed under the pretext that children somehow needed to be protected from pest control products.

The government of Ontario's prohibition was an attack against businesses operating in the professional lawn care industry, and this attack left a trail of economic destruction with hundreds of small businesses destroyed and thousands of people out of work.

The assessments that validated prohibition were performed by a small group of fund-raisers and health care workers who had no expertise whatsoever in matters relating to pest control products.

Sod Growers Have Profited From Prohibition



Ontario's 2009 provincial prohibition was implemented in defiance of overwhelmingly massive and detailed assessments performed by Health Canada, whose work was discredited by fund-raisers and health care workers (a.k.a. lunatic activists) who decided to set their own agendas by interfering in partisan politics and public policy regarding pest control products.

Sod growers were provided with an exception status, and were not subject to Ontario's 2009 provincial prohibition.

In fact, sod growers profited from prohibition, and nowhere is this more evident than in the city of Greater Sudbury.

Sod Growers Profited From Prohibition

Denis Charbonneau is the Manager of Valley Nursery Sod in Chelmsford, a town which was amalgamated into the city of Greater Sudbury.

Charbonneau estimated the demand for turf is up about 20 per cent since arbitrary prohibition was imposed — something he attributes to the number of people tearing out and replacing old lawns overtaken by weeds.

In Sudbury, prohibition led to the stunningly exorbitant costs of sod renovation.

According to Charbonneau —

I believe the main drive is the ban they put on pesticides and herbicides [a.k.a. prohibition], and the home-owners are now struggling to keep anything going.

In Sudbury, prohibition led to garbage dump green spaces.

As a sod grower, Charbonneau is exempt from the 2009 provincial prohibition.

However, there are several facts that Charbonneau and other sod growers are not willing to admit to the public.

Nonetheless, it is expected that the sod grower industry will soon be terrorized and coerced and intimidated into using a certified pesticide-free sod.

Anti-pesticide lunatic-terrorists will concoct the story that home-owner consumers have long demanded certified pesticide-free sod. [?!?!]

The city of Greater Sudbury is located in a region that is infamous for being desolate, dismal, filthy, polluted, and ugly.

Greater Sudbury And Its Desolation ---

Greater Sudbury, with a population of almost 160,000, is a city in the province of Ontario.

Greater Sudbury was created in 2001 by merging the cities and towns of the former regional municipality of Sudbury, along with several previously unincorporated geographic townships.

Fertilizer EnviroTerror In Sudbury

By population, Sudbury is the largest city in the northern Ontario region.

By land area, it is the largest city in Ontario, and the seventh largest municipality by area in Canada.

Sudbury is so desolate that during the Apollo manned lunar exploration program, astronauts trained in Sudbury since its environment resembled the lifeless surface of the moon.

In recent years, the ecology of the Sudbury region has recovered dramatically thanks to re-greening programs, which sadly now include the lunatic-prohibition and restriction of fertilizer that will eventually destroy the professional lawn care industry.

Sudbury's Anti-Fertilizer Prohibition

On July 13th, 2011, the enviro-lunatic city council of Greater Sudbury passed a needless, senseless, and malicious prohibition and restriction on fertilizer use in the urban landscape.

Sudbury was infamously the first municipality in Ontario to enact phosphorus fertilizer prohibition, and it came into effect in April 2012.

Sudbury also restricted all fertilizers used by the professional lawn care industry.

Sudbury legislated based solely on imaginary danger about fertilizer and its alleged effects on cyano-bacteria blue-green algae in water.

There were ridiculous allegations that one-pound of phosphorus can create 700 pounds of blue-green algae. [?!?!]

Fertilizer EnviroTerror In Sudbury

Two anti-pesticide terrorist-organizations coerced and intimidated Greater Sudbury council to prohibit and restrict fertilizers —

- Greater Sudbury Watershed Alliance
- Long Lake Stewardship Committee

There are 371 people on long lake stewardship committee, out of a total of 1,250 residents on long lake, and Greater Sudbury watershed alliance is a coalition of 19 local lake and river stewardship groups.

Details Concerning Sudbury's Anti-Fertilizer Prohibition

The Sudbury prohibition will ...

- ban fertilizer use of phosphorus, but there are EXCEPTIONS
- ban ALL fertilizer use on frozen ground
- ban ALL fertilizer use during rain, or when rain is predicted
- ban ALL fertilizer use within 15 metres of any water body
- ban ALL fertilizer use on impervious surfaces such as driveways and parking lots.

Exceptions To Sudbury's Anti-Fertilizer Prohibition

The Sudbury prohibition will not apply to over 95 per cent of all phosphorus fertilizer use ...

- the use of phosphorus to establish turf from seed or sod
- the use of phosphorus when a soil test indicates a deficiency

Fertilizer EnviroTerror In Sudbury

- the use of phosphorus on agricultural land
- the use of phosphorus on sod farms
- the use of phosphorus on golf courses

Sod supplied to the home-owners is not only fertilized with otherwise prohibited phosphorus fertilizer, it is also herbicide-treated and insecticide-treated.

Sudbury's Anti-Fertilizer Prohibition Unnecessary

In fact, turf fertilizers are not the primary source of phosphorus-loading in area lakes — prohibition will not protect the environment.

Turf Fertilizers No Longer Contain Phosphorus

Moreover, because phosphorus is an expensive raw material, turf fertilizers generally are not composed of the mineral.

95 per cent of all turf fertilizers no longer contain phosphorus, so prohibition is not needed.

Sudbury Merely Copying Failed U.S. Prohibitions

Sudbury is merely following many jurisdictions in the United States, where idiotic restrictions and prohibitions have been imposed on fertilizers containing phosphorus, and even nitrogen.

In America, there have been no tangible results with fertilizer prohibition — U.S. prohibition is a dismal failure.

Notable activities — worked in virtually all aspects of the green space industry, including golf, professional lawn care, distribution, environmental compliance, government negotiations, public affairs, and workplace safety • supervisor, consultant, and, programmer for the successful execution of hundreds of thousands of management operations in the golf and urban landscape, as well as millions of pest control applications • advisor, instructor, and trainer for thousands of turf and ornamental managers and technicians • pesticide certification instructor for thousands of industry workers • founder of the modern professional lawn care industry • prolific writer for industry publications and e-newsletters • first to confirm the invasion of European Chafer insect in both the Montreal region and the Vancouver / Fraser Valley region • with Dr. Peter Dernoeden, confirmed the presence of Take All Patch as a disease of turf in Eastern Canada • with Dr. David Shetlar, confirmed the presence of Kentucky Bluegrass Scale as an insect pest in South Western Ontario, and later, in the Montreal and Vancouver regions

Special contributions — creator of the exception status that has allowed the golf industry to avoid being subjected to anti pesticide prohibition • creator of the signs that are now used for posting after application • co-founder of annual winter convention for Quebec golf course superintendents • the major influence in the decision by Canadian Cancer Society to stop selling for profit pesticide treated daffodils • the only true reliable witness of the events of anti pesticide prohibition in the town of Hudson, Quebec • retired founder of FORCE OF NATURE and A LOOK AT reports

Notable award — the very first man of the year for contributions leading to the successful founding of Quebec professional lawn care industry, which served as a beach-head against anti pesticide activists in the 1980s and 1990s

Legacy — Mr. Gathercole and his colleagues ... designed and implemented strategies that reined anti pesticide activists to provide peace and prosperity for the entire modern green space industry across Canada • orchestrated legal action against anti pesticide activists in the town of Hudson, Quebec • launched the largest founding professional lawn care business in Canada • quadrupled the business revenues of one of the largest suppliers in Canada

Mr. Gathercole is now retired, although his name continues to appear as founder of FORCE OF NATURE and A LOOK AT reports.
