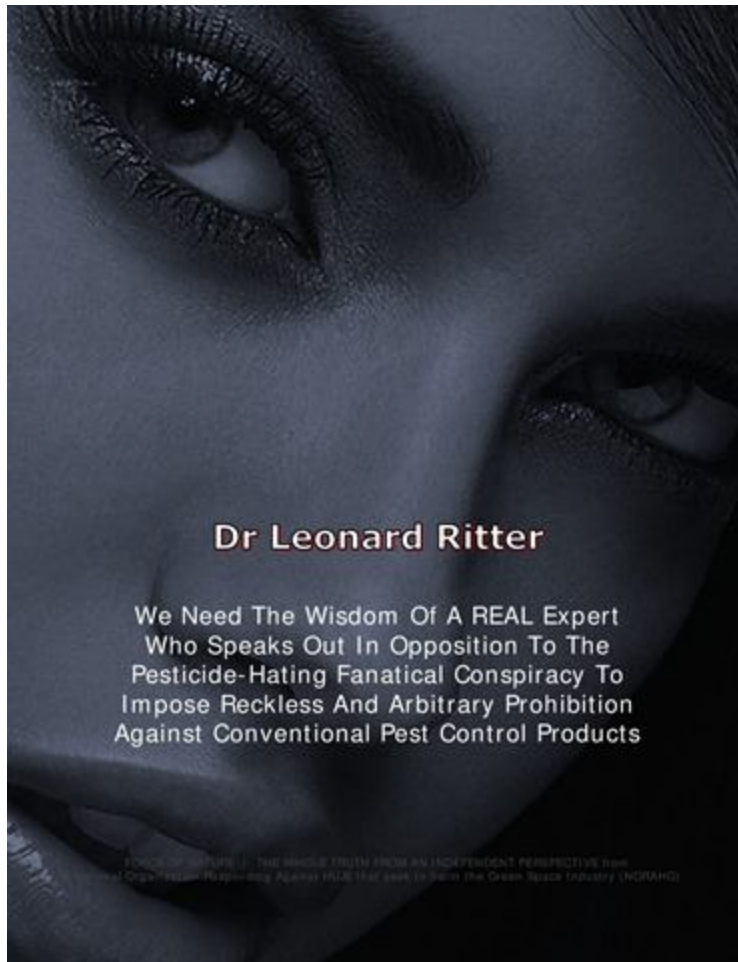

Dr Len Ritter, Professor of Toxicology, says —

There is NO EVIDENCE that the safe application of agricultural pest control products causes cancer, says the prominent toxicology professor from Ontario.

Dr Len Ritter, a Professor Emeritus at the University of Guelph, was in Charlottetown to speak to the Prince Edward Island Potato Board about his research into pest control products.

Ritter points to statistics released recently by the Canadian Cancer Society that show cancer rates are expected to jump 40 per cent in Prince Edward Island by 2030.

According to the report, that rise in cases will be led by upsurges in prostate and colorectal cancer cases in an aging population.





Dr Ritter points out that non-Hodgkin's lymphoma rates, the cancer most often associated with pest control products, are lower in Prince Edward Island than anywhere else in the country when it comes to men, and tied with Quebec for lowest rates in Canada among women.

Dr Ritter says if pest control products were as bad as some say they are, rates of that type of cancer would be higher.

According to Dr Ritter —

*You see the amount [ on Prince Edward Island ] is the lowest in the country.*

*If pesticides were driving it, you would expect the reverse to be true.*

The toxicology professor says he doesn't represent the Canadian Cancer Society, but does rely on its data, as well as data from Health Canada's Pest Management Regulatory Agency ( PMRA ).

According to Dr Ritter —

*My role is not to advocate the use of pesticides, not to promote a pesticide ban.*

*It's to introduce evidence-based information that I hope will allow people to enter debate on a more informed basis.*

Prince Edward Island is on the high end of cancer rates when it comes to lung cancer and melanoma, which Ritter attributes to smoking and exposure to sun.







Ritter said that the International Agency for Research on Cancer ( IARC ) has identified concerns over Roundup, a commonly used herbicide.

Roundup is used for killing grass before a potato field is plowed under.

*It's a legitimate question ... a complex issue.*

*( But ) it was always considered to be among the safest herbicides in the world, and that continues to be the prevailing opinion.*

Greg Donald, general manager of the Prince Edward Island Potato Board, said farmers in the province follow Health Canada and PMRA guidelines, and do not spray any more than they have to.

According to Greg Donald —

*There is a belief that farmers use pest control products because they want to.*

*They are a tool amongst a number of other things that they use that they need to grow healthy and safe food.*

Mr Donald said, adding that growers are concerned about the public perception about pest control products.

According to Mr Donald —

*We wanted to get the facts.*

*Folks who use these chemicals are trained and use them according to the label.*

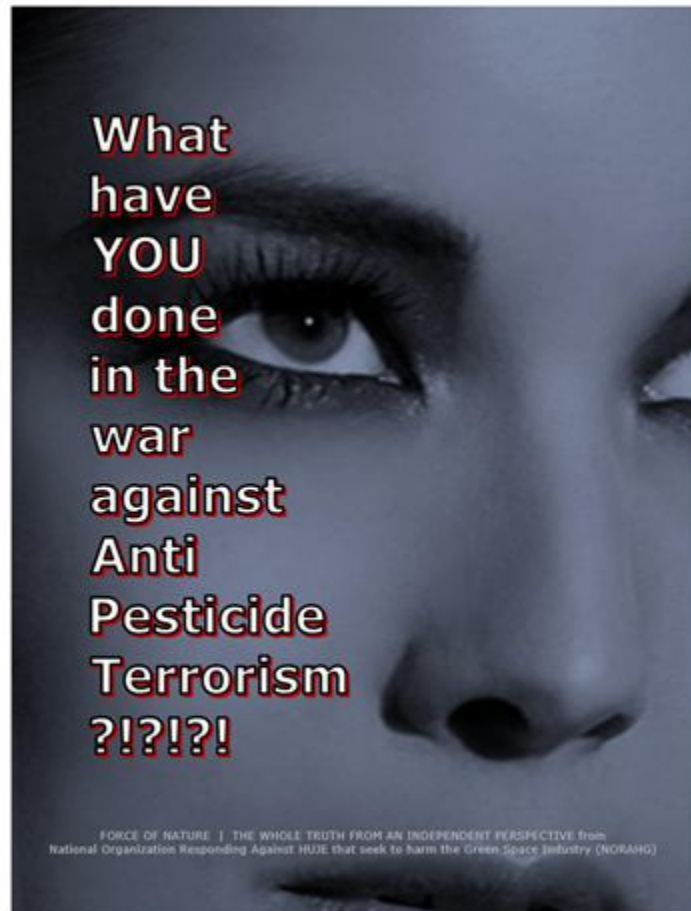

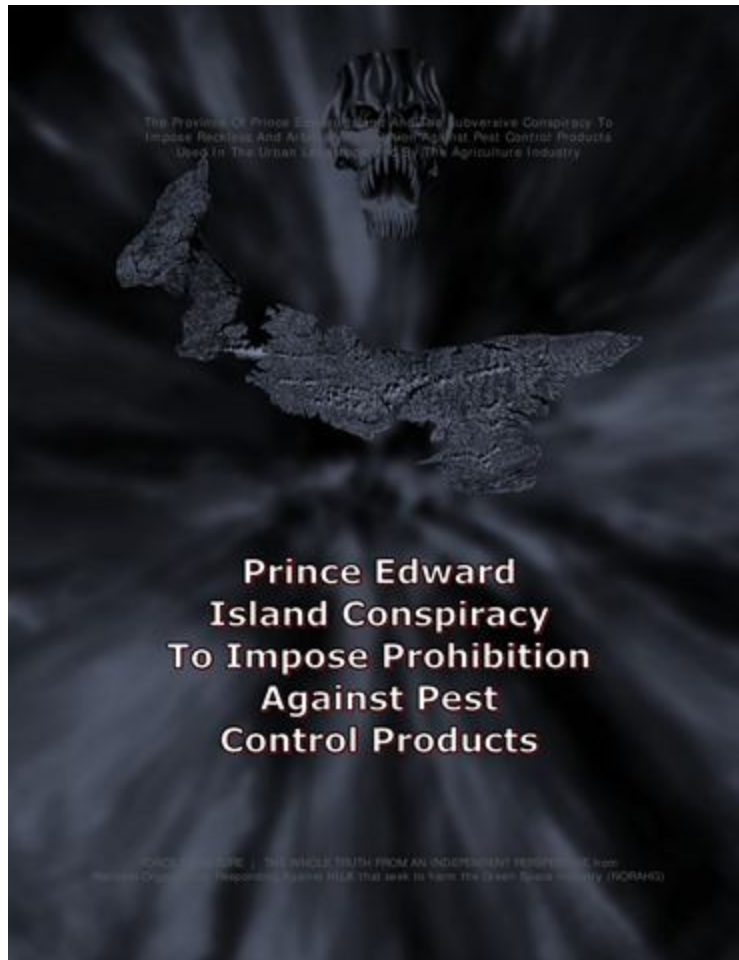

**Professional Lawn Care Businesses Are Granted An Exception Status**

A province-wide prohibition removed 240 products from use by consumers.

Businesses operating in the Professional Lawn Care Industry have been provided with an EXCEPTION STATUS.

2,4-D herbicide is prohibited for use by either consumers or businesses on lawns, but it is ALLOWED for use in the Golf Industry.

Prince Edward Island has indicated that the Golf Industry Exception Status will eventually be REVOKED.

Here is what the Government of Prince Edward Island said —

*We're allowing it on GOLF COURSES because it's a major industry for P.E.I. and we're working towards getting off it.*

*What we're basically saying is you [ the GOLF INDUSTRY ] better find a way to get off it over the next couple of years.*

Prince Edward Island ( PEI or P.E.I. ) is a Canadian Atlantic province consisting of an island of the same name, as well as other islands.

This maritime province is the smallest in the nation in both land area and population ( excluding the northern territories ), and has about 122,000 residents.

The island has a few other names — « *Garden of the Gulf* », referring to the pastoral scenery and lush agricultural lands throughout the province; and « *Birthplace of Confederation* », referring to the Charlottetown Conference in 1864.

Prince Edward Island's prohibition against pest control products came into effect April 1, 2010.

Prohibition differed from legislation proposed in the nearby Province of Nova Scotia, meaning a different set of lawn care products could be sold in either province.

Prince Edward Island's banned list included more than 240 products, many of which contained the chemical 2,4-D.

Prohibition affected products sold in either concentrated or granular form.

Prince Edward Island's prohibition mirrored the legislation imposed in the adjoining Province of New Brunswick.

The Government of Prince Edward Island stopped short of proposing a TOTAL PROHIBITION of pest control products.

In Prince Edward Island, several organizations have ILLEGALLY INTERFERED IN PARTISAN POLITICS by conspiring to prohibit against pest control products used in the Urban Landscape.

They have squandered and misappropriated public and government funds in order to support subversive acts of anti-pesticide terrorism.

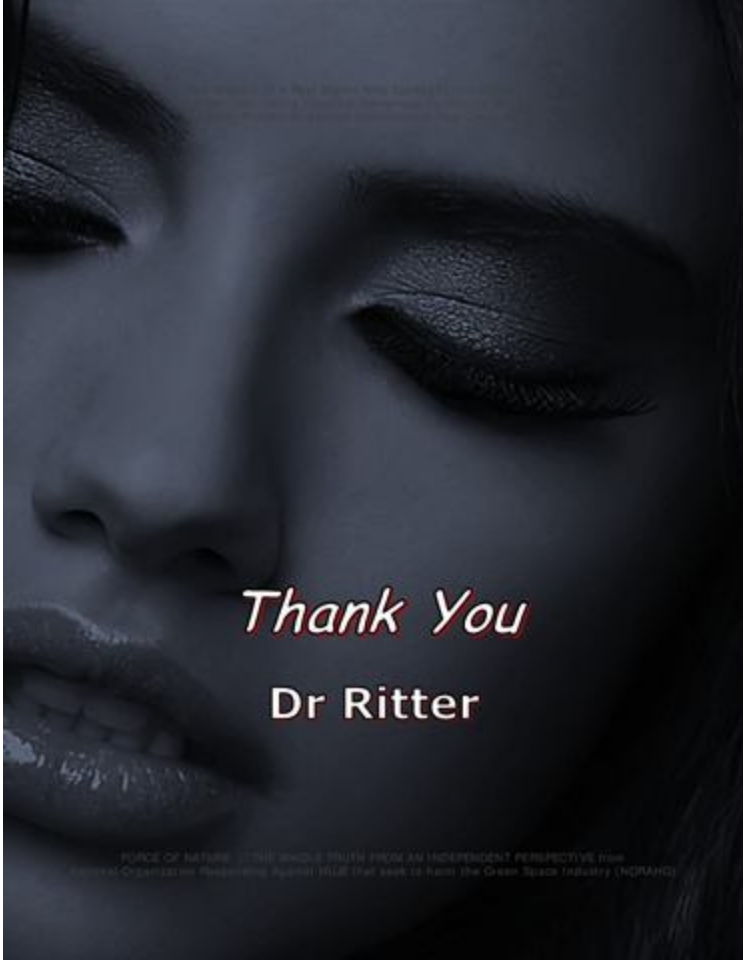
