## NANAIMO, BRITISH COLUMBIA

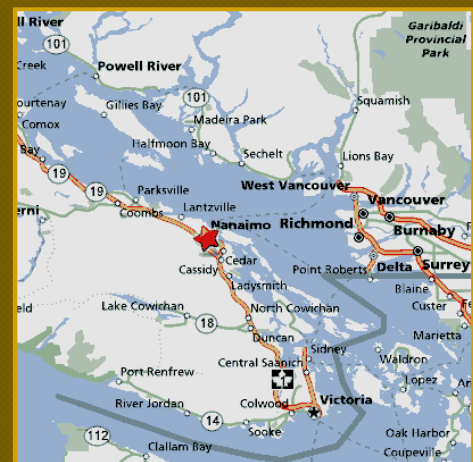

## British Columbia Conspiracy to Prohibit Pest Control Products

### BID TO BAN COSMETIC PESTICIDES IN CITY BACK ON TRACK

The [ contemptible and radical ] CANADIAN CANCER SOCIETY put a bug in the CITY OF NANAIMO's ear on banning pesticides and council responded with \$25,000 for pesticide education and awareness.

Cancer society VOLUNTEER [ Enviro-Maniac, Biology Student, and Karate aficionado ] **KELSEY O'GORMAN** presented city council Monday night with a petition signed by 1,200 NANAIMO residents calling for the city to adopt a bylaw banning cosmetic pesticides.



City staff, under direction of council and the city's ADVISORY COMMITTEE ON THE ENVIRONMENT, were asked to draft a bylaw last September and present it this month. The bylaw, which was to have been drafted over the winter, was subject to input by members of the local lawn and garden industry.

« We were concerned the deadline was passing with no action, » said [ Enviro-Maniac ] **ADRIANE SCHROEDER**, the society's community action coordinator. « This puts the bylaw development process back on track and is a great Earth Day gift for Nanaimo citizens. »

Eighteen other B.C. municipalities have banned cosmetic pesticide use, while ONTARIO and QUEBEC have outright bans on the use of 250 pesticide products. PORT ALBERNI is currently in the process of drawing up its own bylaw. [ So what ?!?! ]

The residential awareness program will educate homeowners on the dangers of pesticides and, if adopted by the city, a ban would not be implemented until APRIL 2010 to allow residents to become educated on the subject.

Currently, the city only uses pesticides as a last resort to control a serious infestation that poses a threat under its INTEGRATED PEST MANAGEMENT SYSTEM.

« *While the city does make an effort to minimize it, and Nanaimo does it very well, the pesticides that are used are quite toxic, »* said [ Enviro-Maniac ] SCHROEDER.

PESTICIDE-TREATED-LAWNS ARE AS SAFE, OR AS TOXIC, AS PESTICIDE-TREATED-CANCER DAFFODILS !

IF IT IS SAFE TOUCH AND HOLD A PESTICIDE-TREATED DAFFODIL, IT IS ALSO SAFE TO WALK ON A PESTICIDE-TREATED LAWN.


