

In fact, Miller has ABSOLUTELY NO EXPERTISE in matters concerning Neonicotinoid Insecticides.

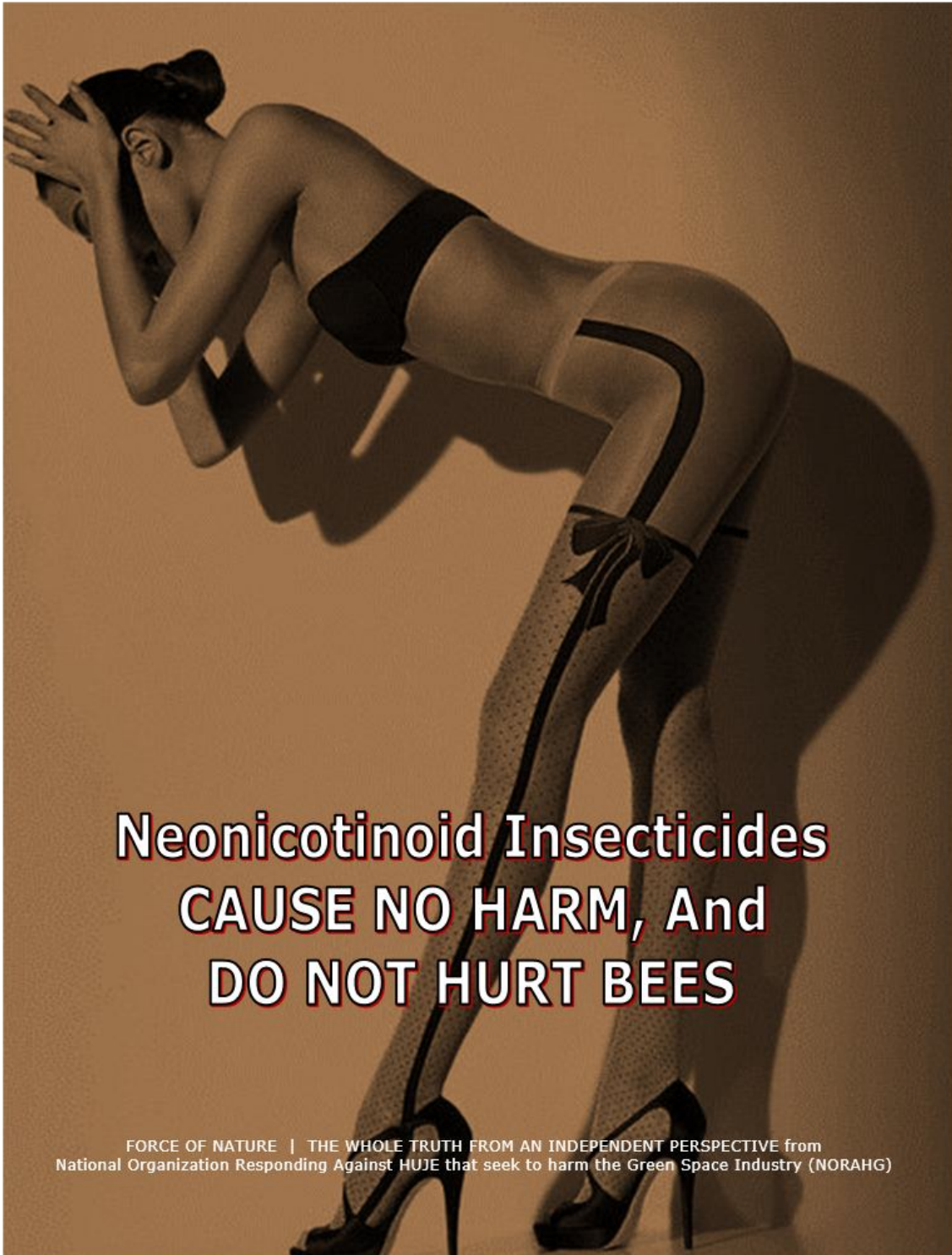
