Over Three-Quarters-Of-A-Million Dead Bees

In July 2015, a late-night highway traffic crash in Wisconsin INVOLVING OVER ONE MILLION BEES.

Because it was dark, the bees were less active in the chaos and a local bee-keeper was able to save about a quarter of the bees.

3.6 Million Dead Bees

The California Department of Transportation sent out a warning Tweet after the incident —

Update WB 10 @ Dillon (semi accident) — Traffic is being detoured through the median around the incident — KEEP YOUR WINDOWS UP DUE TO BEES.

Still, the final death toll was 3.6 MILLION.
