Demonstrators deliver Halloween cards to Lowe's asking them to stop selling products treated with neonicotinoid pesticides.

Supporters of Friends of the Earth will demonstrate outside of Lowe's stores in North America on October 29, 2014, asking Lowe's to stop being a "little shop of horrors" for bees this Halloween, and asking the company to remove plants and seeds treated with beeharming neonicotinoid pesticides from their shelves. Demonstrators will meet on the sidewalk, Halloween costumes encouraged, and then march into the stores to deliver their Halloween cards. Friends of the Earth also encourage individuals to deliver Halloween cards to Lowe's stores across Canada from October 29 to 31.

Additional Information:

This action is part of Friends of the Earth's "Bee Cause" campaign. The Bee Cause calls for a ban on bee harmful pesticides and practices while proposing and delivering practical ways to help bees and wild pollinators.

Friends of the Earth Canada, along with Friends of the Earth US and Pesticide Research Institute released a report entitled Gardeners Beware in June 2014 detailing the problem with neonicotinoid pesticides, their effect on pollinator populations, and their prevalence in garden plants and products across Canada.

Demonstrations will also be held in the United States over noon hour on October 29, organized by Friends of the Earth US and affiliated organizations, in cities such as New York, Philadelphia, Washington, and San Francisco.
