CGSA SUPPORT OF PROHIBITION has VALORIZED the policies of Prohibition-Terrorist-Organizations, like Canadian-Cancer-Society that have nonetheless sworn to ANNIHILATE the Golf Industry.

CRISIS ? WHAT CRISIS ?

There are jurisdictions in British Columbia and Prince Edward Island that are already considering REVOKING the GOLF INDUSTRY EXCEPTION STATUS.

Using IPM ACCOMPLISHES VIRTUALLY NOTHING in terms of resolving the public affairs issues concerning the PROHIBITION of pest control products.

IPM IS A DISMAL FAILURE !

Integrated Pest Management is a DISMAL FAILURE as a cultural practice, and a WASTE OF TIME AND MONEY for the Golf Industry.

The Professional Lawn Care Industry used Integrated Pest Management as a PUBLIC RELATIONS STRATEGY, and FAILED to defend itself from LUNATIC-TERRORIST-PROHIBITION.

Nor does Integrated Pest Management effectively and consistently control the pests of established turf and ornamental plants — at best, it MAY provide some LIMITED IMPROVEMENT towards the efficiency and effectiveness of conventional pest control products.

Integrated Pest Management is an INEFFECTIVE MANAGEMENT STRATEGY FOR CONTROLLING DAMAGING PESTS of established turfgrasses, as well as trees and shrubs.

Elected leaders and staff of Canadian Golf Superintendents Association appear to be more worried about protocols for the implementation of the INEFFECTIVE Integrated Pest Management rather than focus on what its playing customers really want ... HIGH-QUALITY PLAYING CONDITIONS.

Elected leaders and staff of CGSA FAILED THEIR MEMBERS YET AGAIN !

CGSA FAILED THEIR MEMBERS OVER AND OVER AND OVER AGAIN !

FERTILIZATION

It is INCONCEIVABLE that CGSA uses so-called FERTILIZER-REDUCTION-STRATEGIES, again, as a PUBLIC RELATIONS STRATEGY to deflect attention away from the Golf Industry use of pest control products.

The so-called FERTILIZER-REDUCTION-STRATEGIES have been NEEDLESS as well as DISASTROUS for the Golf Industry.

As a consequence of these strategies, PLAYING CONDITIONS and PLANT HEALTH HAVE SUFFERED TERRIBLY, and MAINTENANCE EXPENSES HAVE ACTUALLY RISEN.

FERTILIZER-REDUCTION-STRATEGIES have SEVERELY AFFECTED HIGH-QUALITY PLAYING CONDITIONS.

Diseases that thrive under FERTILIZER-REDUCTION-STRATEGIES (i.e. low-nitrogen), like Anthracnose, that were non-existent just a decade ago, are now RAMPANT and DESTRUCTIVELY LETHAL to golf course turf.

Consequently, FERTILIZER-REDUCTION-STRATEGIES have actually INCREASED the use of pest control products.

Overall, FERTILIZER-REDUCTION-STRATEGIES are a DISMAL FAILURE !

CGSA also remains OBSESSED on BOGUS and POINTLESS ISSUES such as carbon reduction, corridors, habitats, nutrients, and water.

Inevitably, CGSA will need to address MORE IMPORTANT ISSUES, such as LOW MOWING HEIGHT VERSUS HIGH-QUALITY PLAYING CONDITIONS, and the INEVITABLE and TOTAL REVOCATION of the Golf Industry EXCEPTION STATUS.

CGSA FAILED THEIR MEMBERS OVER AND OVER AND OVER AGAIN !

PROFESSIONAL LAWN CARE INDUSTRY

It is INCONCEIVABLE that CGSA supports the ANNIHILATION of the Professional Lawn Care Industry rather than join forces to FIGHT LUNATIC-TERRORIST-PROHIBITION.

This course of action remains the ONLY GUARANTEE that the Golf Industry retains its EXCEPTION STATUS.

PROHIBITION has already DESTROYED the Professional Lawn Care Industry.

CGSA ENDORSES PROHIBITION of pest control products ... as long as the Golf Industry is provided with an EXCEPTION STATUS.

However, the Golf Industry is in a VULNERABLE position regarding pest control products.

BOTH the Golf Industry AND the Modern Professional Lawn Care Industry use the SAME ingredients that are needed to control insect and weed pests.

In fact, Professional Lawn Care maintenance requires LESS PESTICIDE-INPUTS than Golf Course turf.

The Golf Industry enjoys the benefits from a Prohibition EXCEPTION STATUS despite the fact that it uses the VERY SAME INGREDIENTS employed in Professional Lawn Care maintenance.

CGSA has FAILED to defend the Golf Industry from this VULNERABLE position regarding pest control products.

Elected leaders and staff of CGSA FAILED THEIR MEMBERS YET AGAIN !

CGSA FAILED THEIR MEMBERS OVER AND OVER AND OVER AGAIN !

PLAYING CONDITIONS

It is INCONCEIVABLE that CGSA has FALSELY ALLEGED that pest control products used in the Golf Industry are NOT used for so-called COSMETIC purposes.

It is also INCONCEIVABLE that CGSA has defended the Golf Industry EXCEPTION STATUS on the basis that the need for HIGH-QUALITY PLAYING CONDITIONS SOMEHOW SUPERSEDES COSMETIC STANDARDS, especially if Integrated Pest Management (IPM) is used.

It will be IMPOSSIBLE for CGSA to defend the Golf Industry EXCEPTION STATUS on the need for HIGH-QUALITY PLAYING CONDITIONS, especially since ALL pest control products, including those used on the golf course, REPRESENT A PERCEIVED THREAT TO HEALTH AND ENVIRONMENT.

CGSA is more worried about establishing protocols for the implementation of the INEFFECTIVE Integrated Pest Management rather than focus on what its playing customers really want ... HIGH-QUALITY PLAYING CONDITIONS.

Moreover, CGSA has embarked on a LUDICROUS and ILL-FATED campaign to DOWNGRADE THE PLAYING CONDITIONS of the Golf Industry.

CGSA claims that THE GOLF INDUSTRY AROUND THE GLOBE HAS EMBARKED ON AN EFFORT TO REDUCE THE EXPECTATIONS OF THE GOLFER.

Even worse, CGSA has embarked on a campaign of DRIVING GOLFERS OUT BY TELLING THEM WHAT THEY WANT, on the pretext that HIGH-QUALITY TURF IS BAD FOR THE ENVIRONMENT. [?!?!]

This is TRULY IDIOTIC !

Unfortunately, it is NOT the role of CGSA to dictate the expectations to paying golfing customers !

CGSA FAILED THEIR MEMBERS OVER AND OVER AND OVER AGAIN !

PROVIDING WHAT THE CUSTOMER WANTS is a RULE in ANY service industry.

THE GOLFERS ARE THE BOSSES OF THE GOLF INDUSTRY.

Golf Course Superintendents are being given BAD ADVICE, and may overlook that they are EMPLOYEES, and NEED TO DO WHAT THEY ARE TOLD.

GOLFERS ARE DEMANDING HIGH-QUALITY PLAYING CONDITIONS.

CGSA and the Golf Industry must MEET the expectations of its BOSSES by developing and publishing golf MAINTENANCE PROTOCOLS and PERFORMANCE STANDARDS in order to attain HIGH-QUALITY PLAYING CONDITIONS.

Otherwise, what is the purpose of employing a WELL-EDUCATED and WELL-RENUMERATED Golf Course Superintendent ?

Elected leaders and staff of CGSA FAILED THEIR MEMBERS YET AGAIN !

SQUANDERING RESOURCES

It is INCONCEIVABLE that CGSA even attempted to SAVE-QUINTOZENE.

Quintozene is a fungicide that is now PROHIBITED by Health Canada.

It is INCONCEIVABLE that CGSA SQUANDERED ITS RESOURCES to SAVE-QUINTOZENE in view of the many questions concerning the safety of quintozene fungicide, to both the environment and desirable turfgrasses.

To SAVE-QUINTOZENE, CGSA CONCOCTED a NON-EXISTENT CRISIS.

To SAVE-QUINTOZENE, CGSA proved that it was MISGUIDED, MISLEADING, and INCOMPETENT, and it FAILED ITS MEMBERS YET AGAIN !

CGSA FAILED THEIR MEMBERS OVER AND OVER AND OVER AGAIN !

The POMPOUS and IDIOTIC elected leaders and staff of Canadian Golf Superintendents Association (CGSA) should be devoting resources to more serious issues concerning pest control products, such as the IMMINENT THREAT OF A NATION-WIDE PROHIBITION of pest control products, as well as the predictable REVOCATION OF THE GOLF INDUSTRY EXCEPTION STATUS.

Moreover, by defending a product associated with serious health, environmental, and turf phyto-toxicity issues, CGSA has WEAKENED ITS CREDIBILITY AS A PUBLIC AFFAIRS SPOKESMAN FOR THE GOLF INDUSTRY.

Elected leaders and staff of CGSA FAILED THEIR MEMBERS YET AGAIN !

FERTILIZER FEES AND TAXES

It is INCONCEIVABLE that CGSA NEVER EVEN BOTHERED to join the fight against the DESTRUCTIVE PROGRAM of FERTILIZER FEES and TAXES in the Province of Ontario.

In 2010, the Government of Ontario imposed the Municipal Hazardous or Special Waste Program Plan (MHSW) and Harmonized Sales Tax (HST).

To support the MHSW program, Enviro-Lunatic-Government-Officials CONCOCTED THE STORY THAT VAST AMOUNTS OF FERTILIZER ARE THROWN OUT EACH YEAR, with NO RELIABLE DATA.

Moreover, these Enviro-Lunatic-Government-Officials wanted to SPECIFICALLY ENSURE that the HATED Golf Industry WAS NOT PROVIDED WITH AN EXCEPTION STATUS from this program.

MHSW increased the cost of fertilizer by at least FIFTY-EIGHT CENTS per 25-kilogram-bag.

CGSA FAILED THEIR MEMBERS OVER AND OVER AND OVER AGAIN !

The Ontario Harmonized Sales Tax (HST) increased the cost of fertilizer by at least ONE-DOLLAR-AND-TWENTY-FIVE-CENTS per 25-kilogram-bag.

The price of fertilizer sold in Ontario to the Golf Industry increased by at least 50 TO 75 DOLLARS PER METRIC TON.

An 18-hole golf course requiring 30 metric tons of fertilizer per year now must spend OVER TWO THOUSAND DOLLARS MORE.

Furthermore, THE DESTRUCTIVE MSHW FEE WILL BE INCREASED OVER TIME.

Elected leaders and staff of CGSA FAILED THEIR MEMBERS YET AGAIN !

DENIAL AND PROTECTIONISM

The POMPOUS and IDIOTIC elected leaders and staff of Canadian Golf Superintendents Association (CGSA) prefer maintaining an ATTITUDE OF DENIAL and PROTECTIONISM and MOCK-DISMAY AT ANY FORM OF CRITICISM.

They are ignoring the supreme historic opportunity to join forces with the Professional Lawn Care Industry, and litigate against the LUNATIC-TERRORIST-PROHIBITION, and to fight against other serious issues.

A failure to do so will be lethal and final, and future generations will ask the question — *Why did you not act ?*

THE LOOMING GOLF INDUSTRY SHIPWRECK IS ON A COLLISION COURSE.

For the first time in all of our collective history, it can be said that there is NO LONGER A HOPEFUL FUTURE for those employed in the Golf Industry.

CULPRITS

Observers do not necessarily hold the elected leaders responsible for the FAILED, DISGUSTING and UNACCEPTABLE DECISIONS of CGSA.

Some observers blame the Administrative Staff of CGSA.

As is the case within many trade associations, the administrators frequently dictate policy for the elected officials.

Unfortunately, observers have concluded that CGSA Administrative Staff is perhaps NOT SUITED for the task of Public Affairs.

They are NOT COMPETENT to represent the Golf Industry.

MISTREATMENT AND HUMILIATION

Finally, it is INCONCEIVABLE that CGSA is INCAPABLE of WORKING TOGETHER with ANYONE OF VALUE.

CGSA elected leaders and staff have MISTREATED and HUMILIATED even the MOST DISTINGUISHED people within their trade association.

For example, CGSA UNCEREMONIOUSLY and DIGRACEFULLY DUMPED the DISTINGUISHED FOUNDING FATHER of its trade association and its official publication, GreenMaster Magazine — GORDON WITTEVEEN.

CGSA has yet to MAKE AMENDS to his memory and SEEK RESTITUTION.

OVER 85 PER CENT of recent CGSA elected leaders and staff COULD NOT BE BOTHERED TO SEND ELECTRONIC CONDOLENCES when Witteveen passed away in 2010 despite multiple requests asking them to express the proper respect.

The Golf Industry Must Address 16 Critical Issues

WARNING — Regardless of its Exception Status in many jurisdictions, the Golf Industry faces some huge challenges because of its high degree of vulnerability concerning several public affairs issues. In order to successfully deter the malicious efforts of all Enviro-Lunatic-Activists, the Golf Industry must immediately address the following sixteen critical issues.

1. The Golf Industry must CEASE focusing on the INEFFECTIVE Integrated Pest Management (IPM) strategies as the solution to its public affairs problems. Unfortunately, IPM has been designed to be applicable to the Agriculture Industry, and NOT the Golf Industry.
2. The Golf Industry must DIVULGE to the public ALL SCIENTIFIC INFORMATION that ascertains that its chemicals are definitely « *minimum-risk* » or « *reduced-risk* ».
3. The Golf Industry must publicly DENOUNCE the so-called Green Alternatives to conventional pest control products as BOGUS, and the biological-natural-organic methods, as almost INEFFECTIVE and NON-EXISTENT.
4. The Golf Industry must create a FULLY TRANSPARENT DATABASE for RIGHT-TO-KNOW INFORMATION concerning its chemicals.
5. The Golf Industry must directly and actively SUPPORT LITIGATION launched against those Enviro-Lunatic-Activists that have conspired to prohibit pest control products that are Health-Canada-Approved, Federally-Legal, Scientifically-Safe, Totally-Irreplaceable, and Absolutely-Indispensable, and CEASE BEING A MERE CASUAL OBSERVER.
6. The Golf Industry must EXPLAIN why some of its chemicals are PROHIBITED BY OTHER NATIONS, but not in Canada, and cease its wasteful « *Wag The Dog* » policies on irrelevant issues such as saving quintozone, which was ill-fated.

The Golf Industry Must Address 16 Critical Issues

Background Information from an Independent Perspective — In the United States, the Environmental Protection Agency (EPA) concluded that the risks when using quinterozone were substantial from an environmental standpoint. The EPA concluded that the re-registration of quinterozone was acceptable provided that ALL TURF USES WERE TERMINATED. In view of the many questions concerning the safety of quinterozone, it would seem preferable that the Golf Industry withdraw its petition in support of this ingredient. Moreover, by defending a product associated with serious health, environmental, and turf phyto-toxicity issues, the Golf Industry has weakened its credibility. The Pest Management Regulatory Agency of Health Canada (PMRA) followed with the same decision as the EPA by prohibiting the sale of quinterozone beyond 2010. The Manufacturing Industry WILL NOT defend quinterozone. Furthermore, the Manufacturing Industry will NO LONGER invest in ANY pest control products in Canada, since it abhors operating in markets made UNSTABLE by TERRORISM, whether political or Environmental.

7. The Golf Industry must vigorously embark on a MASSIVE PUBLIC RELATIONS campaign to STOP the proposed scheme by Enviro-Lunatic-Activists and National Democratic Party of Canada threatening a NATIONAL PROHIBITION of pest control products. NDP is the political shield for the Environmental-Terror-Movement.

8. The Golf Industry must REVIEW and JUSTIFY its current and extensive array of chemicals.

9. The Golf Industry must plan for the INEVITABLE and TOTAL REVOCATION of its EXCEPTION STATUS in most jurisdictions across Canada, in two to four years. The Golf Industry will LOSE many or ALL of its valued and necessary pest control products.

10. The Golf Industry must PROVIDE the public with SCIENTIFIC INFORMATION supporting the idea that its innovative management practices may SLIGHTLY REDUCE THE USE of pest control products.

The Golf Industry Must Address 16 Critical Issues

11. The Golf Industry must DEVELOP and PUBLISH the GOLF MAINTENANCE PROTOCOLS and the PERFORMANCE STANDARDS EXPECTED BY ITS PLAYING CUSTOMERS. So far, the Golf Industry has been ridiculously inconsistent in defining « *suitable playing surfaces* ».

12. The Golf Industry must SCIENTIFICALLY DEFINE and PUBLICALLY DISCREDIT the mis-leading term « *Organic Golf Course* », and establish policies for EXPELLING clubs using this inaccurate and misleading term from its trade associations.

13. The Golf Industry must very STRONGLY ADDRESS and DISCREDIT the misconceptions concerning imidacloprid, chlorothalonil, 2,4-D, and other chemicals.

14. The Golf Industry must TERMINATE ALL RELATIONSHIPS with all organizations that conspire to prohibit pest control products, like Canadian-Cancer-Society, World-Wildlife-Fund, and others. All related charitable tournaments that provide financial donations and support to these Prohibition-Terrorist-Organizations must be SUSPENDED and RE-DIRECTED.

15. The Golf Industry must OPPOSE the Loathsome and Ridiculous Golf Canada (formerly RCGA) that RAISES MILLIONS OF DOLLARS for the Canadian-Cancer-Society, an Prohibition-Terrorist-Organization that uses this money in its conspiracy to prohibit pest control products that are Health-Canada-Approved, Federally-Legal, Scientifically-Safe, Totally-Irreplaceable, and Absolutely-Indispensable.

16. The Golf Industry must OPENLY and FINANCIALLY SUPPORT POLITICAL CANDIDATES that OPPOSE ANY PROHIBITION of pest control products.
