In late May 2016, two of Golf Industry's most prominent Trade Associations submitted letters to Health Canada.

In both letters, Health Canada was asked to re-evaluate its assessment of Chlorothalonil as a HUMAN HEALTH CONCERN.

Chlorothalonil is the active ingredient found in a fungicide ( disease control product ) used in the Golf Course Industry.

Health Canada has PROPOSED TO ALMOST ENTIRELY PROHIBIT THE USE OF CHLOROTHALONIL ON TURF, except for a single time per year, and JUST FOR SNOW MOLD CONTROL.

The Trade Associations' submission to Health Canada is HIGHLY INAPPROPRIATE, since they CANNOT BE CONSIDERED COMPETENT to talk about pest control products.

Seemingly, the Golf Industry's Trade Associations are self-designating themselves as the opposition to every science-based national government regulator in the world.

More precisely, Trade Associations are becoming the unofficial opposition to Health Canada, whenever it suits their own vested interest.

The assessment proving that pest control products like Chlorothalonil are scientifically-safe is a process that can take up to ten years and cost hundreds of millions of dollars.

Additionally, these products are further re-evaluated every fifteen years.

... NOT by the Golf Industry's Trade Associations.

... but by Health Canada.

Only those products that pose NO unacceptable risk to human health or the environment become Health-Canada-approved and federally-legal.

Health Canada has REVISED the occupational and residential risk assessments of Chlorothalonil with more information relevant to the POTENTIAL EFFECTS OF Chlorothalonil ON HUMAN HEALTH, PARTICULARLY VIA DERMAL EXPOSURE.

## **Submissions By Trade Association To Health Canada**

Letters have been submitted to Health Canada by Canadian Golf Superintendents Association ( CGSA ) and Western Canada Turfgrass Association ( WCTA ).

According to the submission by Canadian Golf Superintendents Association ( CGSA ) —

*The CGSA does have significant concerns with some of the new restrictions that WILL NEGATIVELY AFFECT THE BUSINESS OF MANY GOLF COURSES ACROSS THE COUNTRY. The first concern is the discontinued use [ i.e. PROHIBITION ] of this product on specific and important turf diseases such as dollar spot and anthracnose.*

*Removing [ i.e. PROHIBITING ] the accessibility of this tool, especially while NO OTHER FUNGICIDES WITH THE SAME MULTI-SITE CONTACT MODE OF ACTION ARE AVAILABLE AND EFFICIENT FOR THE SAME REGISTERED USE, WOULD LEAVE GOLF COURSES VULNERABLE TO BOTH NEGATIVE FINANCIAL AND AGRONOMIC IMPACTS.*

*We are confident and urge the PMRA to use science and evidence based information in making its final decision concerning the re-evaluation [ i.e. PROHIBITION ] of Chlorothalonil.*

According to the submission by Western Canada Turfgrass Association ( WCTA ) —

*The proposed amendment [ to PROHIBIT Chlorothalonil ] will have a SIGNIFICANT NEGATIVE IMPACT on the turfgrass management industry, in particular golf courses, whose businesses relies on the proper care and health of turf.*

With PROHIBITIONS against Carbaryl, Chlorothalonil, Iprodione, Neonicotinoid Insecticides, and Quintozene, Golf Facilities will face INCREASING DIFFICULTIES in maintaining high-quality playing conditions.

If/when PROHIBITION is IMPOSED, the owners, employees, and families dependent on businesses operating in the Golf Industry will face TERROR, DESPAIR, and DESTITUTION.

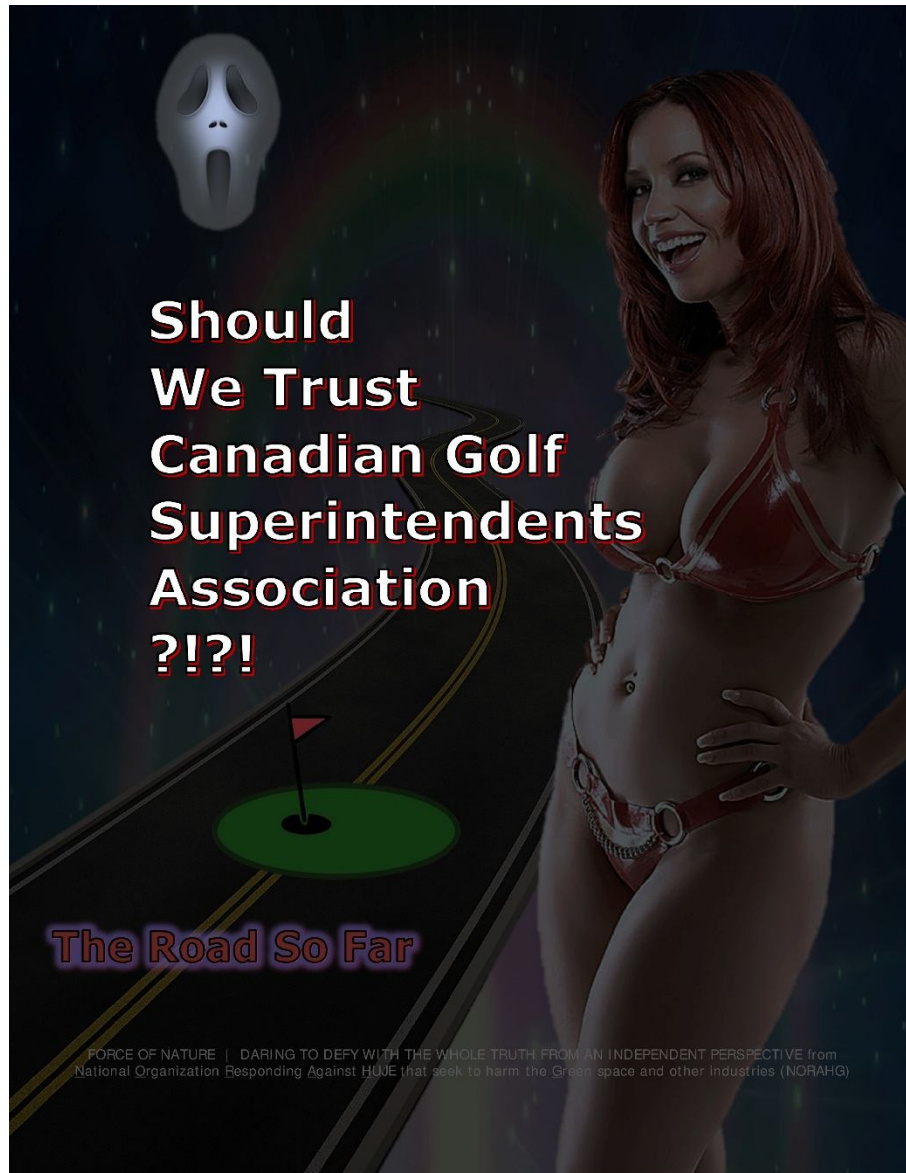

## RE : RESPONSE TO THE AMENDMENT TO THE PROPOSED RE-EVALUATION DECISION REGARDING Chlorothalonil - NOTE REV2016-06

To whom it concerns,

On behalf of the Canadian Golf Superintendents Association (CGSA), please accept our thanks for the opportunity to respond to the amendment to the proposed re-evaluation decision document for Chlorothalonil, particularly as it relates to the use of this ingredient on golf course turf.

Chlorothalonil, the active ingredient in products such as Daconil 2787, Daconil Ultrex, QP Chlorothalonil and Instrata, is a key active ingredient that is part of integrated pest management programs on golf courses throughout the country and is A KEY COMPONENT IN RESISTANCE MANAGEMENT STRATEGIES. Golf course superintendents are trained professionals that understand the specific environments of each site on their properties, keep records of pest infestation, manage damage thresholds limits, use cultural practices to affect the growing environments and reduce the incidence of pest damage before using, with the utmost professionalism and by certified applicators, registered pest control products.

We are encouraged by the PMRA's indication that Chlorothalonil would still be allowed for use on turf to control snow mold diseases however, it should be recognized that Chlorothalonil is also AN IMPORTANT ACTIVE INGREDIENT for the control of other diseases such as anthracnose and dollar spot. IT IS THE ONLY MULTI-SITE CONTACT FUNGICIDE ON THE MARKET AND IS ONE OF THE MOST EFFICIENT ACTIVE INGREDIENTS TO STOP A DISEASE WHEN IT HAS EXCEEDED THRESHOLD LEVELS. The availability of this product ELIMINATES THE RELIANCE ON PREVENTATIVE FUNGICIDE APPLICATIONS and we would strongly encourage continued access for use on golf course turf which is applied on an entirely grass covered soil.

Removing [ i.e. PROHIBITING ] the accessibility of this tool, especially while NO OTHER FUNGICIDES WITH THE SAME MULTI-SITE CONTACT MODE OF ACTION ARE AVAILABLE AND EFFICIENT FOR THE SAME REGISTERED USE, WOULD LEAVE GOLF COURSES VULNERABLE TO BOTH NEGATIVE FINANCIAL AND AGRONOMIC IMPACTS.

According to the 2014 National Allied Golf Associations « *economic impact study* », golf courses contribute greatly to local economies and are small businesses that employ over 300,000 people across the country.

Canadian golf's total direct economic activity is estimated at 19.7 billion dollars and accounts for about 14.3 billion dollars of our country's GDP. Golf courses need to have the proper tools to ensure that we protect the investments made by golf businesses across the country.

The CGSA does have significant concerns with some of the new restrictions [ i.e. PROHIBITION ] that WILL NEGATIVELY AFFECT THE BUSINESS OF MANY GOLF COURSES ACROSS THE COUNTRY. The first concern is the discontinued use of this product on specific and important turf diseases such as dollar spot and anthracnose.

Equally concerning is restricting the re-entry interval to 22 days. It will not be manageable by most golf courses in Canada who cover their greens for winter protection. This re-entry interval would eliminate the use of this essential product due to significant loss of revenue while closing the golf course. Furthermore, the requirement for an enclosed cab for applicators will be cost prohibitive for many golf businesses across the country. We also hope that you will consider the fact that there are NO OTHER PRODUCTS ON THE MARKET WITH THE SAME MODE OF ACTION.

We are confident and urge the PMRA to use science and evidence based information in making its final decision concerning the re-evaluation [ i.e. PROHIBITION ] of Chlorothalonil.

We sincerely hope that you will consider the golf industry's concerns in this matter.

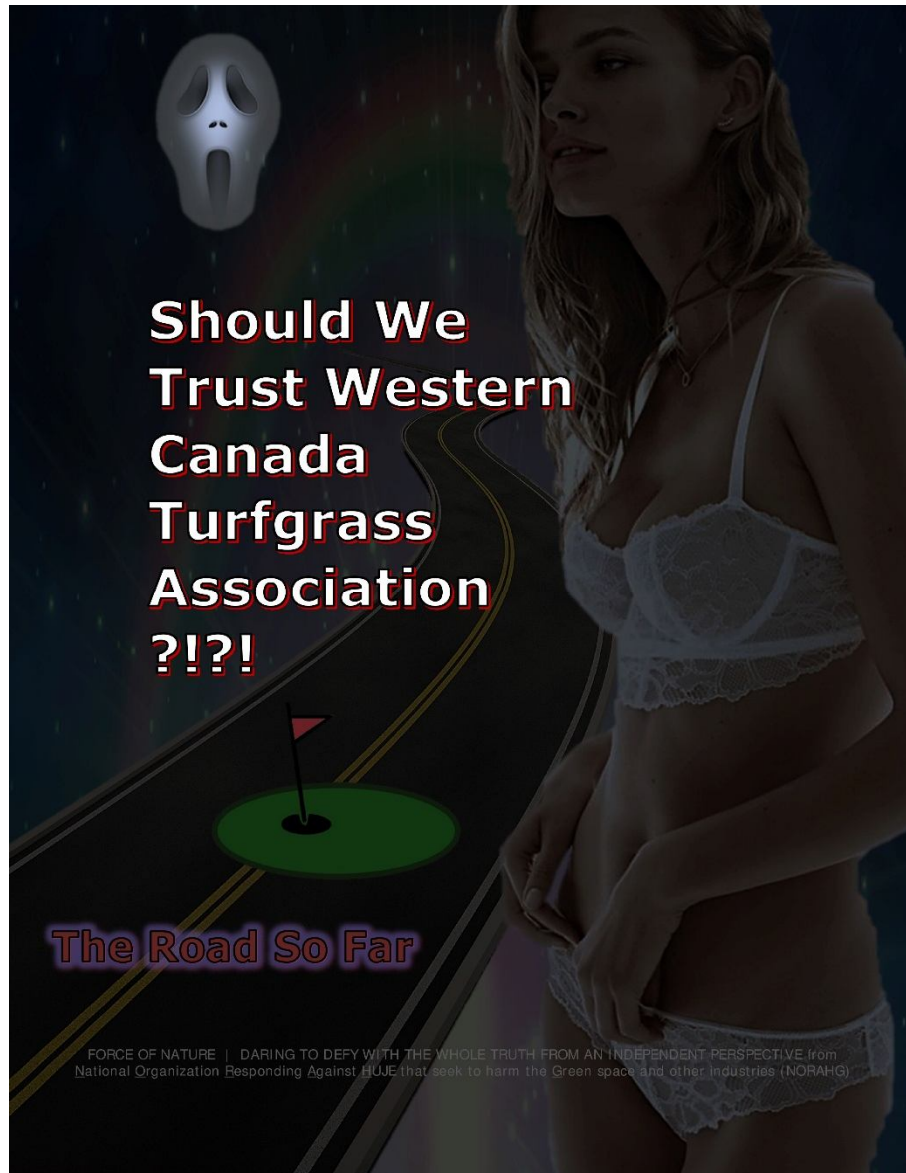

**Dear Sir or Madam :**

On behalf of the Western Canada Turfgrass Association ( WCTA ), allow this letter to serve as our response to the proposed re-evaluation decision regarding the active ingredient Chlorothalonil.

The WCTA is a 700+ member, not-for-profit industry organization representing professional turfgrass managers and the associated industry supply network in western Canada. Areas under the management of these professionals include beneficial greenspace infrastructure such as golf courses, sports fields, parks, and other maintained turf spaces, along with sod farms.

As a professional industry organization, the WCTA has a long-standing track record of supporting and promoting the safe use of pesticides in our work environments through proven IPM practices and close cooperation with government regulatory bodies.

- In 2002, our organization partnered with the BC Ministry of Agriculture to publish the comprehensive resource, IPM Guide for Turfgrass Managers.
- Since 2002, the WCTA has acted as an official Credit Coordinator for Pesticide Applicator Certificate Continuing Education Credits in British Columbia, currently tracking points for over 300 individuals and designing many annual educational offerings to include CEC's toward maintaining an active pesticide applicator certificate.
- Our organization actively participates in the PMRA NOMULE committee helping represent the turf management industry.
- Since 2009, the WCTA has worked with the BC provincial government to craft Integrated Pest Management ( IPM ) legislation aimed at enhancing environmental protection.
- In 2009, the WCTA organized and chaired the National Turf Industry Steering Committee in cooperation with the Pest Management Regulatory Agency.

These on-going efforts help ensure turf managers are well-trained in all aspects of pesticide storage, handling, application and disposal, and are conscientious about choosing the appropriate product, proper equipment calibration, ensuring that applications reach target areas, and following specific label instructions with regards to the use of personal protective



equipment, applying the correct rates and adhering to required re-entry intervals.

Chlorothalonil is used extensively around the world and, although the product has had an established history of safe and effective use for more than 45 years, the proposed amendment would restrict its use to a single yearly application for the control of snow mold.

The proposed amendment will have a **SIGNIFICANT NEGATIVE IMPACT** on the turfgrass management industry, in particular golf courses, whose businesses relies on the proper care and health of turf.

Based on participation, golf is the number one recreational activity in Canada with an estimated yearly participation of 5.7 – 6.0 million and direct spending of 19.7 billion dollars. The Golf Industry contributes 2.8 billion dollars to the province of British Columbia's GDP, 2.4 billion dollars in Alberta, another 446 million dollars in Saskatchewan and 104,000 jobs across the three provinces. In addition, Swedish research from 2008 showed golfers are healthier and live longer than the average population.

Currently, there are four products registered for various diseases on golf courses that are either a standalone product ( Daconil 2787 per Ultrex and Equus 82.5 ), or multiple active products ( Concert and Instrata ). These products are intended to control various summer and winter diseases, although Instrata is only registered for snow mold.

A survey of golf course Superintendents in British Columbia revealed that summer diseases controlled by Chlorothalonil included dollar spot, anthracnose, leaf spot and fusarium patch while winter diseases were grey and pink snow mold. Summer disease pressure in the Prairie Provinces is reduced due to a drier climate, although winter snow molds are often just as devastating.

Typically, summer diseases are treated monthly. In order to prevent disease resistance, Chlorothalonil is rotated with chemistries from other fungicide groups. If a rotational application strategy is employed, **THREE APPLICATIONS WOULD BE THE MAXIMUM** number applied in summer. For snow mold prevention, two fall applications are typically applied and seldom as a single active ingredient product. Maximum application rates for summer diseases are 140 g per 100 square metres of active ingredient, while winter disease prevention rates of application are 108 g per 100 square metres of active ingredient based on the product, Instrata.

Re-entry periods are less than 12 hours for summer application. Fall applications are typically conducted after golf courses close for the winter and therefore pose no re-entry risk. In-season post application activities where workers might handle plant material would include mowing, hole location changing and turf repair. Golfer exposure would occur as they handle equipment during the course of play. Because Chlorothalonil is a contact fungicide, long-term exposure from a single application is minimized because golf greens are typically mowed daily, removing leaf clippings.

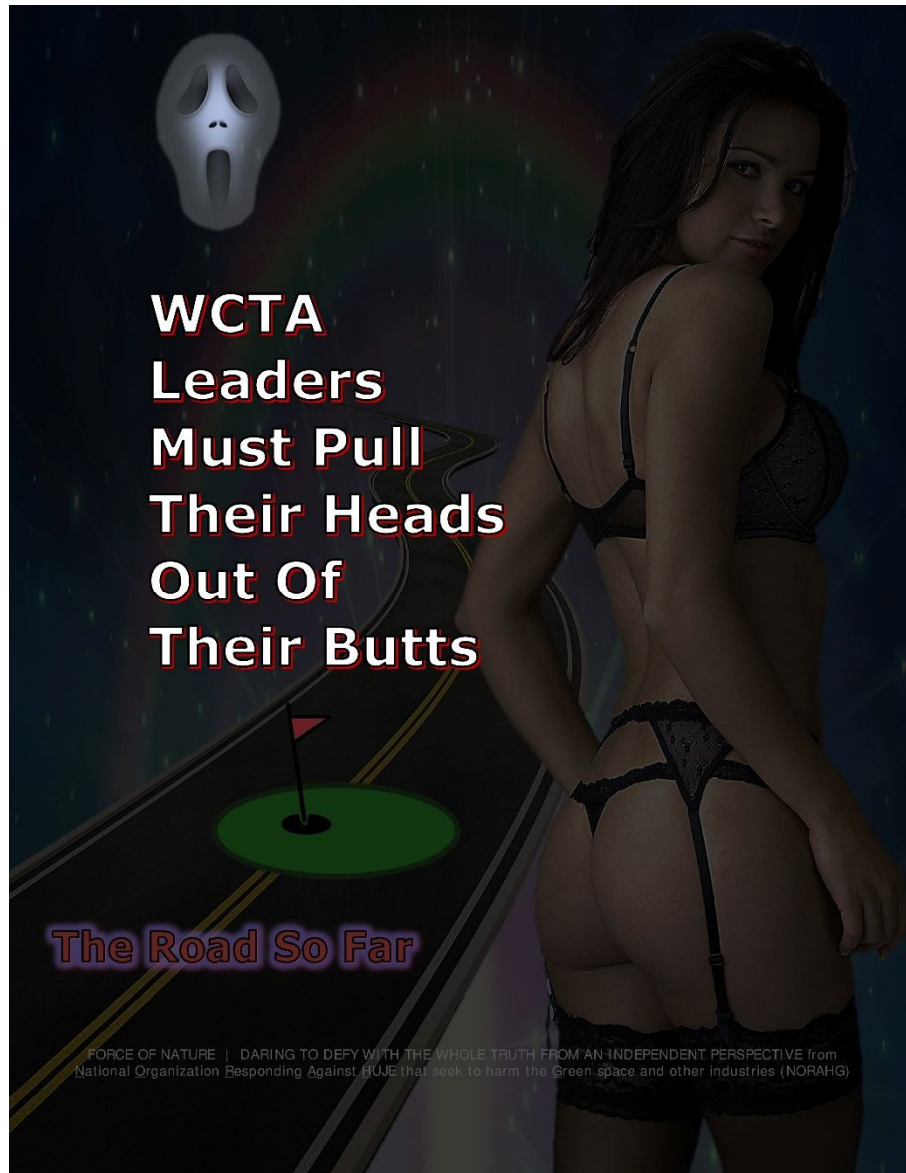

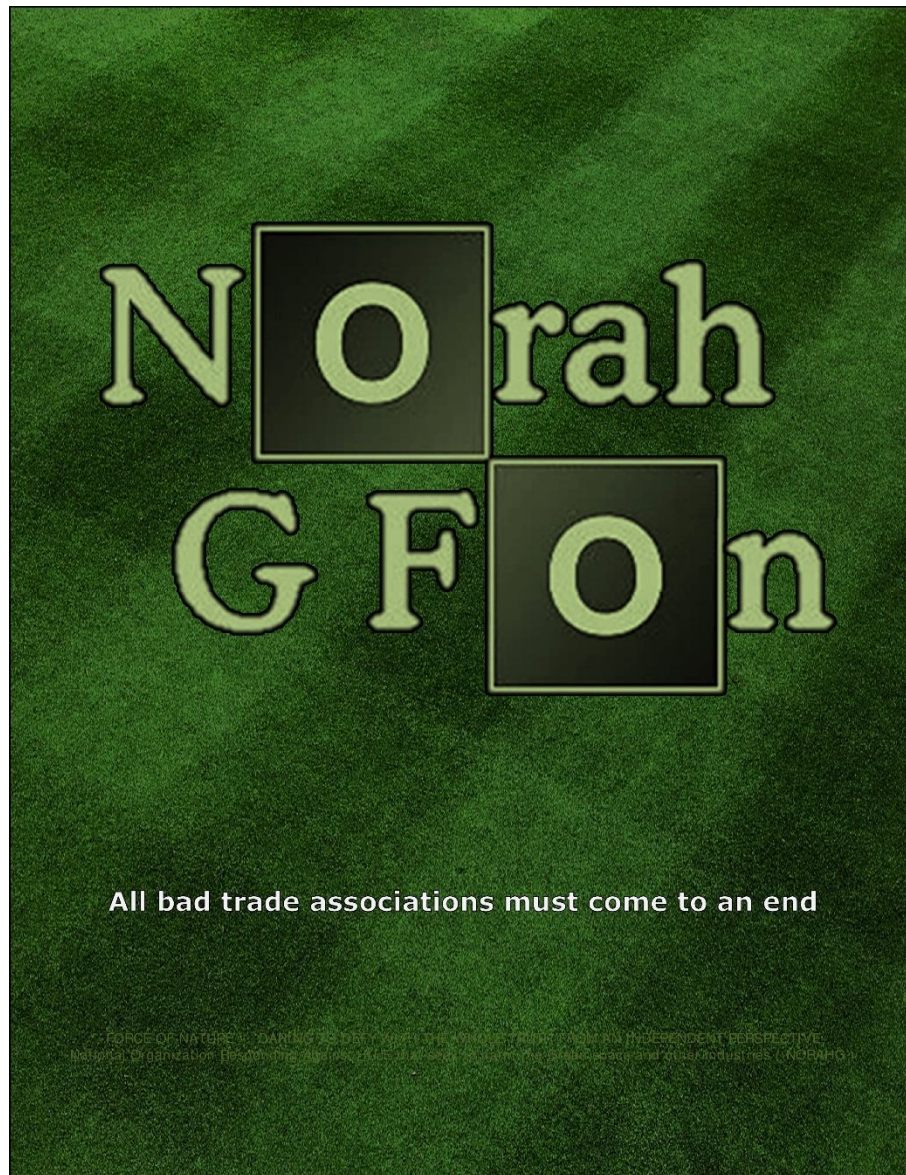
