At Golf Course Superintendents Association of America (GCSAA), Rhett Evans has expertise in Parks and Recreation, and NOT Soil Science. NO ONE involved in this SURVEY has the REQUIRED COMPETENCE for the ASSESSMENT OF ESSENTIAL FERTILIZER NUTRIENTS. The Golf Industry's Trade Associations have absolutely NO EXPERTISE regarding fertilizers and their fate in the environment ! Fertilizers used by the Golf Industry are SAFE for the environment ! Their SURVEY is a mere tool for ANTI-FERTILIZER PROPAGANDA.

As well as finding a REDUCTION IN FERTILIZER NUTRIENT USAGE, this LEFT-WING ANTI-FERTILIZER SURVEY found that golf course superintendents CUT BACK MOST DRAMATICALLY ON PHOSPHORUS, which is one of the three ESSENTIAL NUTRIENTS used to manage turf.

BACKGROUND INFORMATION — FERTILIZER NUTRIENT REDUCTION PROGRAMS WERE NOT CREATED BY GOLF SUPERINTENDENTS ! — In fact, the superintendents themselves DID NOT necessarily decide to reduce their use of phosphorus. In most cases, the fertilizer manufacturing industry made the decision for them by relentlessly offering low- or no-phosphorus fertilizers. The reduction of phosphorus was based upon pricing strategies and validating the anti-fertilizer activist agenda. In recent years, the costs of sources of phosphorus have risen. Low- or no-phosphorus fertilizer mixtures were foisted upon superintendents with the objective of keeping the overall prices in check. Moreover, the fertilizer manufacturing industry adopted low- or no-phosphorus fertilizers, with the mistaken strategy of appeasing fanatical-activists who falsely allege that phosphorus fertilizers are somehow damaging to the environment. The Golf Industry's Trade Associations are spreading FALSE AND MISLEADING DOCTRINES against the use of ESSENTIAL FERTILIZER NUTRIENTS, CONTRADICTING over twenty-five years of research, and proving that they have absolutely NO EXPERTISE regarding Soil Science and/or Essential Nutrient Management !

An ARBITRARY REDUCTION of 53 per cent in PHOSPHORUS FERTILIZER USE was noted between 2006 to 2014, with a particularly ARBITRARY REDUCTION in the Northeast and North Central regions of America.

Lower amounts of POTASSIUM and NITROGEN are also being used according to the LEFT-WING ANTI-FERTILIZER SURVEY, with ARBITRARY REDUCTIONS of 42 per cent and 34 per cent respectively.

This has resulted in an ARBITRARY REDUCTION of more than 80,000 tons per year of ESSENTIAL, YES **ESSENTIAL**, NUTRIENTS, like NITROGEN, PHOSPHORUS, and POTASSIUM.

FERTILIZER NUTRIENT REDUCTION PROGRAMS ARE ARBITRARY AND WRONG ! — Which left-wing anti-fertilizer fanatics decided that nitrogen, phosphorus, and potassium ?!?! The goal of nitrogen, phosphorus, and potassium fertilization is to augment these ESSENTIAL NUTRIENTS in the soil so that colour, density, and growth are improved. The Golf Industry's Trade Associations are spreading FALSE AND MISLEADING DOCTRINES against the use of

ESSENTIAL FERTILIZER NUTRIENTS, CONTRADICTING over twenty-five years of research, and proving that they have absolutely NO EXPERTISE regarding Soil Science and/or Essential Nutrient Management !

USING A BALANCED RATIO FOR FERTILIZATION WILL DECREASE TURF SUSCEPTIBILITY TO CERTAIN DISEASES ! — The Golf Industry's Trade Associations MUST STOP IMPOSING LEFT-WING ANTI-FERTILIZER DOCTRINES on their memberships. Their FALSE, MISLEADING, AND ARBITRARY DOCTRINES against the use of ESSENTIAL FERTILIZER NUTRIENTS CONTRADICT over one-hundred years of research and field expertise. ARBITRARY FERTILIZER NUTRIENT REDUCTION PROGRAMS will be DISTASTROUS for the Golf Industry. Overall, the use of ADEQUATE RATES OF NITROGEN will NOT LEAD to disease problems. Using a fertilizer with a ratio of 3 : 1 : 2 (nitrogen : phosphorus : potassium), WILL DECREASE TURF SUSCEPTIBILITY TO CERTAIN DISEASES, when compared with nitrogen alone. Examples of fertilizers with a 3 : 1 : 2 ratio are 18-6-12 and 15-3-9. These types of fertilizers will tend to be used on golf course putting greens. At least 50 to 75 per cent slow-release nitrogen is suggested.

USING ADEQUATE NITROGEN WILL DECREASE TURF SUSCEPTIBILITY TO CERTAIN DISEASES ! — The incidence of certain diseases, such as Dollar Spot and Red Thread, will INCREASE with LOW NITROGEN fertilization. Conversely, ADEQUATE FERTILIZATION PRACTICES will DECREASE TURF SUSCEPTIBILITY to the following diseases — • Fusarium Patch (Microdochium Patch) • Red Thread & Pink Patch • Take-All.

USING HIGH POTASSIUM AND HIGH PHOSPHORUS WILL DECREASE TURF SUSCEPTIBILITY TO CERTAIN DISEASES ! — A HIGH-POTASSIUM (with HIGH-PHOSPHORUS) fertilizer mixture may be used to SUPPRESS Fusarium Patch (Microdochium Patch) disease. This disease is common in many parts of the nation. It is recommended to use a fertilizer with a 3 : 5 : 5 ratio, and apply it during the fall months. The closest practical example of a fertilizer with this ratio is 15-20-21. This fertilizer is recommended for most types of turfgrasses. Since Fusarium Patch disease is prevalent under cool and moist conditions; hence, at least 50 per cent slow-release nitrogen is recommended.
