The Axis of Environmental Evil

Tax-Exempt For-Profit Environmental-Terrorist-Organizations are financed through a system described as THE AXIS OF ENVIRONMENTAL EVIL, which imminently threatens to ANNIHILATE the Professional Lawn Care Industry.

In Canadian provinces like Ontario, the AXIS includes THREE ENVIRO-LUNATIC-ALLIES —

- GOVERNMENT AGENCIES
- PRIVATE FOUNDATIONS
- TERRORIST-ORGANIZATIONS

PERSONAL DONATIONS are also a major source of funding of the Environmental-Terrorist-Organizations.

In many cases, it is very clear what the funding has been used for.

In other cases, the money has been CLEVERLY DETOURED AND MISAPPROPRIATED against industries such as Professional Lawn Care.

There can no longer be any assumption that environmental or health care funding to ENVIRO-TERRORIST-ORGANIZATIONS is used to solve/cure the problems of society, but rather TO RUIN PEOPLE'S JOBS AND TO ANNIHILATE BUSINESSES.

Principal Interests and Agendas

It Basically Comes Down Money

Ronald G. Dodson is Founder, President, and Chief Executive Officer (CEO) of Audubon International, as well as Founder and Chairman of the Board of the Audubon Society of New York State, Inc.

Dodson is the Creator of the Audubon Cooperative Sanctuary Program for Golf Courses — he represents virtually the ONLY bright spot in the Environmental Movement, and he single-handedly legitimized the name Audubon.

Dodson has harshly criticized Environmental-Terrorist-Organizations like National Audubon Society, a sister organization, and its INFATUATION FOR MONEY —

Most Environmental–Terrorist–Organizations operate as TAX–FREE organizations because of CHARITABLE or NON–PROFIT STATUS.

In other words, most of them DO NOT PAY TAXES, just like churches.

Environmental–Terrorist–Organizations are funded or financed by six major sources —

For many Environmental–Terrorist–Organizations, SIXTY PER CENT, OR MORE, OF FUNDING ORIGINATES FROM GOVERNMENT GRANTS.

Millionaire Organizations

The following MILLIONAIRE Tax–Exempt For–Profit Non–Expert Environmen–tal–Terrorist–Organizations have CONSPIRED, directly or indirectly, to IM–POSE public policy PROHIBITING the use of pest control products.

These MULTI–MILLION DOLLAR MONEY–MAKING MACHINES also finance other Environmental–Terrorist–Organizations.

CANADIAN ASSOCIATION OF PHYSICIANS FOR THE ENVIRONMENT (CAPE) claims to have almost five thousand members. Most of its membership is not even comprised of physicians. The cost of a CAPE membership is one hundred dollars per year. Its operating budget appears to be less than one million dollars per year, and it has about one dozen employees. CAPE received at least two–hundred–and–fifty–thousand dollars directly from the Government of Ontario for the period 2002–2007.

CANADIAN CANCER SOCIETY (CCS) accumulates one–hundred–and–thirty–five–million dollars per year, and a major source of donations originates from the sale of Daffodil flowers and pins. Furthermore, on an annual basis, Golf Canada (formerly Royal Canadian Golf Association, RCGA) raises over 800,000 dollars for CCS through a charity called Golf Fore The Cure. CCS has several dozen lobbyists operating across Canada.

Millionaire Organizations (continued)

CANADIAN ENVIRONMENTAL LAW ASSOCIATION (CELA) is composed of thirteen employees and five legal counsels. The operating budget has been estimated at well over one million dollars per year. CELA has received at least two-hundred-thousand dollars directly from the Government of Ontario for the period 2007-2008.

DAVID SUZUKI FOUNDATION claims to be funded by more than forty-thousand donors from around the world (including eighteen-thousand in Ontario), as well as over fifty corporations and foundations. With fifty employees, its operating budget is likely to be close to five million dollars per year. Suzuki avoids government grants, although it does accept money from organizations funded by the government. Nonetheless, Suzuki has a policy not to accept any type of government grants, and prefers to remain as non-profit independent charity. From at least five of its principal private donors alone, Suzuki has obtained over five million dollars since its creation in 1991. Suzuki is the largest multi-million dollar money-making machine of its kind within the Environmental-Terrorist-Movement.

ECOJUSTICE CANADA claims to have thirty-thousand active supporters that donate money to its cause. It has an operating budget of about four million dollars per year, and employs a contingent of forty staff members. Like Suzuki, Ecojustice also has a policy of not accepting any government grants, and prefers to remain as non-profit independent charity. Nonetheless, Ecojustice does accept money from organizations funded by the government.

Millionaire Organizations (continued)

ENVIRONMENTAL DEFENCE CANADA (EDC) has an operating budget of over three million dollars per year, and employs almost twenty-five staff members. EDC operates with several lobbyists in Ottawa. In 2008, EDC received five-hundred-thousand dollars from the Government of Ontario, and eighty-five-thousand dollars from the Government of Canada. Additionally, EDC received a total of over one million dollars from the Government of Ontario for the period 2004-2009.

ONTARIO COLLEGE OF FAMILY PHYSICIANS (OCFP) claims to have more than 6,400 members. Its operating budget is between half to one million dollars per year. OCFP received over three million dollars just from the Government of Canada alone, for the period 2004-2008.

ORGANIC LANDSCAPE ASSOCIATION (FORMERLY ORGANIC LANDSCAPE ALLIANCE, OLA) has a mere ten members which it refers to as service providers. They are simple lawn care companies that boast not to use pest control products. OLA received almost one-hundred-thousand dollars in grants, mostly from the Government of Ontario.

SIERRA CLUB OF CANADA has an operating budget of over 1.25 million dollars per year. This group received funding from the Government of Ontario.

WORLD WILDLIFE FUND OF CANADA (WWF) has an operating budget of approximately four million dollars per year. This organization claims to have 150,000 supporters across Canada. In 2008, WWF received hundreds of thousands of dollars in grants from the Government of Ontario and the Government of Canada.

Of all the sources of funding, the GOVERNMENT GRANTS ARE THE MOST UN-ETHICAL, the most unfair, and the most insidious.

Government grants, especially in the Province of Ontario, led to the DESTRUCTION of the Professional Lawn Care Industry.

Many Environmental-Terrorist-Organizations are actually financed with government tax dollars, through agencies such as The Ontario Trillium Foundation (OTF).

OTF operates as the FINANCIAL SHIELD used by the Government of Ontario to supply money to Environmental-Terrorist-Organizations.

This money, directly or indirectly, paid for infra-structures and activities that led to the DESTRUCTION of the Professional Lawn Care Industry.

There is something HIDEOUSLY WRONG with an Environmental-Terrorist-Organization that is FINANCED WITH GOVERNMENT MONEY, which CONSPIRES TO PROHIBIT federally-legal pest control products, and that EXTENSIVELY DAMAGES tax-paying businesses and workers in the Professional Lawn Care Industry.

According to a 2008 report from the National Center for Charitable Statistics, here are the most up-to-date statistics concerning U.S. Enviro-Lunatics —

<< Taken as a whole, the environmental movement appears to have grown in number of organizations, members, and in total revenues almost every year since 1960. >>

Total revenue for environmental and conservation groups GREW FROM 1.9 BILLION DOLLARS IN 1989 TO 8.2 BILLION DOLLARS IN 2005, the latest year for which data was available.

The rate of growth between 1989 and 2005 was 50 per cent higher than the average for all public charities.

According to National Center for Charitable Statistics, 8,078 of the estimated 26,000 ENVIRONMENTAL NON-PROFITS received enough income to require them to file an IRS Form 990 tax return.

Some 40 per cent of the 26,000 environmental groups are dedicated to ...

- land trusts
- protecting natural resources and water resources/wetlands conservation.

About 9 per cent are dedicated to ...

- political advocacy

Another 9 per cent ...

- the highly politicized world of environmental education.

The remaining 42 per cent are devoted to narrower thousands of environmental issues like ...

- beautification projects and recycling
- botanical gardens
- fisheries
- specific species

Still, **POLITICAL ACTIVITY CONSUMES VAST AMOUNTS** of the environmental movement's resources.

Of the 8.2 billion dollars in annual revenue collected by the country's 26,000 environmental non-profits, **32 PER CENT OF IT GOES TO 285 THAT ARE BASED IN THE WASHINGTON, D.C., AREA.**

From 1996 to 2005, 105 new environmental non-profits were started in metro D.C. — a 62 per cent increase.

And the share of total revenue rises to 43 per cent if organizations are included from the mid-Atlantic region, within easy striking distance of the nation's capital.

The regional demographics also suggest a large political disparity in the environmental movement between the grass-roots and the D.C.-based activists.

Expertise in — environmental issues and environmental terrorism — turf and ornamental maintenance and troubleshooting — history of the industry — sales and distribution of seeds, chemicals, fertilizers, and equipment — fertilizer manufacturing

Notable activities — worked in virtually all aspects of the Green Space Industry, including golf, professional lawn care, distribution, environmental compliance, government negotiations, public affairs, and workplace safety — supervisor, consultant, and programmer for the successful execution of hundreds of thousands of management operations in the golf and urban landscape, as well as millions of pest control applications — advisor, instructor, and trainer for thousands of turf and ornamental managers and technicians — pesticide certification instructor for thousands of industry workers — founder of modern professional lawn care industry — writer for industry publications and e-newsletters — the only true reliable witness who intervened in the development of prohibition in the town of Hudson, Quebec

Special contributions — creator of the exception status that has allowed the golf industry to avoid being subjected to the prohibition of pest control products — creator of the signs that are now used for posting after application — co-founder of annual convention for Quebec golf course superintendents — the major influence for the decision by Canadian Cancer Society to stop selling for profit pesticide treated daffodils — retired founder of Force Of Nature and A Look At e-newsletters
