Calgary (pronounced /ˈkælgri, ˈkælgəri/) is the largest city in the Province of Alberta, Canada. The Calgary Metropolitan Area (CMA) is the third most diverse in Canada in terms of visible minorities after Toronto and Vancouver when considering only CMAs with population greater than 200,000. It is located in the south of the province, in an area of foothills and high plains, approximately 80 km (50 miles) east of the front ranges of the Canadian Rockies. The city is located in the Parkland region of Alberta. Calgary is the third largest civic municipality, by population in Canada, and is also an emerging global city. According to the GaWC, Calgary is a "gamma negative world city".

In the Canada 2006 Census, the city had a population of 988,193 and the CMA had a population of 1,079,310. As of the 2009 civic census, Calgary's population was 1,065,455 and the CMA had a population of 1,182,446.

Greater Calgary is the fifth largest CMA in the country after Toronto, Montreal, Vancouver, and Ottawa. Located 300 km (200 mi) due south of Edmonton, statisticians define the narrow populated area between these cities as the "Calgary-Edmonton Corridor". LOBBY HEATS UP FOR BY-LAW BANNING PESTICIDE USE IN CALGARY

On WEDNESDAY OCT 7TH, the Standing Policy Committee on Utilities and Environment, are meeting to hear recommendations for a pesticide by-law.

Calgary is the largest municipality in Canada without a pesticide regulation.

SO WHAT ?

As of SEPT 2008, **133** municipalities passed the by-law, with eleven other municipalities in the process of passing it.

COMMENTARY FROM AN INDEPENDENT PERSPECTIVE — AS OF 2009, THE MUNICIPALITIES OF ONTARIO HAVE BEEN STRIPPED OF THEIR PROHIBITION POWERS. THE MUNICIPALITIES CLEARLY WERE NOT KNOWLEDGEABLE ENOUGH TO ENACT PROHIBITIVE BY-LAWS. A MUNICIPALITY HAS AN ONUS OF RESPONSIBILITY TO VERIFY THE JUNK SCIENCE INFORMATION THAT SERVES AS THE BASIS FOR PROHIBITION LEGISLATION. SO FAR, MUNICIPALITIES HAVE FAILED TO BASE THEIR LEGISLATIVE DECISIONS ON SOUND SCIENCE. UNFORTUNATELY, MANY MUNICIPALITIES PUBLICLY HAVE SUPPORTED JUNK SCIENCE ON THEIR WEB SITES AND IN PUBLIC STATEMENTS.

COMMENTARY FROM AN INDEPENDENT PERSPECTIVE — AS THE LOCAL LEGAL AUTHORITY, MUNICIPALITIES HAVE A DUTY TO MAKE DECISIONS FOR THE WELL-BEING OF THE COMMUNITY, BUT, WITH PROHIBITIONIST LEGISLATION, THEY NONETHELESS FAIL IN THEIR BASIC RESPONSIBILITIES. CONSEQUENTLY, THE PROVINCE OF ONTARIO ELIMINATED THE MUNICIPAL AUTHORITY TO PROHIBIT PEST CONTROL PRODUCTS, REGARDLESS OF THE RULING OF THE SUPREME COURT OF CANADA CONCERNING THE TOWN OF HUDSON.

However, not everyone considers such by-laws to be effective.

THEY ARE NEEDLESS, SENSELESS, AND MALICIOUS !

A **CBC Marketplace** investigation in 2007 found pesticide products that were illegal to use in a community were still easily purchased in major stores.

So WHAT ?

In **Toronto**, whose pesticide by-law passed in 2002, there were no convictions in 2006, one in 2007 and three in 2008.

So WHAT ?

GIDEON FORMAN, Executive Director of the **Canadian Association of Physician's for the Environment** will be participating in the hearing as will the **Canadian Cancer Society**. Together they have lobbied City Council to put a stop to unnecessary pesticide use in Calgary.

MANIACS SHOULD REPORT ON RESEARCH THAT COMPLIES WITH THE SAME RESEARCH STANDARDS AS THE PEST CONTROL PRODUCT INDUSTRY. INDUSTRY MUST COMPLY WITH VERY PRECISE AND DEMANDING STANDARDS WHEN IT COMES TO UNDERTAKING THE SCIENTIFIC RESEARCH REQUIRED BY GOVERNMENT REGULATORY AGENCIES. SCIENTIFIC DATA SUBMITTED TO HEALTH CANADA AND OTHER FEDERAL REGULATORS MUST BE DONE BY GOOD LABORATORY PRACTICE (GLP) QUALIFIED LABORATORIES.

AN UNINTENTIONAL GLP VIOLATION CAN INVALIDATE THE STUDY, REQUIRING THE STUDY TO BE REPEATED, WHICH IS VERY COSTLY.

UNDER THE PEST CONTROL PRODUCTS ACT, INTENTIONALLY MISREPRESENTING THE FINDINGS OF A GLP STUDY IS A VIOLATION THAT UPON CONVICTION, CAN LEAD TO A FINE UP TO \$500,000 OR A JAIL TERM OF UP TO THREE YEARS.

WRONG !

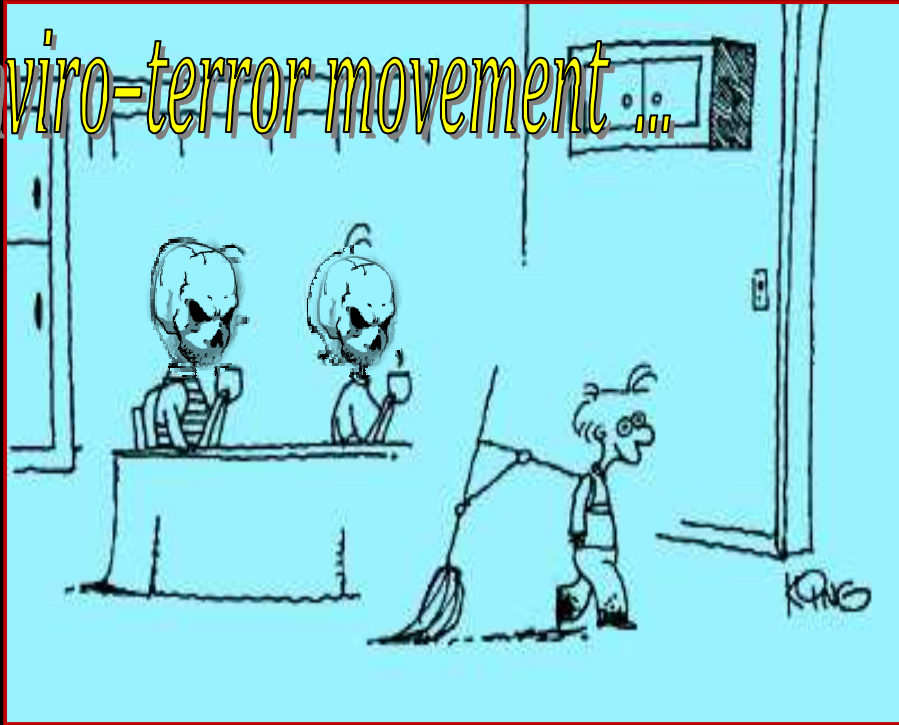
