DUBIOUS GREEN ALTERNATIVES PROMOTED BY ENVIRO-MANIACS !

COMMENTARY FROM AN INDEPENDENT PERSPECTIVE —

ENVIRO-LIE : THERE ARE VALID ALTERNATIVES TO CONVENTIONAL PEST CONTROL PRODUCTS !

FACT : SOME OF THE SO-CALLED GREEN ALTERNATIVES HAVE NEGATIVES RANGING FROM ALMOST TOTAL INEFFECTIVENESS EXCEPT UNDER VERY SPECIFIC CIRCUMSTANCES, TO A QUESTION ABOUT THEIR TOXICITY.

FACT : OVERALL, SO-CALLED LOWER-RISK ALTERNATIVES OR GREEN ALTERNATIVES ARE LESS EFFECTIVE AND STUNNINGLY MORE EXPENSIVE THAN CONVENTIONAL PEST CONTROL PRODUCTS.

FACT : THE USE OF SO-CALLED GREEN ALTERNATIVES, WHICH ARE LESS EFFECTIVE THAN CONVENTIONAL PEST CONTROL, MAY COST AS MUCH AS TEN TIMES MORE !

FACT : THE SO-CALLED LOWER-RISK ALTERNATIVES OR GREEN ALTERNATIVES ARE NOT SAFER, NOT BETTER, AND NOT MORE EFFECTIVE !

ENVIRO-DECEPTION : POLITICIANS AND THE PUBLIC WERE ASSURED BY ENVIRO-MANIACS THAT SO-CALLED LOWER-RISK ALTERNATIVES, OR GREEN ALTERNATIVES, WERE ALREADY AVAILABLE TO REPLACE CONVENTIONAL PEST CONTROL PRODUCTS.

ENVIRO-DECEPTION : CONVENIENTLY, MANY OF THESE GREEN ALTERNATIVES ARE DISTRIBUTED BY THE ENVIRONMENTAL TERROR ORGANIZATIONS THEMSELVES ! THE SAME ORGANIZATIONS THAT SEEK TO CONSPIRE FOR PROHIBITION. MANY ENVIRO-MANIACS AND THEIR ORGANIZATIONS ARE SIMPLY RICH AND GREEDY SALESMEN THAT HAWK THEIR OWN LINE OF SO-CALLED ALTERNATIVE GREEN PRODUCTS !
