Suzuki — Do you use pesticides in an attempt to improve the appearance of your lawns or garden ? Think again.

Suzuki — Researchers have found that pesticides can be associated with serious illnesses, including cancer, damage to the immune system, and neurological problems. Children are particularly vulnerable. [WRONG !]

THIS INDUSTRY MUST COMPLY WITH VERY PRECISE AND DEMANDING STANDARDS WHEN IT COMES TO UNDERTAKING THE SCIENTIFIC RESEARCH REQUIRED BY GOVERNMENT REGULATORY AGENCIES. SCIENTIFIC DATA SUBMITTED TO HEALTH CANADA AND OTHER FEDERAL REGULATORS MUST BE DONE BY GOOD LABORATORY PRACTICE (GLP) QUALIFIED LABORATORIES.

FACT : THE ONTARIO COLLEGE OF FAMILY PHYSICIANS (O.C.F.P.) DOES NOT HAVE ANY QUALIFIED LABORATORIES FOR TESTING PEST CONTROL PRODUCTS. IN FACT, IT HAS NO LABORATORIES WHATSOEVER.

FACT : NOT A SINGLE PERSON AT THE ONTARIO COLLEGE OF FAMILY PHYSICIANS (O.C.F.P.) HAS ANY RECOGNIZED EXPERTISE, TRAINING, OR BACKGROUND, IN MATTERS CONCERNING PEST CONTROL PRODUCTS ! MOST OF THESE PEOPLE ARE MERE HEALTH CARE WORKERS, AND NOT SCIENTISTS OR RESEARCHERS !

Quebec

Suzuki — The Province of Quebec was the first to ban lawn and garden pesticides. Now, Dow AgroSciences LLC (“ *Dow* ”) intends to challenge the Quebec ban under Chapter 11 of the North American Free Trade Agreement (NAFTA). The David Suzuki Foundation and Équiterre are working with legal counsel at Ecojustice to vigorously defend Quebec’s ban on lawn chemicals.

The fine print, though, is that lawn care companies will still be allowed to use pesticides, “*spot application*” products will still be for sale, and golf courses, public parks, school yards, and hospital grounds are exempt from the ban !

Suzuki — Only herbicides containing the active ingredient 2,4-D will be completely banned on private lawns. Why the narrow focus ? Quebec has outlawed 2,4-D and 11 other lawn chemicals. The Ontario ban extends to 81 active ingredients. [SO WHAT ?!?!?!]

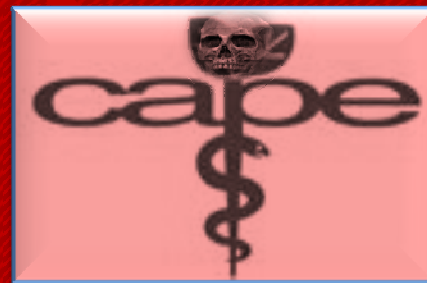
