The SAFETY ASSESSMENTS by Health Canada takes into consideration children's physiology, behaviours, and habits while playing on treated grass.





Dr James S Bus — The Wisdom Of A REAL Expert (continued)

According to Dr Bus —

There is NO regulatory agency in the world ... that regards 2,4-D as a human carcinogen or as a threat to children's health.

Dr James Bus said Health Canada, through the Pest Management Regulatory Agency (PMRA), establishes exposure limits based on «*extremely conservative* » evaluation of the science.

For example, on the matter of 2,4-D Herbicide, PMRA scientists review data from experiments where mice and rats are fed a diet containing 2,4-D for a two-year period.

The animals are monitored for adverse health outcomes, including cancer.

According to James S Bus —

Those studies (identify) what we call a NO OBSERVED EFFECT LEVEL.

In those studies the overall NO OBSERVED EFFECT LEVEL ... was five milligrams per kilogram of body weight, per day.

That's the dose (of 2,4-D) by which the regulators use to make their judgments.

The PMRA then divides the five mg per kg figure by 100, to build a GENEROUS SAFETY FACTOR into the exposure standard for humans, which is 0.05 mg per kg.

Exposure experiments demonstrate home-owners are RARELY EXPOSED to 0.05 mg of 2,4-D per kg of body weight, when label instructions are followed.

[Dr Bus also reviews the work of Dr Solomon.]

Dr Keith R Solomon, a University of Guelph toxicologist, published a study in 1992 on human exposure to 2,4-D.

Solomon and Shelley Harris recruited 10 volunteers to sit, stand and roll on a plot of grass 24 hours after a 2,4-D application.

Five volunteers wore long sleeves and pants and five volunteers wore shorts and bare feet.

According to Dr Solomon —

NO DETECTABLE RESIDUES WERE FOUND in urine samples supplied by volunteers exposed to sprayed turf 24 hours following application.

In the same experiment Solomon had volunteers go on the grass one hour after 2,4-D was applied.

Solomon detected 2,4-D in the urine of volunteers who were barefoot and wore shorts, but THE LEVELS WERE WELL BELOW THE NO EFFECT LEVEL FROM RAT EXPERIMENTS.

According to Dr James S Bus —

The dose those individuals received [in Solomon's experiment] was still 1,000 TIMES LOWER than the five mg per kg of body weight.

Dr Bus has served as President of the Society of Toxicology, the American Board of Toxicology, and the Academy of Toxicological Sciences, and as a Director of the International Union of Toxicology.

Dr Bus has received multiple awards during his scientific career with Dow Chemical, Michigan State University, and the Upjohn Company.

He is an Adjunct Professor in the Department of Pharmacology and Toxicology at Michigan State University.


