- << Most substances have the potential to cause an adverse effect at high enough doses, but there is usually a lower dose where NO harmful effects will occur. >>
- << The acceptable level of exposure is at least ONE-HUNDRED TIMES LOWER than the NON-TOXIC dose. >>
- << On the non-dietary exposure side of the equation, specific studies that look how the pesticide residue can be transferred to people, INCLUDING CHILDREN when they do certain activities. That being farmers in their fields, home-owners using a product, or actually CHILDREN PLAYING ON TREATED GRASS. >>
- << Health Canada determines the amount Canadians may be exposed to through diet and other activities. These potential exposure levels are determined for various SENSITIVE populations and AGE GROUPS, including INFANTS, TODDLERS, CHILDREN, adolescents, and adults. A potential exposure is OVER-ESTIMATED for their protection. >>
- << Science is certainly the basis of all Health Canada regulatory decisions for pesticides, and the approach is PRECAUTIONARY. >>
- << Health Canada approves only those pesticides that show NO INCREASE TO HEALTH RISK, including CANCER. >>


