## Henderson wants cosmetic pesticides banned on city land

Coun. Ben Henderson is plowing ahead in his fight against cosmetic pesticides by asking his colleagues to ban their use on city property.

"We should only be using pesticides for weeds that are on the noxious weed list," Henderson said Wednesday after announcing he'll propose the ban at the next council meeting.

"If it's not on that list, there's a public health issue around pesticides. They do cause harm."

Almost a dozen speakers urged the community services committee to outlaw cosmetic pesticides last March, arguing they're linked to cancer and other illnesses.

They asked councillors to copy limitations imposed by more than 170 municipalities in other provinces, but the committee voted against looking into it further.

Henderson, who said chemicals might also be needed to stop such plant scourges as Dutch elm disease, wants the full council to take part in the debate.

"My motion is not designed to take the option away where we're truly dealing with noxious weeds or pests that are more than cosmetic," he said.

"If we're just talking about some weeds on a playing field, they aren't doing anybody any harm."

The city has been asked to ban cosmetic pesticides several times in the past 20 years.

It said no most recently in 2012 over concerns about controlling invasive species, cost and lack of proof about the benefits.

Edmonton's integrated pest management program deals with weeds, insects and other problem species using non-toxic methods such as better turf care and biological control of harmful bugs before applying chemicals.

The city put out the equivalent of 2,461 kilograms of pesticide active ingredients in 2013, down 45 per cent from 2001.

Coun. Tony Caterina doesn't see much point in examining the issue again when the motion is raised, likely Jan. 27.

"I still don't favour it and I don't think there's going to be any new information brought forward," he said.

"We know the city's trying their best to do all kinds of things, and every time we adjust something the dandelions grow out of control and people complain."
