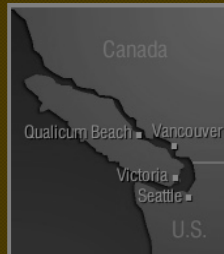

means of controlling pest invasion is in VIOLATION OF FEDERAL LAW.

Barry Avis is in VIOLATION OF FEDERAL LAW.

Barry Avis must publicly withdraw the ILLEGAL recommendation.

However, the anti-pesticide crusade didn't sit well with Councillor JACK WIL-
SON.

According to JACK WILSON —

The removal of DDT from the world market is a good example where politics outweighed scientific fact because of the DEPRAVED INDIFFERENCE of Enviro-Maniac-Activists. The measures that were urged for its removal had little basis in fact or science.

DDT had to be eliminated in order to « *save the environment* » — a move that appeared to be self-serving and under-handed by DEPRAVED Enviro-Maniac-Activists.

The fact that MILLIONS OF PEOPLE were HARMED and KILLED with the removal of DDT is ignored. Sadly, « *save the environment* » appeared to be a cause that IGNORED any human suffering. Consequently, Enviro-Maniac-Activists are often described as exhibiting DEPRAVED INDIFFERENCE.

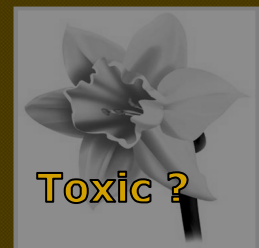
