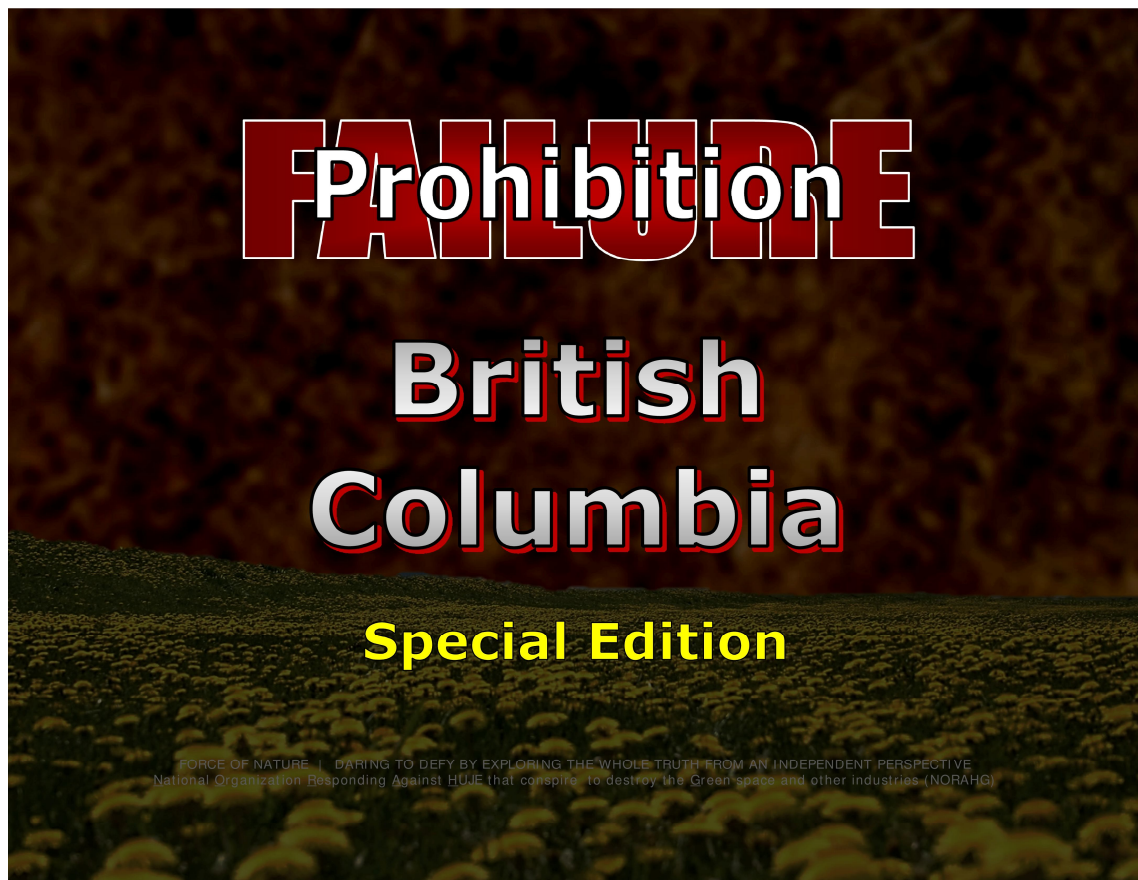

## **Pretext For Lawn Bowling Exception Status**

### **No One Wants To Play On #@!!% Pest-Infested Lawn Bowling Greens**

The EXCEPTION STATUS was deemed necessary after a disease began to develop on the bowling greens.

In essence, officials at Qualicum Beach have confirmed that their prohibition has created the catastrophic ecological carnage of uncontrolled, invasive, destructive, cosmetically ruinous pests !

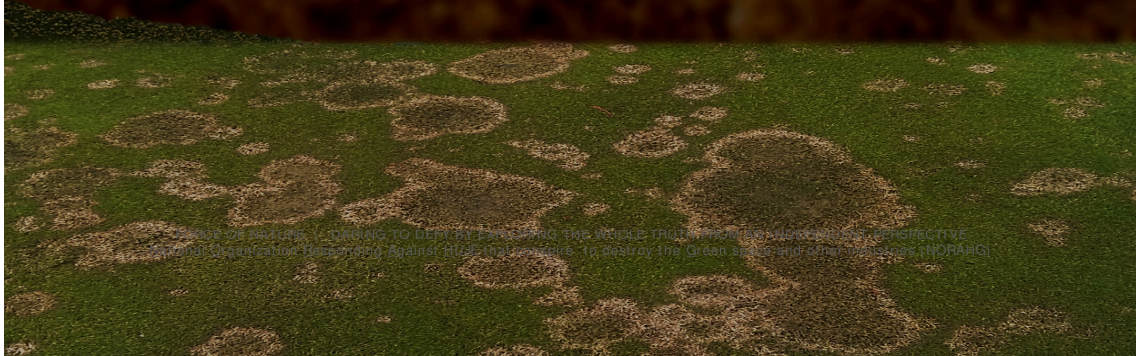

## SUMMARY – IMPOSITION OF PROHIBITION

Anti-pesticide prohibition imposed by the town of Qualicum Beach is a blow against science-based assessments of pesticides, against safe and cosmetically-attractive green spaces, and against local businesses that rely on the use of conventional pest control products.

Consequently, Qualicum Beach's municipal prohibition against conventional pest control products has become a DISMAL FAILURE.

## **SUMMARY – BASIS FOR PROHIBITION**

### **Qualicum Beach's Prohibition Is A Dismal Failure Because It Is Based Upon A False-Pretext As Well As False-Principles**

The basis for Qualicum Beach's prohibition has been confusing and inconsistent, and conflicts with national regulatory agencies around the world that approve products created by the pesticide manufacturing industry.

Prohibition was validated by town councillors under the FALSE-PRETEXT that ...

*... the residents of the Town of Qualicum Beach are concerned about the [ ARBITRARILY ] NON-ESSENTIAL use of pesticides, and the [ SUPPOSED ] RISK that pesticides MAY pose to the NATURAL ENVIRONMENT. [?!?!]*

Qualicum Beach's prohibition was also based upon several FALSE PRINCIPLES, such as

*... the application of pesticides contributes to the CUMULATIVE CHEMICAL LOAD ABSORBED BY THE NATURAL ENVIRONMENT. [ FALSE ! ]*

*... pesticides cannot be necessarily confined to a single location but MOVE THROUGH THE ENVIRONMENT in the air, land and water and may have an impact on non-target organisms and plants. [ FALSE ! ]*

*... ALTERNATIVES to the application of pesticides exist. [ FALSE ! ]*

Qualicum Beach's fanatical-prohibition was / is needless, senseless, malicious, and unnecessary.

Its prohibition has been 100 per cent politically-based and 0 per cent science-based.

The basis for prohibition in Qualicum Beach has been confusing & inconsistent, and conflicts with national regulatory agencies around the world, that are relied upon for health and safety assessments.

Town officials have ignored the fact that conventional pest control products are scientifically-safe, and, when used properly, WILL NOT cause harm to children, people, animals, or the environment.

Consequently, Qualicum Beach's municipal prohibition against conventional pest control products has become a DISMAL FAILURE.

## **SUMMARY – RESIDENTIAL PROPERTY OWNERS**

Its prohibition by-law has been extremely biased and highly prejudicial against residential property owners.

The prohibition has forced residential property owners to resort to the back-breaking, agonizing, and humiliating job of manual weed picking, which is prominently prescribed in a town brochure.

Allowing green alternative pesticides is Qualicum Beach's GOVERNMENT-GUIDED FORCED SELECTION PROCESS — it is aimed at serving ARBITRARY POLITICAL PREFERENCES ONLY.

Qualicum Beach has unwisely defied the market-driven and scientifically-assessed conventional products — they are SUPERIOR IN EVERY WAY to green alternative pesticides.

GREEN ALTERNATIVE PESTICIDES ARE BOGUS AND DISMAL FAILURES !

The underlying assumption by Qualicum Beach, which is FOOLISH, is that its prohibition by-law somehow serves society by FORCING residents and businesses to find ALTERNATIVES from an arbitrary list of POLITICALLY-SELECTED green alternative pesticides.

Such FORCED SELECTION also WRONGLY ASSUMES that alternatives are «*green products*» that will be «*safer*» and work as well as conventional products — THEY ARE NOT SAFER, and THEY DO NOT WORK.

Moreover, by definition, ALTERNATIVES ARE INFERIOR, which is why they did not win the market-place originally — which explains why they DO NOT WORK.

The FORCED SELECTION of green alternative pesticides supposedly removes «*bad*» or «*dangerous*» chemicals from the market, and replaces them with «*green products*» that are «*safer*» — THIS IS FALSE.

Overall, green alternative pesticides are BOGUS and LESS TESTED, raising the prospect that they are NOT SAFER than the conventional products arbitrarily banned by Qualicum Beach's government.



Overall, green alternative pesticides are NOT safer, NOT cutting edge, NOT scientific, NOT progressive, NOT good for public health and the environment, and DO NOT WORK.

They consist of OLD CHEMISTRIES THAT ARE LESS TESTED by national regulatory agencies.

Qualicum Beach's government-guided FORCED SELECTION has NOT provided anyone with truly « *green products* ».

Conversely, the pesticide manufacturing industry already offers its own versions of « *green products* » — every single time it creates new products.

The assessment proving that these products are scientifically-safe is a process that can take up to ten years and cost hundreds of millions of dollars.

The cost to pesticide manufacturing industry to get every pest control product from the lab to store shelves is about 250 million dollars.

These products are proven to be useful and safe at affordable prices — they can only be considered as REAL « *green products* », and NOT so-called green alternative pesticides.

The pesticide manufacturing industry's market-driven and scientifically-assessed « *green products* » are INFINITELY SUPERIOR to Qualicum Beach's government-driven green alternative pesticides.

Consequently, Qualicum Beach's municipal prohibition against conventional pest control products has become a DISMAL FAILURE.

## **SUMMARY – HOME-MADE CONCOCTIONS**

**Qualicum Beach's Prohibition Is A Dismal Failure

He should publicly WITHDRAW his illegal recommendations.

Illegal concoctions represent a danger to our children, a danger to adults, and a danger to the environment.

Some observers are incredulous that Qualicum Beach allowed an arbitrary EXCEPTION STATUS for the golf industry.

Qualicum Beach's provision for this GOLF EXCEPTION STATUS represents another example of the FAILURE and the RIDICULOUSNESS of its anti-pesticide prohibition.

Qualicum Beach's GOLF EXCEPTION STATUS is INCONSISTENT and UNFAIR because golf facilities employ the very same ingredients that are used to control pests that damage city-owned green spaces & residential properties.

If it is safe for children and adults to walk and play on pesticide-treated golf facilities, then why is it not safe for them to walk and play on pesticide-treated lawns ?!?!

What is a solution ?!?!

In order to be consistent and fair, Qualicum Beach must provide NO EXCEPTION STATUS for golf facilities unless they adhere to a proposal that there will be a transition to more pest resistant turfgrass varieties.

For example, all golf facilities in Qualicum Beach should be expected to transition their putting greens from annual bluegrass to creeping bentgrass.

Improved varieties of creeping bentgrass are more resistant to pests than annual bluegrass, an invasive grass species that is highly susceptible to diseases and insects and requires more chemicals for playability as well as for cosmetic enhancement.

Nonetheless, Qualicum Beach's municipal prohibition against conventional pest control products has become a DISMAL FAILURE.
