- 7. Sustainable forest and farming practices

Committee members discussed making the following amendments to the above seven consolidated items as follows:

- Insert "and management" after "Preservation" in Item 1
- Insert "(regulations in place)" after "sources" in Item 2
- Insert "management and enhancement" after "Preservation" and insert "and watersheds" after "streams" in Item 3
- Strike "which includes sustainable growth" in Item 6
- Merge Items 1 and 3 to single item to read "Preservation of major ecosystems in our community"

Chair Kent Becker requested that a new list be created based on earlier discussion and circulated to Committee members prior to the next meeting. Committee members were asked to prioritize the list by assigning a priority number to each item.
