It seems the plight of the bees is being left behind in what is shaping up as more of a political fight.

Those that support keeping the neonicotinoid (neonic) insecticides have the, " We can't do without it and the world will starve" statements, and name those who want to ban it as, " not real farmers or good managers (bee keepers organic) even if they do call themselves farmers," syndrome.

There is a call to have science provide the solution, and both sides are LINING UP WITH THEIR TOKEN SCIENTISTS, calling the pesticides from safe to poison.

What is known is that bees are dying by the millions, which many are blaming on neonics, as witnessed by ANTI-PESTICIDE LUNATIC-BEEKEEPER Dave Schuit, who this year lost more than half his 2,000 hives. [Why is Schuit one of just few few bee-keepers who are losing bees?!?! And why are we just taking his word for it ?!?!]

Canada's losses last winter reached nearly 29 per cent of the colonies across the country, a death of more than 200,000 colonies. [ See below for more exact details. ]

That's double the percentage of losses in the previous year.

Manitoba saw the largest losses, with 46.4 per cent of colonies dying, while Ontario had the second highest rate of loss at 37.9 per cent. [?!?!]

The Ontario Federation of Agriculture (OFA) maintains that their position on this troubling issue is a call for more, "sound science-based solutions by Health Canada's Pest Management Regulatory Agency (PMRA)." [Canadian Honey Council, representing Bee-Keepers all across Canada, ACTIVELY OPPOSES PROHIBITION against Neonicotinoid Insecticides, arguing that the harm to growers would be SUBSTANTIAL, and that there will be NO NOTABLE CHANGE in bee mortality.]

Their membership affiliates, the Grain Farmers of Ontario, recently LAUNCHED A CAMPAIGN BY MAILING OUT 28,000 POSTCARDS TO GRAIN FARMERS ACROSS ONTARIO, asking that they lobby their MPs and MPPs not to ban the use of neonic pesticides.

Local ANTI-PESTICIDE LUNATIC-ORGANIC GRAIN GROWER and member Sean McGivearn, challenged his own association, by asking which directors initiated this political action on behalf of all grain growers, how much it cost to send out 28,000 post cards, and the minutes of the meeting.

The response from the GFO to the first question: which of 15 directors agreed to the motion, " *This information will not be released,*" to the second on cost, "The costs/budget of the post cards will not be released," and as to the minutes, " *The circulation of the GFO board minutes will remain as they have in the past.*"

John Cowan, vice president of the GFO did say that, "Neonicotinoid seed treatments are an IMPORTANT TOOL for Ontario's corn, soybean and wheat farmers and without it farmers have a potential yield loss of three to 20 bushels per acre, which would significantly cut their incomes."

Yet results from Purdue University field trials in Indiana, USA, from 2011 and 2012 could not prove any measurable statistical yield gain from using neonic seed treatments. [This is a nonsense report. Besides, if PROHIBITION is IMPOSED, there is a HIGH PROBABILITY many corn growers would switch to other insecticides that are MUCH MORE HARMFUL TO BEES AND ENVIRONMENT.]

Recently, the federal government, trying to take the sting out of a general population's concern over the use of these pesticides and bees dying as a result, came out with a report titled, Action to Protect Bees From Exposure to Neonicotinoids Pesticides.

This report came out after they approved the use of neonics for next season.

" Health Canada's Pest Management Regulatory Agency (PMRA) has determined that current agricultural practices related to the use of neonicotinoid treated corn and soybean seed are affecting the environment due to their impacts on bees and other pollinators."

Among the planned measures are forcing corn and soybean farmers to follow certain seedplanting practices, improving labels on pesticide and seed packages and requiring seeds to have " dust-reducing" lubricants.

- " Basically I see it as a band-aid, " said ANTI-PESTICIDE LUNATIC-BEEKEEPER Schuit, operator of Saugeen Country Honey located in Elmwood.
- " (The Pest Management Regulatory Agency) should've done their study before they approved this pesticide," he added.

Yet there are some leaders in the farm community who are acknowledging the problem of bee deaths, even though their provincial counterparts are saying something differently. " Farm seed coated with the pesticide neonicotinoids is seen as the major culprit in the deaths of bee colonies, " said Grey County Federation director Jacquie Hendry. [ According to Agriculture Canada, there is NO bee crisis since CANADA'S HONEY YIELD IS TWICE THE WORLD'S AVERAGE. According to a U.S. FEDERAL STUDY, there is NOT ENOUGH EVIDENCE TO SUPPORT A PROHIBITION against Neonicotinoid Insecticides, and that THE COSTS OF PROHIBITION MIGHT EXCEED THE BENEFITS. ]

The European Union partially banned the use of neonics for the next two years. [It is perhaps worth pointing out that France PROHIBITED against Neonicotinoid Insecticides in the 1990s, and it has seen NO MARKED REDUCTION in Bee Colony Collapse Disorder.]

The Ontario Beekeepers Association wants the same.

Ontario Premier and Agricultural Minister Kathleen Wynne appointed a, bee health working group, made up of bee keepers, grain growers, academics and others, to report back with findings next spring.

But the last word may actually be up to farmers and anyone who is concerned.

Furthermore, exposure of men to greater amounts of AMITRAZ can lead to death due

to respiratory failure, mainly after oral uptake or inhalation. In Turkey during 1989, 41 cases of deadly AMITRAZ intoxications were detected. Other frequently occurring symptoms after massive AMITRAZ intoxication are bradycardia, depression, hyperglycemia, hypothermia, loss of consciousness, miosis, respiratory depression, and vomiting. In other words, bee-keepers are illegally using products that are known to cause cancer, and are known to kill people. It has been concluded that bee-keepers are producing potentially dangerous honey. And yet, these same bee-keepers complain about neonicotinoid insecticides, which, in fact, do not cause cancer, are scientifically-safe, and cause no harm. If bee-keepers are lying and cheating by using illegal products, then, are they also lying and cheating with their public statements about bee deaths and neonicotinoid insecticides?!?! Sadly, bee-keepers are the least credible and the least qualified to provide any advice concerning neonicotinoid insecticides.
