In early March 2017, the House of Commons Standing Committee on Agriculture and Agri-Food held two days of hearings on the proposal to prohibit against imidacloprid, inviting testimony from representatives of the agriculture industry, including ...

- Syngenta Canada & Bayer CropScience Inc

The manufacturers of neonicotinoid insecticides

- CropLife Canada

The agriculture industry lobby group

- Canadian Honey Council

Grain Farmers of Ontario

Ontario Fruit and Vegetable Growers' Association

Farming lobby groups

Representatives of government agencies were also invited, including ...

- Agriculture Canada
- Health Canada's Pest Management Regulatory Agency (PMRA)

Environment and Climate Change Canada was NOT invited.

For some inexplicable reason, David Suzuki Foundation, and its Quebec ambassador Equiterre, were also invited to give testimony, despite the fact that NEITHER organization has ANY expertise on neonicotinoid insecticides, and BOTH organizations have been investigated for illegal interference in partisan politics and public policy, in violation of taxation laws.

No other anti-neonicotinoid & environmental-terrorist organizations were invited to provide testimony, although several have interfered by issuing public statements regarding their mock-concerns about the hearings' so-called one-sided approach [?!?!]. (See later segments.)

Proposed Prohibition Against Imidacloprid

Imidacloprid is one of three widely-used neonicotinoid insecticides that are registered for use in Canada.

Health Canada's Pest Management Regulatory Agency [**PMRA**] said in 2016 that the insecticide should be phased-out [**i.e. prohibited**] over three to five years because it supposedly harms aquatic insects, which **HIGHLY-QUESTIONABLE THEORETICAL LABORATORY RESEARCH** suggests could affect food chains and destabilize whole ecosystems.

Mr Pat Finnigan, Member in Parliament [**MP**] and Chairman of the House of Commons Standing Committee on Agriculture and Agri-Food, noted that the prohibition against imidacloprid was **BASED ON MERE QUESTIONABLE THEORETICAL LABORATORY DATA**, and **NOT** real-world levels of insecticides in the environment.

However, Mr Scott Kirby, Director General for the PMRA's Environmental Assessment Directorate, told the House of Commons Standing Committee on Agriculture and Agri-Food that the onus is on the « *insecticide industry* » to prove that neonicotinoid insecticides are safe, and so far, this has NOT been done.

According to Mr Kirby, « *I absolutely feel and believe that there is evidence out there that there are risks of concern. Nonetheless, the proposed prohibition against imidacloprid has been UNMASKED and INVALIDATED !* »

... Would Never Have Been Proposed If Health Canada Had Not Arbitrarily Disregarded Twenty Crucial Studies

Mr Paul Thiel, Vice-President of Bayer, the developer of imidacloprid, has said the Health Canada had ARBITRARILY DISREGARDED more than 20 CRUCIAL STUDIES that it was provided concerning imidacloprid.

Instead, Health Canada decided to validate its proposed prohibition against imidacloprid on the basis of QUESTIONABLE THEORETICAL LABORATORY DATA, and NOT real-world levels of insecticides in the environment.

... Was Based Upon Politicized Science At Health Canada

Representatives of the agriculture industry told the House of Commons Standing Committee on Agriculture and Agri-Food that they will be forced to apply MORE pest control products and at HIGHER COSTS.

According to Mr Mark Brock, Chair for the Grain Farmers of Ontario, « *the Conference Board of Canada determined that the IMPACT of NOT having access to neonic seed treatments would cost \$600 MILLION annually to corn and soybean farmers in Ontario alone* ».

Mr Rod Scarlett, Executive Director of Canadian Honey Council, has stated that bee-keepers are concerned about the LACK OF ALTERNATIVES to neonicotinoid insecticides.

According to Mr Pat Finnigan, Member in Parliament [MP] and Chairman of the House of Commons Standing Committee on Agriculture and Agri-Food, « *... the loss of the insecticide imidacloprid remains a great concern for the agriculture sector. Farmers and insecticide registrants are afraid that*

discontinuing imidacloprid would FORCE FARMERS TO USE GREATER QUANTITIES OF INEFFECTIVE INSECTICIDES. »

Chairman-MP Pat Finnigan

**The Chairman Of The House Of
Commons Standing Committee
Agrees That The Proposed
Prohibition Against Imidacloprid
Is Essentially Invalidated**

Mr Pat Finnigan is a Member in Parliament [MP] and Chairman of the House of Commons Standing Committee on Agriculture and Agri-Food.

Scientists at the PMRA are tasked with making the final decision on imidacloprid, but Chairman-MP Pat Finnigan, saying he was speaking on behalf of the committee, weighed in on the proposal to prohibit against imidacloprid during a 90-day public consultation period, which ended on March 23rd, 2017.

MP Finnigan noted that « *insecticide manufacturers* » complained that the re-evaluation of imidacloprid and the proposal to prohibit against this ingredient was BASED ON MERE [**QUESTIONABLE THEORETICAL**] LABORATORY DATA, and NOT real-world levels of insecticides in the environment.

In a letter to Health Minister Jane Philpott, sent on March 23rd, 2017, Chairman-MP Pat Finnigan repeated the concerns raised by representatives of the agriculture industry that the PMRA's process was TOO SHORT, NOT transparent and IGNORED data that could support the continued use of imidacloprid.

According to MP Finnigan —

... the loss of the insecticide imidacloprid remains a great concern for the agriculture sector.

Farmers and insecticide registrants are afraid that discontinuing imidacloprid would FORCE FARMERS TO USE GREATER QUANTITIES OF INEFFECTIVE INSECTICIDES.

Concerns have been raised about THE LACK OF TRANSPARENCY of PMRA's re-evaluation process.

MP Finnigan has stated that the committee had asked for the extension after getting « *pushback* » from representatives of the agriculture industry who complained that the PMRA had NOT listened to its concerns.

Additionally, David Suzuki and his fanatical-operatives have raised mock-concerns about MPs' one-sided hearings [**?!?!**] of the House of Commons Standing Committee on Agriculture and Agri-Food. (See later segments.)

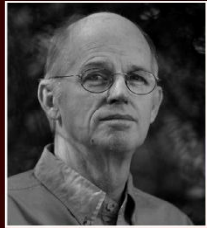

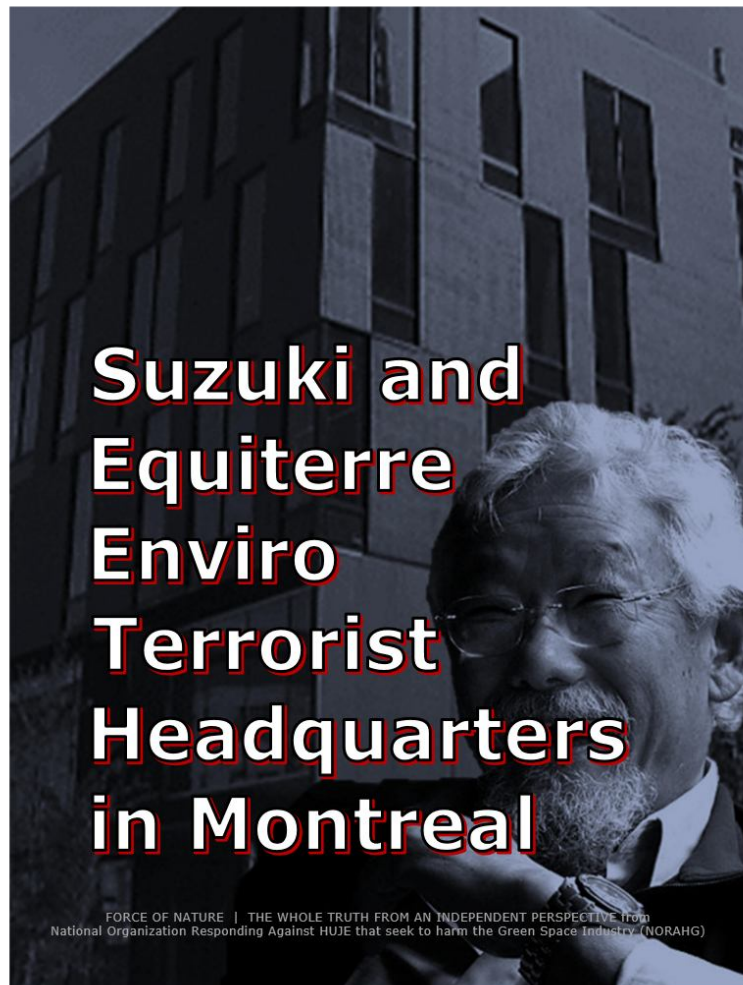
