There are 7,000 Bee-Keepers keeping 600,000 colonies of honeybees across Canada.

Essentially, a mere 1.0 per cent of all Bee-Keepers are reporting losses.

These represent the Anti-Pesticide Lunatic-Bee-Keepers of Canada.

Over 99 per cent of all Bee-Keepers are reporting NO losses.

According to the U.S. Agriculture Department and the U.S. Environmental Protection Agency, THE SINGLE MOST DETRIMENTAL PESTS OF HONEYBEES ARE VARROA MITES.

According to Ernesto Guzman, a Bee Researcher at the University of Guelph, VARROA MITES continue to be THE PRIME SUSPECT IN BEE DEATHS.

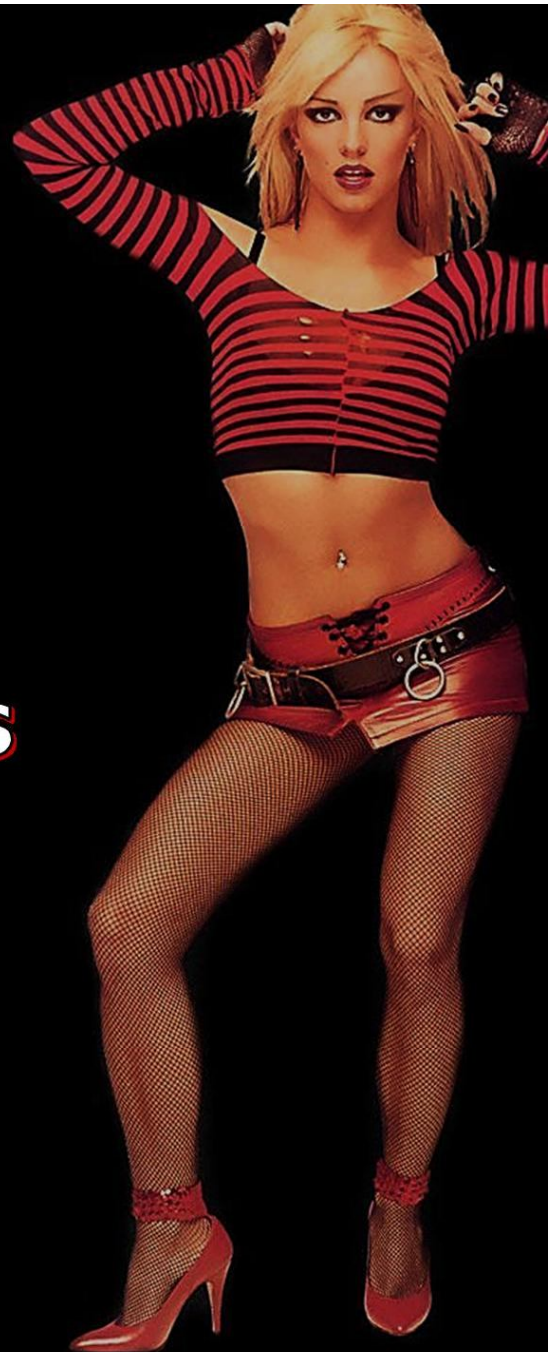
