I believe that the taxes we pay in the City of Vernon have been unnecessarily high for the last 6 years both at the City level and the RDNO level. We must return to a zero based budgeting approach where every line item expenditure is justified. Just because a item or position was there last year does not automatically justify its inclusion in this year's budget.



We have been building up Reserves by stealth in this City and with the present economical situation it may be necessary to use some of these reserves to deliver infrastructure spending that will be necessary. Reexamination of all reserves especially at RDNO must be a top priority.

  - An open and effective Grants Policy


