Whether it's the voice in a political TV advertisement or that of an outspoken neighbour, Canadians are used to being urged to support a particular candidate in an election.

What they are not accustomed to is foreign entities with deep pockets sending money to Canada in the hopes of swaying the results on election night.

That's the allegation contained in a worrying complaint filed with Elections Canada.

A group called Canada Decides alleges that money funneled from the United States to Canadian political advocacy groups shaped the outcome of the 2015 federal election, which enabled the Justin Trudeau Liberals to form government.

« *The outcome of the 2015 election was skewed by money from wealthy foreigners,* » alleges the complaint, claiming third party groups hostile to the Stephen Harper Conservatives worked to unseat government members they considered to be vulnerable.

Among Canada Decides' directors is Joan Crockatt, the former Conservative MP for Calgary Centre, who lost her seat to Liberal Kent Hehr by 750 votes.

Elections Canada must treat the complaint with the seriousness it warrants.

For years, commentators and researchers, such as Ms Vivian Krause, have accused wealthy American foreign entities of financing anti-conservative campaigns, particularly those promoting environmental issues such as so-called global warming.

Ms Krause and others, have argued such efforts are intended to keep Canada's energy resources land-locked and dependent on the United States as its only customer, which is clearly against Canada's economic interests.

These earlier suspicions are unsettling in themselves, but accusations that the 2015 election outcome was materially impacted by foreign meddling demand attention — as Canada's former chief electoral officer acknowledges.

According to Mr Jean-Pierre Kingsley, Canada's former chief electoral officer —

A general election is a national event, it's not an international event, and foreign interests have no place, and for them to have found a back door like this, that is not acceptable to Canadians.

I think the overwhelming majority of Canadians care about foreign money playing a role in our elections, regardless of what party they favour.

This issue is about the overall fairness of our elections, about keeping a level playing field.

Mr Kingsley is right.

Canadians understand they are part of a global community and unavoidably subjected to potent outside influences — perhaps necessarily so, on occasion — but moneyed political activists [and foreign entities] cannot be allowed to taint our elections, as has been alleged.

Along with determining the veracity of the allegations, it is clear that steps must be taken to ensure the integrity of Canada's electoral system, which contains loopholes that often permit foreign donations to third party groups.

We cannot enable outsiders to influence the future of our great nation.

Clearly, Suzuki serves as a shield for TIDES USA, with access to millions and millions of dollars that may be used to interfere in the 2019 Canadian Federal Election.

A British Columbia coalition of health and environmental groups that includes David Suzuki Foundation has recommended provincial legislation that —

- 1. BANS the use and sale of pesticides used to improve the appearance of lawns and gardens, including a requirement for GOLF COURSES TO PHASE-OUT PESTICIDES.*
- 2. Allows exemptions only when necessary to protect public health and safety.*
- 3. Allows municipalities to enact and enforce by-laws that are more restrictive of pesticide use than the provincial law.*
- 4. Includes a « white list » of low-risk pesticides that are permitted on lawns and gardens to promote public awareness.*

[So-called Low-Risk Green Alternative Pesticides DO NOT WORK and ARE NOT LOW RISK !]

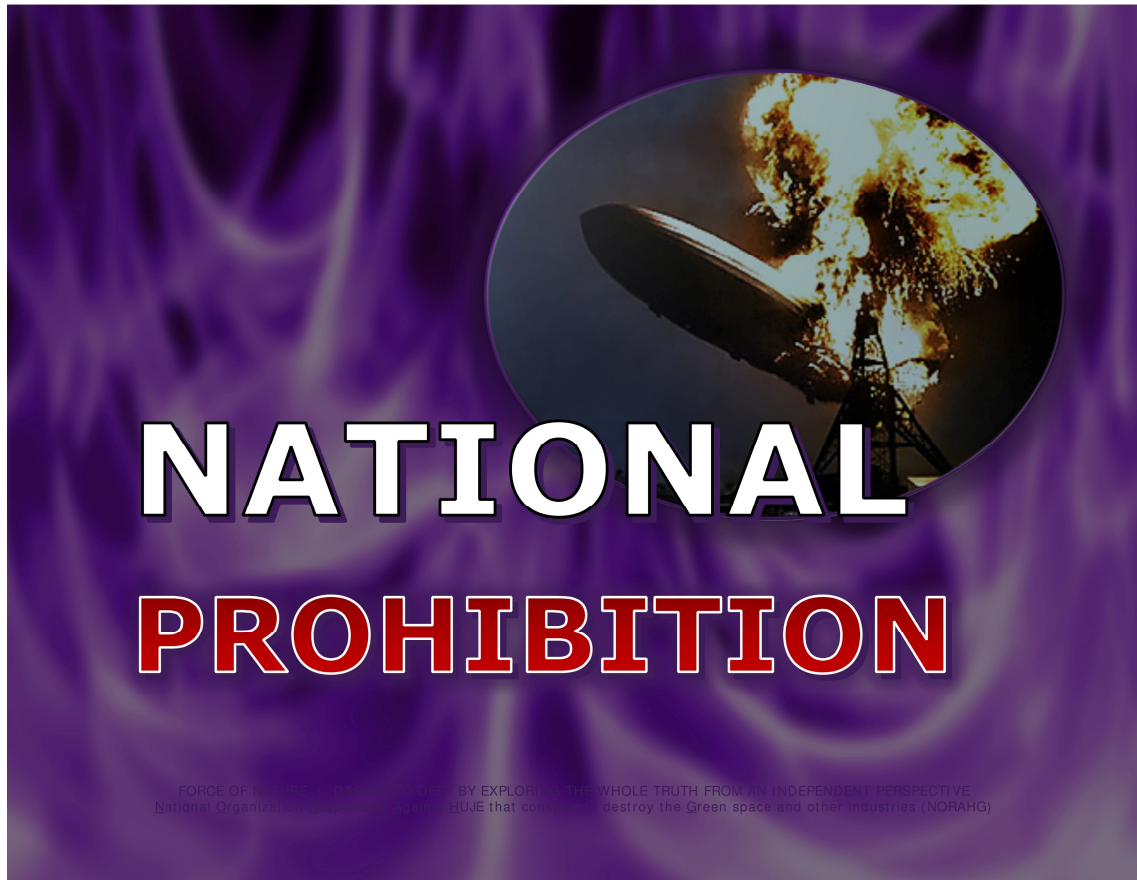
