Overview

Kamloops is a city in south-central British Columbia with a population of over 85,000.

As of January 1st, 2016, the city of Kamloops, British Columbia, has arbitrarily imposed prohibition (i.e. pesticide ban) against conventional pest control products used by businesses operating in the professional lawn care industry.

A majority of Kamloops' elected officials supported this prohibition because of Councillor Donovan Cavers' berserk outbursts and relentless coercion, intimidation, and terrorism.

The public must NOT forget that Cavers is a high-ranking official with Green Party of Canada, with strong ties to Canadian Cancer Society.

Both organizations have conspired, nationally, to impose reckless and arbitrary prohibition despite the fact that pest control products are scientifically-safe and will cause NO harm.

The pivotal vote that allowed this prohibition to be enacted was made by Councillor Arjun Singh.

Kamloops' prohibition also extends to all municipal land, such as parks and sports fields.

There could be EXORBITANT AND COSTLY IMPLICATIONS for the City of Kamloops if council votes in favor of a SELF-IMPOSED MUNICIPAL PROHIBITION against conventional pest control products on all municipal land.

A report from the city's Parks, Recreation and Cultural Services department says it would cost approximately 30,000 DOLLARS for ADDITIONAL STAFF TIME and GREEN ALTERNATIVE PESTICIDES.

In addition, the report says 25,000 DOLLARS would be needed for EDUCATIONAL PURPOSES (i.e. PROPAGANDA) for the public including interpretive signage and workshops.

A recommendation by staff is that council approve the two expenditures for the 2016 base budget.

Observers expect that these EXORBITANT AND COSTLY EXPENDITURES will be REPEATED on an annual basis, in perpetuity.

And these costs will ONLY CONTINUE TO INCREASE.

Pesticide-Hating Lunatic-Councillor Arjun Singh, who was among those who voted in favor of PROHIBITION on all residential properties in July 2015, says THE COSTS ARE NO SURPRISE.

So, it comes as NO SURPRISE to Singh that Kamloops WILL SPEND HUNDREDS OF THOUSANDS OF DOLLARS EVERY DECADE, in order to satisfy his PERSONAL LIFE-STYLE CHOICE.

The report also states it would cost an additional 40,000.00 DOLLARS for Green Alternative Pesticides, as well as increased staff time, materials and equipment.

The city could also be faced with other costs including 100,000.00 DOLLARS to replace the turf of a sports field in the event of DESTRUCTIVE PEST INFESTATIONS, which are likely to occur on a VERY REGULAR BASIS.

Kamloops Council Weighs Options On Self-Imposed Municipal Anti-Pesticide Prohibition

The use of conventional pest control products is back on City council's lap with a recommendation on extending a residential PROHIBITION to SELF-IMPOSED MUNICIPAL PARKS PROHIBITION.

A two-pronged recommendation would have the City allocate an additional 30,000 DOLLARS in the 2016 budget for ADDITIONAL MAINTENANCE COSTS as well as 25,000 DOLLARS for PUBLIC OUTREACH AND EDUCATION (i.e. PROPAGANDA CAMPAIGN).

An accompanying report, however, raises the prospect of SIGNIFICANTLY GREATER COSTS should council decide to extend a park maintenance PROHIBITION to INCLUDE PLAYING FIELDS.

There are three options outlined —

- ARBITRARY SELF-IMPOSED MUNICIPAL PROHIBITION of all conventional pest control products on ornamental plants, shrubs, and

flowers in city parks (30,000 DOLLARS), as proposed in the July 14, 2015, motion.

- In addition to option 1, include all sports fields and turf areas at an increased cost of 40,000 DOLLARS (70,000 DOLLARS total).
- And/or increase PUBLIC OUTREACH AND EDUCATION PROGRAM RESOURCES to ensure the long-term success of the SELF-IMPOSED MUNICIPAL PROHIBITION (25,000 DOLLARS).

According to Bryon McCorkell, Kamloops' parks and recreation director —

If council considers eliminating step 4 of the integrated pest management plan in all park (turf and sports fields) areas, the cost of switching to alternative pest control products (i.e. green alternative pesticides) and management practices would require a further 40,000 DOLLARS for INCREASED STAFF TIME, MATERIALS, AND EQUIPMENT.

Other costs could include COMPLETE REPLACEMENT OF A SPORTS FIELD TURF in the case of full infestation of a playing surface, which could exceed 100,000 DOLLARS per field (AND LIKELY TO OCCUR EVERY SINGLE YEAR).

Substitution of alternatives for Roundup Herbicide, including vinegar, heat, steam and various other approaches, were cited as THE MAIN REASON FOR INCREASED EXORBITANT COSTS.

Roundup Herbicide represents A COST-EFFECTIVE OPERATIONAL TOOL, McCorkell stated in his report.

Observers note that that these alternatives are often ILLEGAL, WORTHLESS, and SIMPLY WILL NOT WORK, which will inevitably lead to the ANNUAL REPLACEMENT OF SPORTS FIELD TURF.

Obviously, the SELF-IMPOSED MUNICIPAL PROHIBITION would not apply to noxious weeds, which the City is required by law to control, he notes.

After considerable debate and a vocal lobby by commercial applicators, a CONTROVERSIAL RESIDENTIAL PROHIBITION was ARBITRARILY IMPOSED by a vote of 5-4 in July 2015, and took effect January 1st, 2016.

Immediately following the adoption of the PROHIBITION, Pesticide-Hating Lunatic-Councillor Arjun Singh moved that the City should follow suit in its SELF-IMPOSED MUNICIPAL PROHIBITION on park and grounds maintenance.

Singh contended that the City should be leading by example.

The staff report also responds to council's direction on increased public education on alternatives to pest control product use, which would require expansion of a horticultural outreach program currently offered by the ECOSMART TEAM.
