

Background Information

Newfoundland Conspiracy

In 2012, Newfoundland recklessly and arbitrarily prohibited against pest control products used in the urban landscape.

These products were/are desperately need by businesses operating in the professional lawn care industry.

Newfoundland (and Labrador) is a province of Canada on the country's Atlantic coast.

This eastern-most Canadian province is comprised of two main regions — the island of Newfoundland off the country's eastern coast, and Labrador on the mainland to the north-west of the island.

The province is often referred to by the abbreviation « NL ».

The population is greater than 500,000, and the capital city is Saint John's, with almost 110,000.

On July 14th, 2011, Newfoundland's Department of Environment and Conservation announced that the following ingredients would no longer be permitted for application on lawns in the province — carbaryl, 2,4-D (2,4-dichlorophenoxyacetic acid), mecoprop, dicamba, and MCPA (2-methyl-4-chlorophenoxyacetic acid).

Government Thugs Attack A Legitimate & Tax-Paying Business

The Government of Newfoundland's personal horde of pesticide-hating thugs are abusing their government powers and authorities.

They are currently terrorizing Mr Donald Barry's business, Green Lawn.

According to court documents obtained, government thugs have alleged that Green Lawn of violating the Environmental Protection Act because they believe this business has been offering pest control services without a license between October 30th, 2013, and September 7th, 2016.

Government thugs obtained a search warrant in September 2016 as part of their investigation.

NO charges have been laid, and the allegations have NOT been proven in court.

In a statement to CBC News, Lunatic Environment Minister Perry Trimper confirmed that his government thugs are investigating Green Lawn's use of arbitrarily prohibited pest control products.

Pesticide-hating fanatics have also ratted-out Green Lawn to Health Canada, according to court documents.

Three informants to Health Canada between June 2014 and June 2015 alleged the business was using non-registered pest control products during that time frame.

Green Lawn owner Mr Donald Barry HAS NOT returned messages seeking comment.

To get the search warrant, a government thug from the Department of Environment provided a judge with information from former disgruntled employees and non-expert customers who ratted-out this business with allegations.

Apparently, there are also first-hand observations that suggested the business was illegally spraying pest control products.

Court documents show that in July 2014, a government thug observed a Green Lawn employee spraying a lawn on Waterford Bridge Road with a pest control product used to treat chinch bugs — a destructive insect pest that destroys lawns.

The items seized via the search warrant include pest control products that were arbitrarily prohibited by Newfoundland, despite the fact that they are already federally-approved to control destructive pest problems on home lawns.

No one in the professional lawn care industry should feel safe from these Newfoundland's government thugs!

These thugs have converted Newfoundland into a haven for subversive-enviro-terrorism.

Mr Donald Barry and his Green Lawn business will very likely be fined thousands of dollars for using pest controls product that have been arbitrarily prohibited by subversive Newfoundland government thugs.

In fact, the products used by Green Lawn were/are federally-approved and will cause NO harm according to Health Canada.

Mr Donald Barry and his business will likely be convicted for bogus violations under Newfoundland's Environmental Protection Act for using pest control products that are approved by Health Canada.
