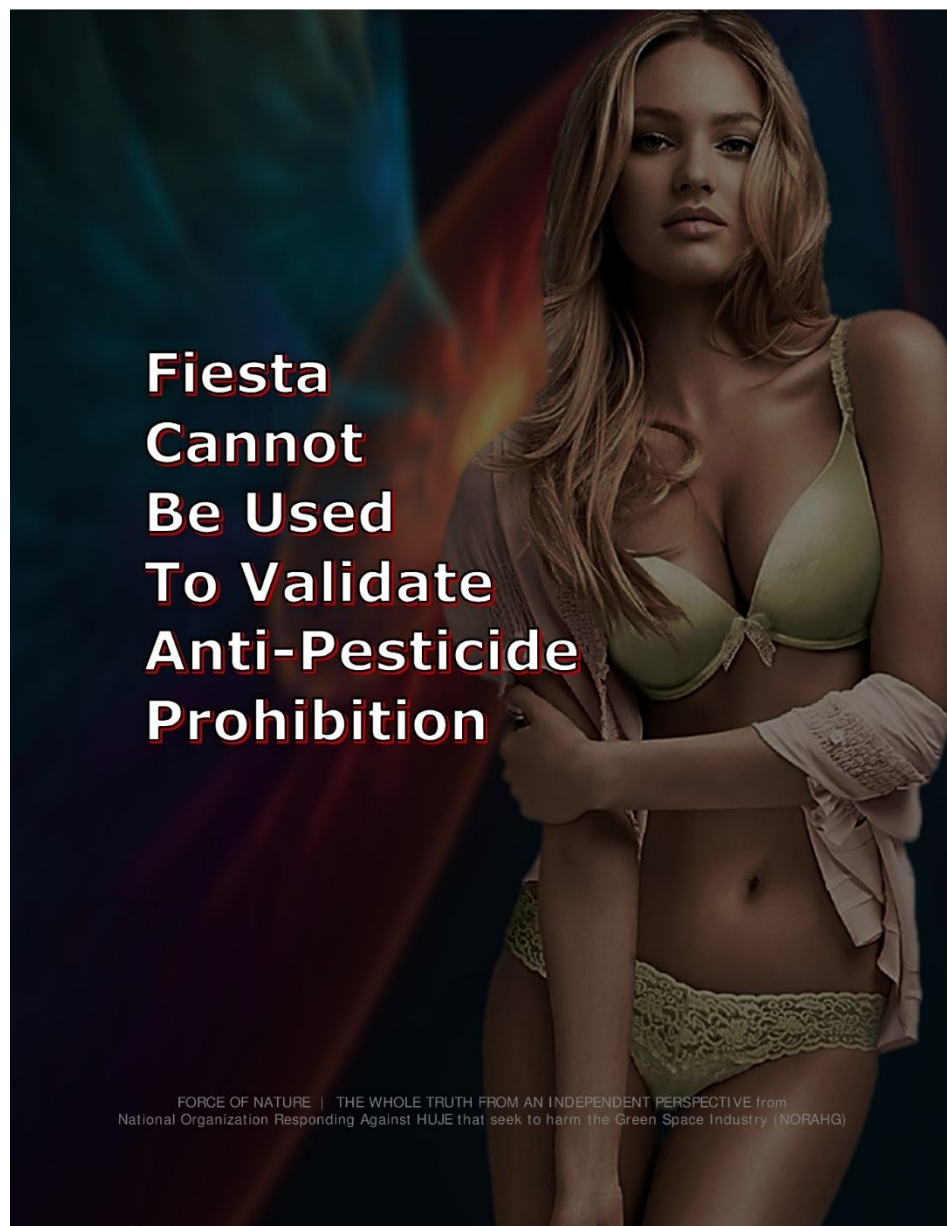

In fact, Fiesta DOES NOT CONTROL BROAD-LEAVED WEEDS, it merely SUPPRESSES THEM.

Even with EXCESSIVE REPEAT APPLICATIONS, the weeds are NEVER ENTIRELY CONTROLLED with Fiesta.

In many cases, TOP-GROWTH IS MERELY SUPPRESSED within a few days after application, but ROOTS REMAIN INTACT, which explains the RAPID RE-GROWTH after a Fiesta application.

Excessively High Rates

In addition to WEEDS NOT CONTROLLED OR DESTROYED, EXCESSIVE REPEAT APPLICATIONS and TOXIC DETERIORATION IN TURF QUALITY AND DENSITY, Fiesta has other MAJOR DISADVANTAGES.

In order to SUPPRESS weeds, Fiesta requires EXCESSIVELY HIGH RATES of active ingredient when compared to CONVENTIONAL pest control products like Killex.

According to label directions, Fiesta MUST NOT BE APPLIED MORE THAN 4 TIMES PER YEAR, and TREATMENTS MUST BE REPEATED EVERY 3 TO 4 WEEKS.

However, adequate broad-leaved weed control with Fiesta Herbicide is too often only achieved with an EXCESSIVE 6 TO 8 REPEAT APPLICATIONS PER SEASON, or more.

Adequate broad-leaved weed control with CONVENTIONAL products like Killex was achieved with 2 to 2½ REPEAT APPLICATIONS PER SEASON.

The EXCESSIVELY HIGH RATES of Fiesta seems to fly in the face of the desired environmentalist objective of reducing the amount of active ingredient being applied in pest control product programs.

The EXCESSIVELY HIGH RATES also lead to a DETERIORATION IN TURF QUALITY AND DENSITY, which will, in turn, predictably lead to FURTHER PROBLEMS WITH WEED INVASION. (See previous segment.)



Stunningly Exorbitant Costs – 1

The commercial maintenance for an average lawn will cost 75 DOLLARS per season when using CONVENTIONAL weed control products.

Stunningly Exorbitant Costs – 2

Fiesta is STUNNINGLY MORE EXPENSIVE than CONVENTIONAL pest control products like Killex, a herbicide that was ARBITRARILY PROHIBITED by the governments like Ontario in 2009.

For example, 1 litre of domestic Killex, which treats 8500 square feet, costs a mere 20.99 DOLLARS per unit.

By contrast, 1 litre of domestic Weed-B-Gon (a.k.a. Fiesta), which treats only 1300 square feet, costs 39.99 DOLLARS per unit.

HOME-OWNERS AND PROFESSIONALS CANNOT AFFORD THIS #@!!% BAN NONSENSE WHICH FORCES THEM TO RELY ON FIESTA.

As another example, Fiesta was first introduced in 2009, the cost of a single application ranged from 13 TO 26 DOLLARS per 1000 square feet, although by 2014, this cost had fallen.

This represented a cost that was UP TO 31 TO 62 TIMES HIGHER THAN Killex.

The material cost of Fiesta may range from 50 to 100 DOLLARS per average 4000-square-foot lawn, depending upon the application rate.

Consequently, Professional Lawn Care businesses have had to DOUBLE or TRIPLE the customer cost of an application of weed control.

Fiesta is INFERIOR !

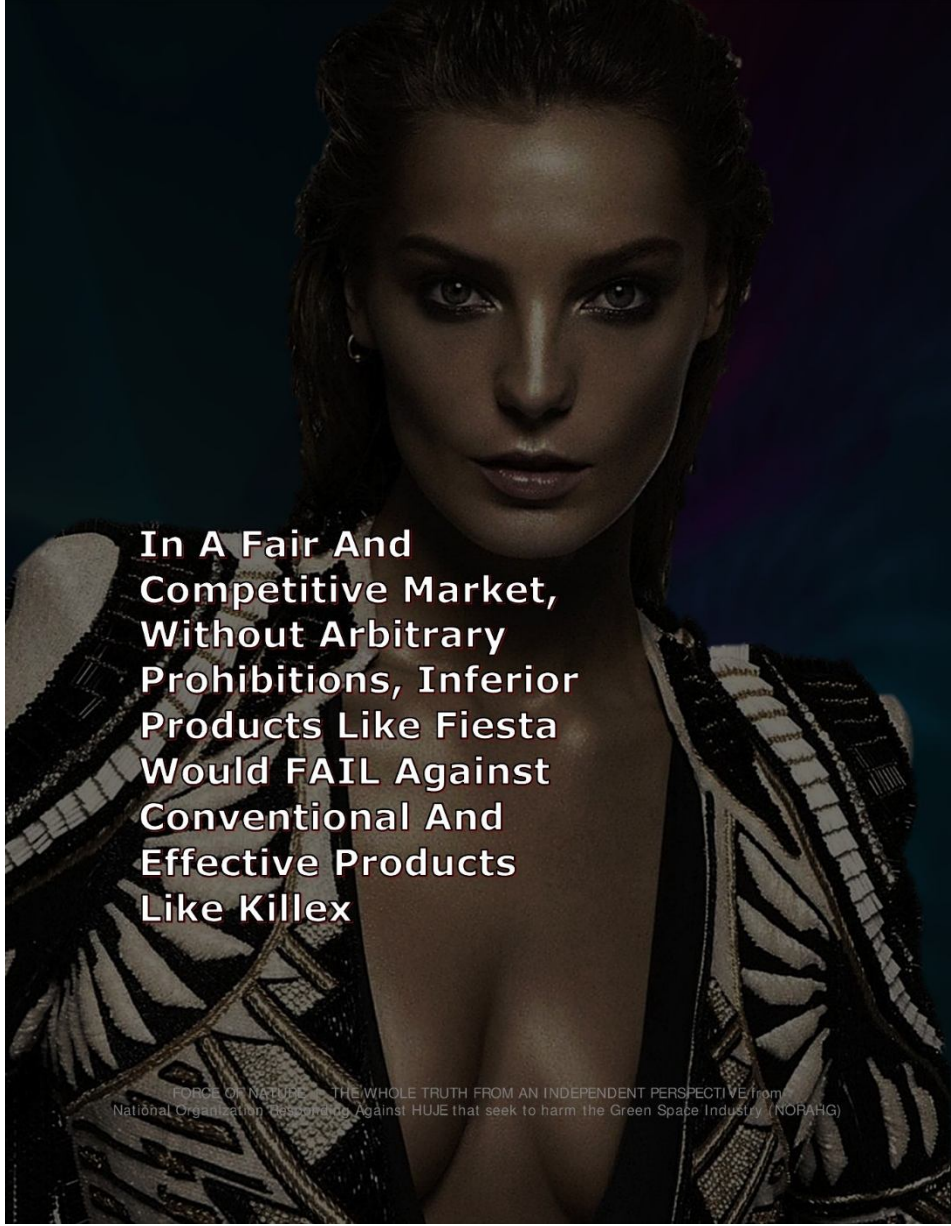

Fiesta is also INFERIOR because it is NOT COMMERCIALY VIABLE, and when compared to Killex, it is NOT EFFICACIOUS, it is NOT ECONOMICAL, and it is NOT A LEGITIMATE LOW-RISK ALTERNATIVE.

Fiesta is INFERIOR and a DISMAL FAILURE, and MUST NOT even be remotely used in order to validate the PROHIBITION of CONVENTIONAL pest control products.

MUNICIPALITIES that have attempted to use INFERIOR Green Alternative Pesticides like Fiesta have seen NOTHING BUT DISMAL FAILURE, and have returned to using CONVENTIONAL pest control products whenever possible.

Fiesta DOES NOT WORK !

It was/is IMPOSSIBLE to control WEEDS without CONVENTIONAL pest control products like Killex.

Since 2009, in the Province of Ontario, home-owners and professionals have been FORCED TO RELY UPON INFERIOR Green Alternative Pesticides like

Fiesta because of the RECKLESS AND ARBITRARY PROVINCIAL PROHIBITION against CONVENTIONAL pest control products.
