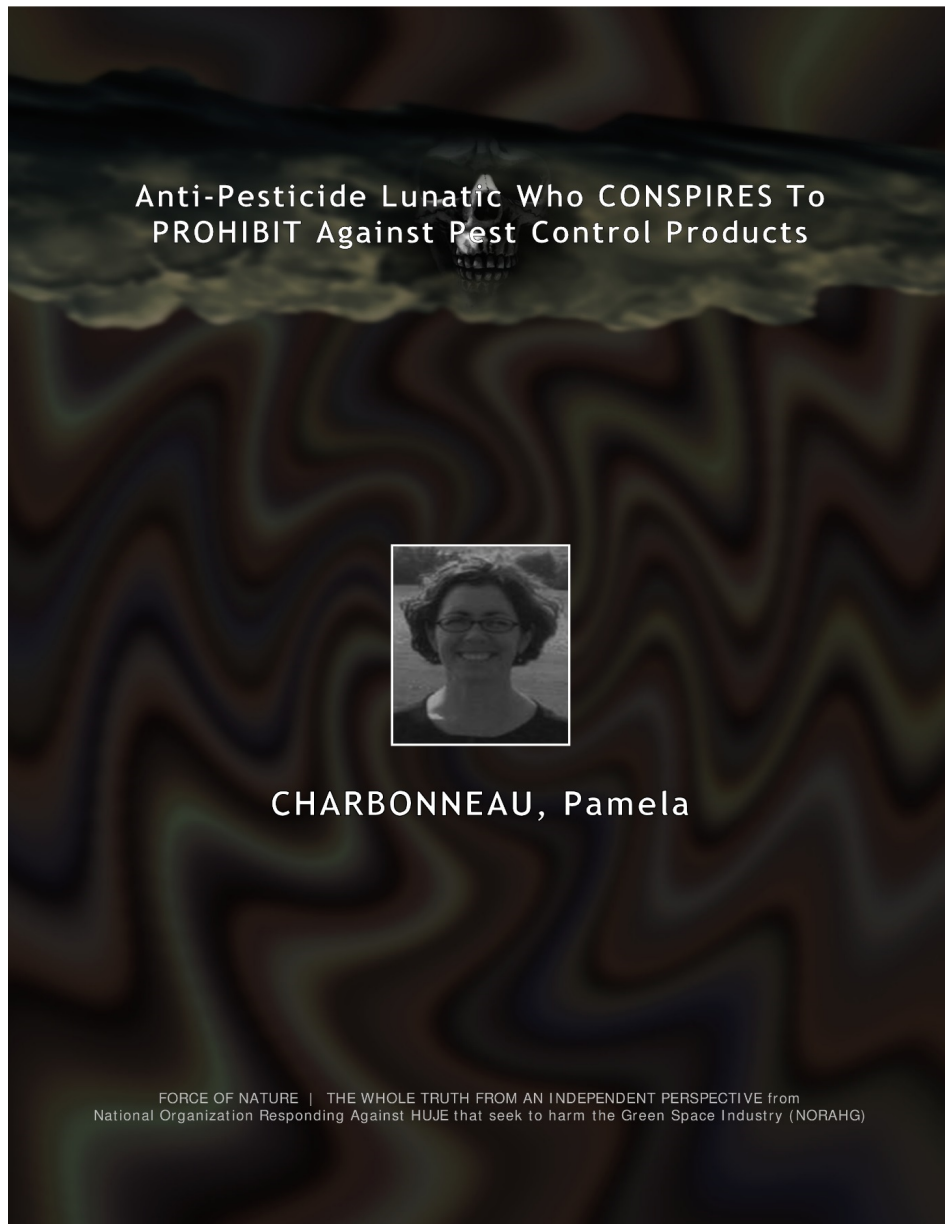

An Exception Status was provided to industries like golf, sports fields, specialty turf, forestry, and agriculture — these industries employed THE VERY SAME pest control products otherwise PROHIBITED for the Modern Professional Lawn Care Industry.

The legislation was implemented despite the fact that the PROHIBITED pest control products were still FEDERALLY-LEGAL, SCIENTIFICALLY-SAFE, PRACTICALLY-NON-TOXIC, and CAUSE NO HARM.

Since PROHIBITION, the University of Guelph has become the INSTRUMENT of Anti-Pesticide PROPAGANGA for the Government of Ontario.

Consequently, University of Guelph is listed among the nation's PROMINENT ANTI-PESTICIDE & ENVIRONMENTAL-TERRORIST ORGANIZATIONS.

University of Guelph is a PROPAGANDA SHIELD in the CONSPIRACY TO PROHIBIT against pest control products used in the Urban Landscape.

ALL Government-Officials employed at the University of Guelph, like Charbonneau, have been told to « *toe the line* ».



Fiesta Is Inferior And Does Not Work

Pam Charbonneau's Fiesta is INFERIOR !

By definition, alternatives are INFERIOR, which is why they did not win the market-place originally.

Overall, Green Alternative Pesticides are INEFFECTIVE, INADEQUATE, INFERIOR, HIGH-RISK, MORE TOXIC, and STUNNINGLY EXPENSIVE !

More specifically, Pam Charbonneau's Fiesta is INFERIOR because of DETERIORATION IN TURF QUALITY AND DENSITY, EXCESSIVE REPEAT APPLICATIONS, EXORBITANT COSTS, WEED-INFESTED AND DANGEROUS GARBAGE DUMP GREEN SPACES, ILLEGAL KNOCK-OFFS, MANUFACTURER BETRAYAL, STAINING NON-TARGET SURFACES, TOXIC DETERIORATION IN TURF QUALITY AND DENSITY, and WEEDS NOT CONTROLLED OR DESTROYED.

None of these DISADVANTAGES existed with CONVENTIONAL products like Killex and before they were ARBITRARILY AND RECKLESSLY PROHIBITED.

Pam Charbonneau's Fiesta is also INFERIOR because it is NOT COMMECIALLY VIABLE, and when compared to Killex, it is NOT EFFICACIOUS, it is NOT ECONOMICAL, and it is NOT A LEGITIMATE LOW-RISK ALTERNATIVE.

Fiesta is INFERIOR and a DISMAL FAILURE, and MUST NOT even be remotely used in order validate the PROHIBITION of CONVENTIONAL pest control products.

MUNICIPALITIES that have attempted to use INFERIOR Green Alternative Pesticides like Fiesta have seen NOTHING BUT DISMAL FAILURE, and have returned to using CONVENTIONAL pest control products whenever possible.

Pam Charbonneau's Fiesta DOES NOT WORK !

It was/is IMPOSSIBLE to control WEEDS without CONVENTIONAL pest control products like Killex.

Since 2009, in the Province of Ontario, home-owners and professionals have been FORCED TO RELY UPON INFERIOR Green Alternative Pesticides like
