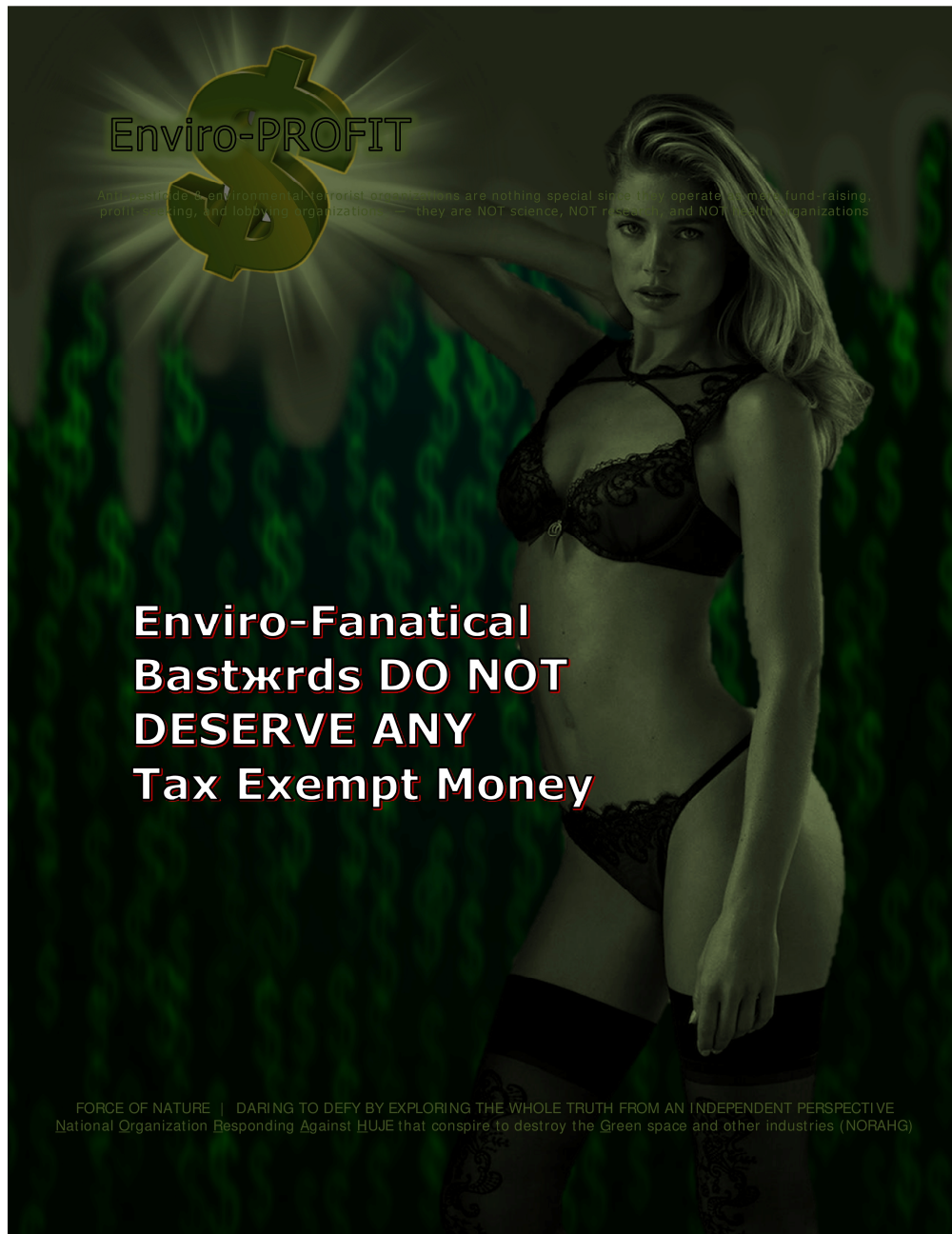

## Early Investigations

## **The #@!!% Environmental-Terrorist Organizations' Spending Activities That Interfere With Partisan Politics & Public Policy**

The roots of these investigations go back to 2010 when news broke that these organizations were receiving millions of dollars in enviro-profit as part of the Tar Sands Campaign, an illegal interference with construction of pipelines for exporting Alberta oil.

On December 7th, 2013, according to Mr Jim Flaherty, Finance Minister of the Conservative Government of Canada —

*We spent some time on it last year and we're looking at it again now as I prepare the [ 2014 ] budget.*

*So if I were an environmental charity using charitable money, tax-receipted money for political purposes I would be cautious.*

On June 7th, 2012, according to Stephen Harper, Prime Minister of Canada —

*If it's the case that we're spending on organizations that are doing things contrary to government policy, I think that is an inappropriate use of tax-payer money and we will look to eliminate it.*

Consequently, the Government of Canada had allocated 13.4 million dollars for the Canada Revenue Agency ( CRA ) to ensure that no more than 10 per cent of monetary resources is being spent investigating illegal interference with partisan politics & public policy by environmental-terrorist organizations.

Illegal interference could even include telling an organization's members to contact elected officials about new government regulations.

They deserve the revocation of their charity tax-exempt statuses.

## **The Big Chill On Poor Li'l Enviro-Terrorist Charities**

### **Current Investigations**

In early 2015, Canada Revenue Agency ( CRA ) announced that 21 audits had been completed.

Five charities were advised that CRA intended to revoke their charity tax-exempt status.

Six charities were sent education letters.

Compliance agreements were done with eight charities.

Furthermore, as of September 2015, a further 28 audits are underway and 11 more have yet to begin.

## Environmental Defence Canada ( EDC )

### EDC INVESTIGATION

Environmental Defence ( EDC ) is in mid-appeal of its audit, and may face the revocation of its charity tax-exempt status. [ Hopefully ]

Environmental Defence says it has spent nearly half a million dollars on legal and other expenses so far.

In 2011, this organization was initially sure it had cleared what seemed like a routine audit.

Its Canada Revenue Agency auditor told them they were basically good to go. [ ?!?! ]

No red flags, no major concerns.

« *Everything looked fine,* » alleges fanatical executive director Tim Gray.

Seven months later, Environmental Defence received a letter stating that its charity tax-exempt status was being revoked.

The reason ?!?!

The organization's work was deemed too political.

### EDC DESCRIPTION

Environmental Defence Canada ( EDC ) is a mad-hatter, non-expert, tax-exempt, for-profit, anti-pesticide & environmental-terrorist organization that

conspires to impose reckless and arbitrary prohibition against pest control products across the nation, with headquarters in Toronto, Ontario.

It also operates as a shield organization for David Suzuki Foundation with Suzuki himself as an EDC honorary board member.

It is a member of the Suzuki-enviro-terrorist-alliances.

The Environmental Defence building is surrounded by a large meadow-like green space that looks like a garbage dump with NO lawn.

Environmental Defence was established in 1984 under the name Canadian Environmental Defence Fund.

Environmental Defence is a vast tax-exempt fund-raising millionaire multi-million dollar profit-making machine operated by a handful of non-expert fanatical mad-hatter activists who are paid-for-profit as subversive lobbyists.

Environmental Defence has an operating budget of over three-million-dollars per year, and employs almost twenty-five mad-hatter staff members, including several lobbyists in Ottawa.

This organization has developed expertise in providing funding assistance, legal, scientific, planning and engineering referrals, and organizational support to citizens and groups.

It tends to pursue nationally-significant cases involving politicized science and junk science.

This fanatical mad-hatter organization depends on junk science to concoct fear-mongering, fraudulent lies, misconceptions, coercion, threats, deceptions, terror, and paranoid conspiracies.

## **EDC CONTROVERSY**

Environmental Defence has despicably exploited babies as weapons of coercion and environmental terror.

In 2009, Environmental Defence published « *Slow Death by Rubber Duck* », with proceeds from book sales going to support campaigns that interfered with partisan politics & public policy.

#### SUZUKI INVESTIGATION

In anticipation of an audit by Canada Revenue Agency, David Suzuki himself was forced to resign from his own foundation for fear that his outspoken political views and interference in partisan politics would compromise the foundation's charity tax exempt status.

Although David Suzuki was forced to quietly step down from the Board of Directors of David Suzuki Foundation during summer of 2011, his resignation was not officially announced until 2012.

On April 13th, 2012, Suzuki officially announced he had stepped down from the board of directors of his organization, alleging that he wanted to shield it from partisan attacks —

*I want to speak freely without fear that my words will be deemed too political, and harm the organization of which I am so proud.*

*I am keenly aware that some governments, industries and special interest groups are working hard to silence us.*

They use threats to the Foundation's charitable status in attempts to mute its powerful voice on issues that matter deeply to you and many other Canadians.

Suzuki's decision followed the Government of Canada's decision to investigate environmental terrorist organizations and their illegal interference in partisan politics & public policy.

Canada Revenue Agency was allocated 13.4 million dollars to ensure that no more than 10 per cent of monetary resources was being spent by organizations like Suzuki while interfering on these issues.

The Government of Canada DOES NOT want its society to continue living in the 9|11 era of illegal, partisan, profit-hungry, tax-evading, anti-pesticide, enviro-fanatical-terrorism !

## **SUZUKI DESCRIPTION**

David Suzuki Foundation is an anti-pesticide & environmental-terrorist organization that conspires to impose reckless and arbitrary prohibition against pest control products across the nation, with headquarters in Vancouver, British Columbia.

It claims to be funded by more than forty-thousand donors from around the world ( including eighteen-thousand in Ontario ), as well as over fifty corporations and foundations.

With fifty employees, its operating budget is likely to be close to five-million-dollars per year.

Suzuki avoids government grants, although it does accept money from organizations funded by the government.

Moreover, in 2010, Suzuki DID accept grants from Ontario Trillium Foundation, ranging from 100,000 to 250,000 dollars.

From at least five of its principal private donors alone, Suzuki has obtained over five-million-dollars since its creation in 1991.



Suzuki is one of the largest multi-million dollar money-making machine of its kind within the anti-pesticide and enviro-terrorist movement.

## SUZUKI CONTROVERSIES

David Suzuki foundation promotes itself as a nation-wide, non-partisan, non-profit, registered-charity, tax-exempt environmental organization.

The rules at the Canada Revenue Agency seem clear.

A registered charity « *cannot be involved in partisan political activities*».

Unless, apparently, you are David Suzuki and the David Suzuki Foundation.

Here is how Canada Revenue Agency defines what is prohibited to David Suzuki Foundation —

*A political activity is considered partisan if it involves direct or indirect support of, or opposition to, a political party or candidate for public office.*

Charities can promote the policies of political parties and candidates they agree with, but must not directly or indirectly support the political party or candidate for public office.

On July 21st, 2011, the Toronto Star reported David Suzuki, in an interview, urged Ontarians to re-elect Liberal Premier Dalton McGuinty on October 6th, 2011 —

*I'm offering an endorsement of what Mr McGuinty has done, absolutely.*

Suzuki does not interfere in partisan politics ?!?!

Suzuki was a principal partisan architect with the Ontario McGuinty Government in conspiring to prohibit pest control products used in the urban landscape.

Suzuki described the environmental policies of the Conservative opposition rival, Mr Tim Hudak, as « *absolute insanity* ». [ ?!?! ]


