Grain producers are NOT accepting the proposal for a pesticide regulation, announced on July 19th, 2017, as part of the Quebec Pesticide Strategy 2015-2018.

The government intends to PROHIBIT the use of five pest control products for agricultural purposes unless it is justified in advance by an agronomist.

The proposed amendments would PROHIBIT, by 2019, the agricultural use of atrazine, chlorpyrifos and three neonicotinoids (clothianidin, imidacloprid, and thiamethoxam), unless their use is justified in advance by AGRONOMISTS.

PROHIBITION would also include the sale and application of neonicotinoids in the Urban Landscape.

A draft of the regulations was published in the Gazette Officielle du Québec on July 19th, 2017.

The PROHIBITIONS may be enforced within 45 days following the date of publication.

Of the products that would be prohibited, three are Neonicotinoid Insecticides, which are [**falsely**] associated with the DECLINE of bee colonies.

According to grain farmers, the measures announced will SIGNIFICANTLY INCREASE PRODUCTION COSTS, and that the impending measures make up for only a fraction of the negative impact on production.

In a written statement to The Canadian Press, Mr Christian Overbeek — President of the Grain Growers of Quebec — argued that eliminating these products may mean a YIELD REDUCTION of more than 5 per cent.

The Grain Growers of Quebec estimates that this decline in productivity will amount to TENS OF MILLIONS OF DOLLARS ANNUALLY.

Added to this is the COST OF AGRONOMISTS and RECORD-KEEPING of pest control products that the government estimates will total 8.5 MILLION DOLLARS PER YEAR.

The last budget announced by Quebec officials provides a mere 3.0 MILLION DOLLARS PER YEAR in funding, which Grain Growers of Quebec call a « *slap in the face* ».

They also claim that the PROHIBITION against pest control products in Europe has led to increased use of other products and increased presence of pests. [**See later segment entitled PROHIBITION FAILURES.**]

The Grain Growers of Quebec will be making their case at government consultations.


They also face nearly insurmountable opposition from David Suzuki, and its fanatical operatives, including its acolytes that have obviously INFESTED the government of Quebec.
