There are NO valid alternatives to conventional pest control products !

Without the use of conventional pest control products, many jurisdictions have had to resort to the back–breaking and agonizing job of WEED PULLING BY HAND !

Municipalities CANNOT afford the high cost manual labour required for weed pulling. Consequently, Government Officials enlist the help of resident VOLUNTEERS, most of whom are elderly and unemployed.

In cities like Lawrence, Kansas, Government Officials are now reverting back to conventional pest control since residents are no longer interested to volunteer their time in a losing battle against weeds.

NOT A SINGLE Environmental–Maniac–Activist has ANY recognized expertise, training or background in matters concerning pest control products or the management of Green Spaces ! To convert all parks to pesticide-free, a cost analysis has estimated that the City of Lawrence would have to spend 213,000 dollars for equipment, 116,000 dollars annually for staff, and 95,000 dollars annually for materials.

LM Week in Review

On June 7 [2005], in response to pressure from environmental [terror] activists, the city commissioners of Lawrence, Kansas, voted unanimously to designate Watson Park as « *pesticide-free* ». The seven-acre park adjacent to the downtown was part of the original town of Lawrence.

Watson Park will be a TEST CASE so that the community can see the results of a pesticide-free maintenance program.

Carnage

Fred DeVictor, director of Parks and Recreation, said his department would also use the park to find out how much pesticide-free management will actually cost the city.

Although the parks and recreation department showed it spends less than \$10,000 a year for pesticides, activists had lobbied the city's commissioners to convert all of the city's 52 parks to PESTICIDE-FREE MAINTENANCE by 2009. However, a COST ANALYSIS by the Parks and Recreation staff estimated that the city would have to spend \$213,000 for equipment; \$116,000, annually for staff; and \$95,000, annually for materials to achieve that goal.

In a May 11 [2005] memo to the City Manager giving details of the budget requirements for a proposed pesticide-free maintenance program, Mark Hecker, Park & Maintenance Superintendent wrote :

<< Most of our professional staff, and most of the horticultural industry, do not believe this is the most cost effective way to manage a park system. If requested, we could provide testimony from industry experts, articles and quotes from trade publications and research done by universities and professional organizations that would detail the proper and safe use of pesticides as a management tool. We have concerns that our inability to use pesticides may reduce the quality of our parks and could threaten the long-term health of the City's parks, trees, shrubs and flowers. >>

After discussion, it was decided to designate a « signature » pesticide-free park and eventually compare the results to the city's other parks.

In May 2005, the Lawrence City Commission requested the Parks and Recreation Department to select a park to conduct a pilot program, maintaining it as a pesticide-free area for a one-year period. Lawrence Parks and Recreation staff chose Watson Park in Downtown Lawrence.

During this time, the department experimented with non-pesticide products to manage weeds, insects, and fungi in the park, as well as DEVELOP A VOLUNTEER NETWORK to help manage the space. Volunteers assisted with the park by weeding the flower and shrub beds.

[GOVERNMENT OFFICIALS REVERTED BACK TO CONVENTIONAL PEST CONTROL SINCE RESIDENTS ARE NO LONGER INTERESTED TO VOLUNTEER THEIR TIME IN A LOSING BATTLE AGAINST WEEDS.]

When pesticide use is necessary, signs will be posted one hour prior to application. They will be placed in highly visible areas and remain up for 24 hours after application. The notification signs will include: the name and active ingredient of the pesticide product, the target pest, the date of pesticide use, and contact information for the city department.

Section XIII. – Impact to system

Integrated Pest Management as a general rule is a more expensive management system than the traditionally used pesticide treatments to manage the parks. Therefore, budget adjustments will be essential in order to reach the long range goals set by this policy. These budgetary needs will develop from the increase in workload caused by reducing pesticide application and increasing cultural and biological control tactics to solve pest problems. These control tactics can be effective but are often more time consuming and labor intensive. This is demonstrated by the annual labor hour report for Buford Watson, Jr. Park shown below.

Annual Labor Hour Report - Buford Watson, Jr. Park				
Years	2004	2005	2006	2007
Pruning/Landscape Bed Maintenance(Hours)	295.5	336.75	416.5	408
These hours include mulching, pruning, weed removal, flowers, and watering.				

This table shows almost a 30% increase in park labor hours from 2004 to 2006, after the implementation of the pesticide reduction plan. Alternative methods of pesticide control to regulate pests require a substantial commitment of labor resources. Alternative methods and products to pesticides generally require multiple attempts or applications to attain the same results as a single application standard for most pesticides.

The table below demonstrates the estimated increased labor, labor cost, materials cost, and total cost of managing a 1,000 square foot area with pesticides vs. hand weeding.

Cost for weed management in a 1,000 square foot area				
Method	Labor	Labor cost	Materials cost	Total Cost
Roundup Pro	1 hour	\$21	\$2	\$23
Hand Weeding	12 hours	\$252	\$0	\$252

The table above demonstrates the increase in labor workload and cost for maintaining a 1,000 square foot landscaped area in a park. This example is the estimated increase expected of an average park landscape area for the City of Lawrence. There are other examples where this increase is much more drastic. One example is city maintained cemeteries. Without the ability to apply pesticides around headstones, the workload would increase more than 400 percent. An example of this increase is shown in the table below.

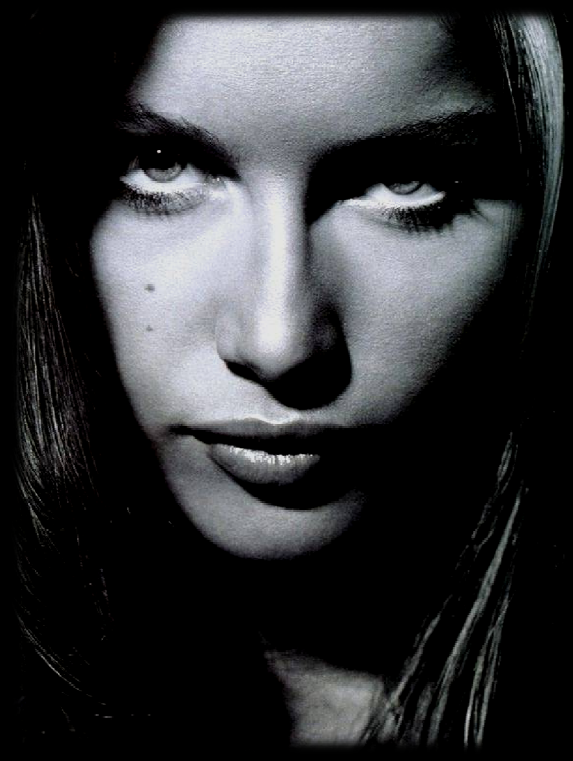
