The 2,4-D Task Force is comprised of those companies owning the technical registrations on the active ingredient in 2,4-D herbicides. The Task Force II was

organized to provide massive scientific funding for the ongoing Good Laboratory Practice (GLP) research studies required to respond to the US Environmental Protection Agency (US EPA) Registration Review and Health Canada's Pest Management Regulatory Agency (PMRA) Pesticide Re-Evaluation Programs. It is widely recognized that these national regulatory agencies are leading world authorities on pesticide toxicology, exposure, and epidemiology. They conduct an exhaustive series of scientific risk assessments to evaluate the human health and environmental impacts of 2,4-D prior to its registration. Currently-used pest control products like 2,4-D have been tested in more ways than virtually any other set of substances. The general standard for the registration of a pest control product is that there are no unreasonable adverse effects to humans or the environment when the pesticide is used according to label directions.

Part of our effort in spring is to do things to ENGAGE PEOPLE and have conversation about what they can do on their lawns that's environmentally friendly. [!?!]

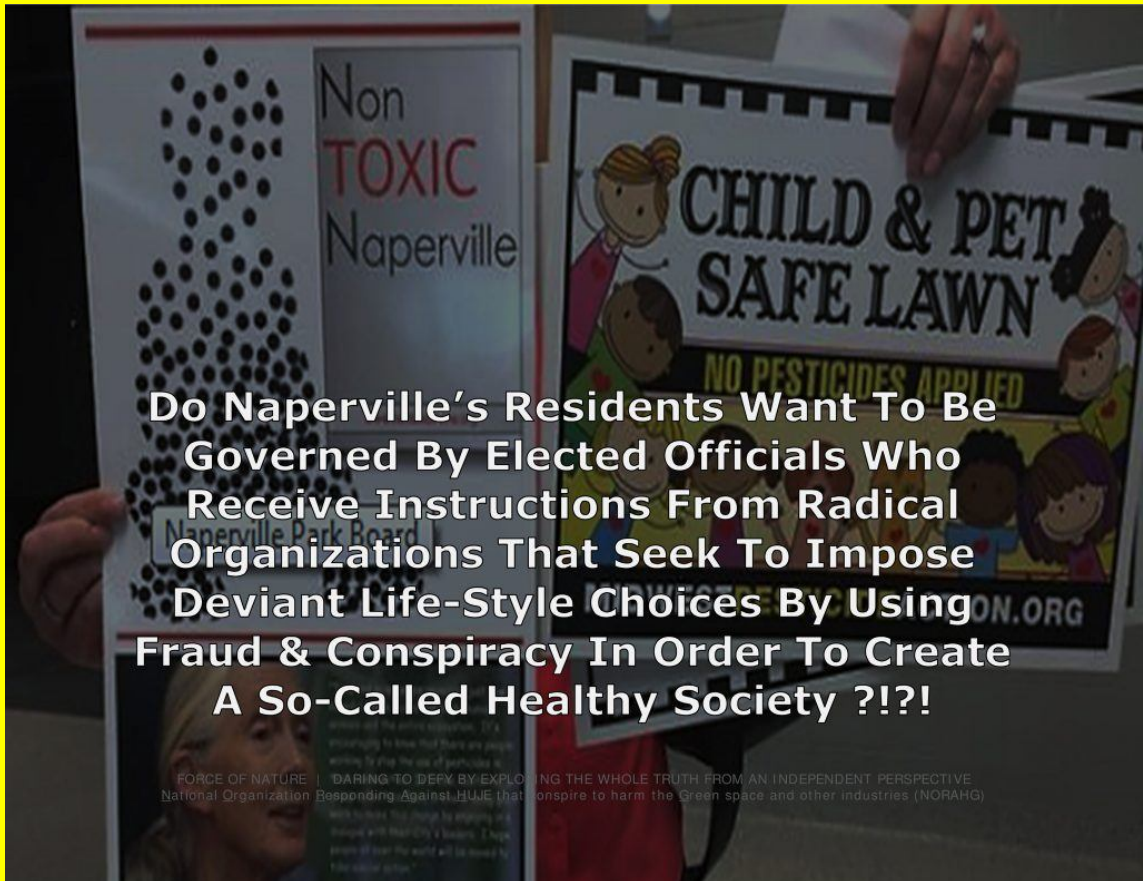
