The Danish government has announced that it has reached an agreement that aims to PHASE OUT PEST CONTROL PRODUCT USE ON GOLF COURSES throughout the country.

A broad political majority has agreed that the Danish Golf Industry should be FORCED to use FEWER AND LESS HARMFUL PEST CONTROL PRODUCTS, even though the ones currently in use are GOVERNMENT-REGISTERED and SCIENTIFICALLY-SAFE.

There is consensus that the long-term goal is a TOTAL PHASE-OUT OF PEST CONTROL PRODUCT USE ON DANISH GOLF COURSES concurrently with the development experience of pest control product management and use of alternative methods.

Environment Minister will therefore undertake a technical review by external experts in order to define the lowest level of pest control product use on golf courses where there continue to be made for an operation of the runways.

As part of the agreement, Environmental Protection Agency Chemical Inspection Service in 2011 to repeat its review of whether golf clubs using pest control products that cannot be legally used on golf courses.

Clubs caught in serious or repeated VIOLATIONS of the rules WILL BE REPORTED TO THE POLICE.

The agreement, which was made between the Danish Government, the Danish People's Party, the Social Democrats, the Socialist People's Party and the Danish Social-Liberal Party, seeks to replace the present Agreement On The Golf Courses Of The Future dating from June 2005.

It states that the long-term objective is a PHASING-OUT OF THE CONSUMPTION OF PEST CONTROL PRODUCTS ON DANISH GOLF COURSES coupled with increases in education regarding pest control product-neutral care utilizing ALTERNATIVE METHODS, such as MECHANICAL WEED CONTROL.

Part of the agreement involves an evaluation of the results achieved so far, to be carried out before the end of 2014, in order to inform efforts to TIGHTEN THE REQUIREMENTS.

The partial aim of the 2005 agreement was that, before the end of 2008, the USE OF PEST CONTROL PRODUCTS ON GOLF COURSES SHOULD BE REDUCED TO 0.1 KG OF ACTIVE INGREDIENT PER HECTARE (HA).

As part of the 2005 agreement, golf courses were to submit their pest control product use data in the form of annual Green Accounts to THE DANISH GOLF UNION, which has ADVOCATED FOR STRONGER ENVIRONMENTAL PRACTICES.

The Union's analysis of these accounts has revealed a 2008 consumption of 0.23 kg per hectare, and 0.24 kg per hectare for 2009, equivalent to a total consumption on Danish golf courses of 2.5 tonnes of active agent.

All parties were coerced into agreeing that this was somehow not satisfactory.

The 2005 agreement was a solely voluntary effort to reduce usage, but under the new agreement, it will be replaced by binding regulations regarding golf organizations' use of pest control products.

The regulations are to be based on the following Enviro-Lunatic Principles, outlined in the agreement —

LUNATIC DANISH PRINCIPLE NO. 1

Golf is an important part of Danish sporting activities; but, for the sake of human health and the environment, the pest control product consumption in the golf organizations must be minimized. [?!?!]

Hence, the Enviro-Lunatic Danish Minister for the Environment will initiate an external expert evaluation for the purpose of determining the lowest possible level of pest control product consumption on Danish golf courses, still allowing the feasibility of continued operation of the courses.

These external experts are likely to be Non-Expert For-Profit U.S. Prohibition-Terrorist-Organizations like Beyond Pesticides.

LUNATIC DANISH PRINCIPLE NO. 2

Regulations, subject to which only the appliance of so-called, and BOGUS, low-risk pest control products shall be allowed on golf courses and other public areas, will be implemented.

Risk factors will be determined using a bench-marking system based on the health and environment properties of the individual pest control products.

LUNATIC DANISH PRINCIPLE NO. 3

The current partial aim of 0.1 kg active agent per hectare will be replaced by the establishment of a new cap scheme for the use of pest control products on golf courses based on the pest control products' PERCEIVED and ALLEGED strain on health and environment.

The ceiling imposed will be determined on the basis of the expert opinion provided subject to clause 1 and will be calculated using the bench-marking system referred to under clause 2.

This will urge the golf clubs to apply the pest control products of lowest impact in each individual case.

In consideration of the historic reference, the consumption will still be stated in kilograms of active agent per hectare.

LUNATIC DANISH PRINCIPLE NO. 4

In consideration of the consumers, an investigation will be carried out for the purpose of assessing the feasibility of preparing a public statement of the pest control product consumption at the individual courses.

LUNATIC DANISH LEGISLATION

Following these goals, the Danish Minister of the Environment introduced a bill in January 2011 proposing an amendment to the existing chemical law.

The bill would authorize subsequent regulations that would impose binding requirements on Danish golf courses with respect to their use of pest control products.

The parties also agreed that it is essential to follow-up on golf course pest control product consumption and continue to monitor usage.
