The Golf Industry is facing its WORST ATTACKS by SELF-APPOINTED LUNATIC-AUDITORS from Prevent Cancer Now (PCN) who will attempt to judge the practices of the Golf Industry.

Prevent Cancer Now's LUNATIC-AUDIT has already identified trends, such as annual variability in pesticide usage, and shifts from older (supposedly more toxic) insecticides to newer ones (purported to be less toxic to non-insect life forms).

History Of IPM Council Web-Site

Since 2009, the Government of Ontario has ARBITRARILY PROHIBITED the sales and use of pest control products on lawns and gardens, BUT NOT GOLF COURSES.

Before the Act was finalized by the government, the Golf Industry committed itself to using Integrated Pest Management (IPM) to REDUCE PESTICIDE USE.

IPM includes cultural practices (choice of grasses, types and timing of fertilizer, mowing, aeration, etc...).

To track the PROGRESS ON PESTICIDE REDUCTION, ANNUAL REPORTS FROM EVERY GOLF FACILITY are required to be posted on the web-site of the IPM Council of Canada.

With the on-line posting, the PROGRESS ON PESTICIDE REDUCTION in the reduction of pest control products by the Golf Industry can now be easily tracked and evaluated by Anti-Pesticide & Golf-Hating Lunatics.

A quick perusal of the IPM Council web-site has shown observers that there has been NO PROGRESS ON PESTICIDE REDUCTION.

IPM Is Not, We Repeat Not, Among Critical Issues For The Golf Industry !

As everyone in the Golf Industry knows, IPM DOES NOT WORK !

Moreover, IPM will NOT REDUCE PESTICIDE USE.

Here are some FACTS about IPM —

√ FACT — IPM DOES NOT WORK

Despite rigged testimonials and mock-photos, Integrated Pest Management (IPM) is INEFFECTIVE and DOES NOT WORK !

Sadly, IPM is promoted by those who FALSELY ALLEGE SUCCESS, and by those who are likely CONCOCTING LIES, MISCONCEPTIONS, and DECEPTIONS for their own nefarious personal interests.

Overall, IPM is a WASTE OF TIME AND MONEY for Golf Facilities.

IPM cultural practices DO NOT CONTROL PESTS of established turfgrasses, and WILL NOT ENSURE ADEQUATE PLAYING CONDITIONS. (See later paragraph.)

IPM IS A FAILURE !

√ FACT — IPM IS INAPPROPRATE FOR THE GOLF INDUSTRY

For several decades, IPM has been BASTERDIZED into A RIDICULOUS NUMBER OF VERSIONS in order to suit the needs pesticide-hating fanatics, left-wing educators, and hapless professional.

The Pesticide-Free-Version of IPM DEMANDS the ELIMINATION of the use of conventional pest control products while adopting so-called IPM-Cultural-Practices that will somehow suppress pest populations to an acceptable level.

This is WRONG !

IPM is NOT EVEN the best way to simply REDUCE PESTICIDE USE.

IPM-Cultural-Practices CANNOT be consistently considered as true alternatives to conventional pest control products, since damaging pests are often only SUPPRESSED, and NOT CONTROLLED.

Wherever Pesticide-Free-IPM is entirely relied upon for the maintenance of turf and ornamentals, damaging pests MAY ONLY BE SLIGHTLY SUPPRESSED, at the expense of plant growth, playing conditions, and appearance.

Otherwise, it is IMPOSSIBLE for maintenance professionals in Golf Facilities to keep their properties playable and/or beautiful by using IPM.

Unfortunately, IPM has been designed to be applicable to the Agriculture Industry, and NOT the Golf Industry.

In agriculture, IPM is a LEGITIMATE pest control strategy that uses a variety of complementary strategies including — mechanical devices, physical devices, as well as genetic, biological, and chemical management.

√ FACT — IPM PROVIDES NO BENEFIT

The interpretations of Integrated Pest Management (IPM) provide NO BENEFIT and NO SCIENTIFIC BASIS with the use of simplistic messages like « *use least toxic pesticides as a last resort* » and « *apply it only as a last resort* ».

According to three scientific organizations — Weed Science Society of America (WSSA), American Phytopathological Society (APS), and Plant-Insect Ecosystems Section of the Entomological Society of America (P-IE ESA) — these messages are NOT THE CORRECT APPROACHES to the pesticide component of an Integrated Pest Management (IPM) program.

√ FACT — IPM DOES NOT EXCUSE THE USE OF ILLEGAL CONCOCTIONS

Golf Facility professionals must STOP using unregistered concoctions under the FALSE PRETEXT that they are following the strategies of Integrated Pest Management (IPM).

Unregistered concoctions with compost tea, dish soap, vinegar, and phosphite are NOT legal, NOT valid, NOT effective, NOT economical, and NOT safer as alternatives to legally-registered conventional pest control products.

Virtually all such alternatives are BOGUS.

Moreover, it is a violation of federal law to recommend or sell or use unregistered concoctions for controlling pests that are NOT registered under the federal law.

If someone recommends or sells an unregistered concoction with the claim that it controls pests, it technically becomes a pest control product.

Such a claim, in either verbal or written form, regarding an unregistered product becomes technically a violation of federal law.

Additionally, preparing, storing, and using unregistered concoctions can pose risks to health and environment.

Most often, these pest control concoctions and recommendations are written by anonymous or non-expert authors who KNOW NOTHING about pest control.

Conventional products, such as 2,4-D and Chlorothalonil, cannot be replaced by bogus, illegal, untested, unproven, and often dangerous concoctions !

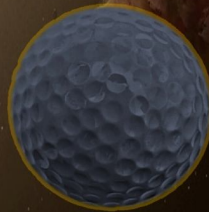



5. ANTI-PESTICIDE GOVERNMENT OFFICIALS & ACTIVISTS — The Golf Industry must CEASE its pointless and wasteful attempts to educate and to convince pesticide-hating government officials and activists. These fanatics will NEVER reverse their attitudes against conventional pest control products.

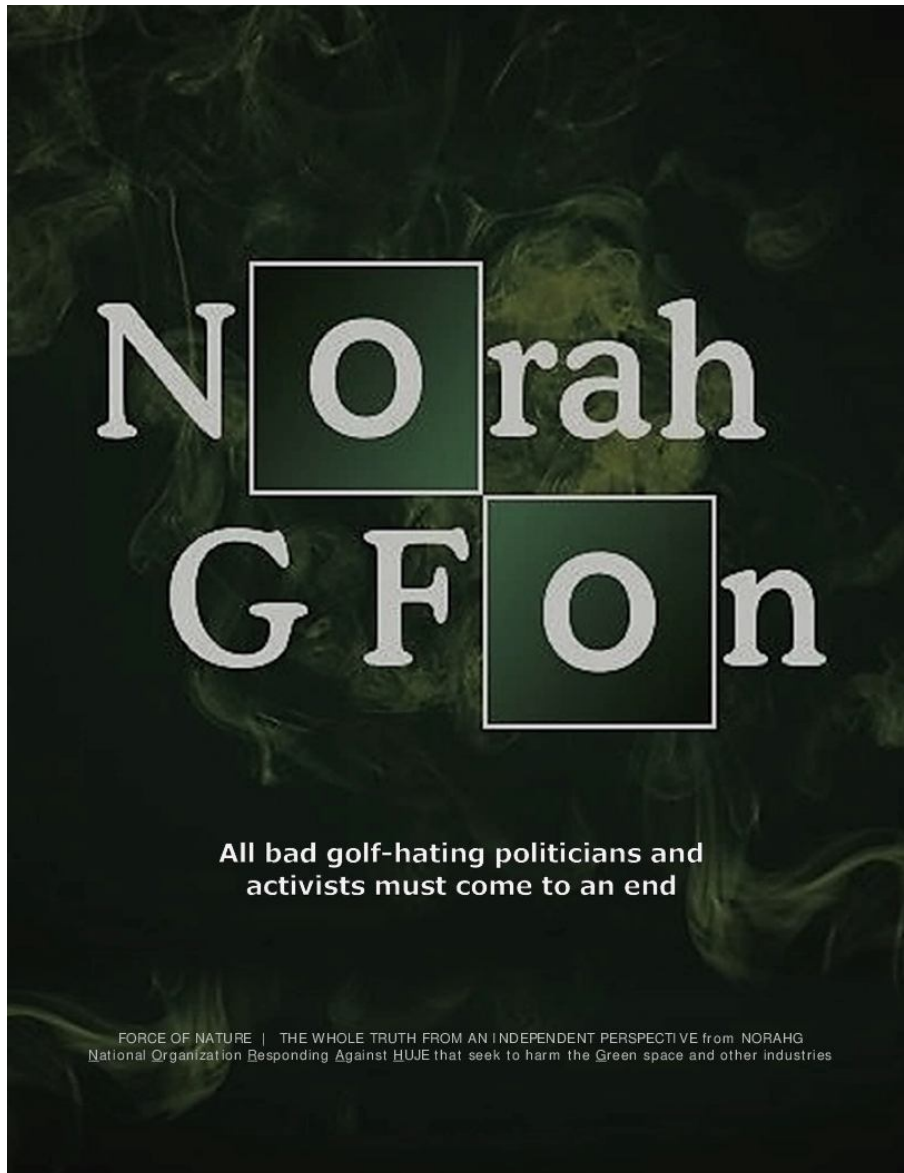
14. POLITICAL ACTION — The Golf Industry Must openly and financially SUPPORT all political candidates who oppose any prohibition of pest control products and fertilizers.
