In order to compensate for her lack of expertise, she relied upon junk science and fake news, and affectionately became known as the clown witch of junk science.

It also seems that Irwin was the person who can ultimately be acclaimed for fanatical-prohibition in the town of Hudson, Quebec, and all other prohibitions that followed — this is also a myth.

Irwin had many co-conspirator allies, including the mayor, councillors, and staff of the town of Hudson, Quebec.

Hudson was a small isolated ghetto-town with a frustrated anglophone minority, among them being Irwin, living in a province that practices french supremacy.

Thankfully, Irwin's Legacy Has Been Silenced, Forever

When the Supreme Court of Canada (SCC) ruled in favour of Hudson's fanatical-prohibition in June 2001, it determined that the town could legally impose prohibition.

The SCC ruled that Hudson did NOT contravene either provincial or federal laws.

The SCC did NOT rule on the basis of June Irwin's lying lunatic rants, nor did it rule on the safety of pest control products.

In essence, the ruling in favour of Hudson decided the outcome between municipal versus provincial and federal authority.

Even though the Quebec government itself imposed its own province-wide fanatical-prohibition during the period 2003 to 2006, its legislation was invalidated and defeated in 2011 when a legal challenge, the NAFTA lawsuit, was settled, and Quebec officials were humiliated into admitting that products, like 2,4-D herbicide, did NOT pose an unacceptable risk to human health or the environment.

Consequently, pest control products were shown to be scientifically safe and the Quebec's fanatical-prohibition was irrefutably invalidated.

Ultimately, June Irwin's legacy against pest control products ended in DISMAL FAILURE.

Nonetheless, in all cases, fanatical-prohibitions against conventional pest control products have, themselves, become DISMAL FAILURES that have led to catastrophic business carnage, ecological carnage with uncontrolled pests, and financial carnage !

These fanatical-prohibitions have been extremely biased, highly prejudicial, inconsistent, unfair, subversive, and destructive (just like June Irwin).

Clearly, many government officials have empowered themselves to arbitrarily prohibit safe and effective conventional pest control products, and, with extreme bias and total prejudice, have allowed higher-risk, ineffective, and inferior green alternatives because it aligns with their political precepts and doctrines (just like June Irwin).

Allegations from these government officials, and their fanatical-activist co-conspirators, regarding the imaginary danger of pest control products are totally false, and are untrue mis-representations designed to alarm and enrage the public and to advance their agendas and ideologies.

National regulatory agencies, like EPA and Health Canada, DO NOT allow the use of unsafe pest control products !

An open letter to Mayor Taylor Bradbury and Hudson town council:

We are concerned about abortions but we haven't ensured the fetus life without pollution.

Le Presse July 22, 1988, reports that the herbicide used in the cultivation of corn has been shown to cause birth defects and genetic anomalies. The herbicide is found in alarming quantities in the ground waters of Ontario and in the Great Lakes. The herbicide can enter the body by drinking water or by bathing in the water.

The Globe and Mail, Feb. 7, and *Le Devoir* Feb. 18, 1989, reports on the toxic PCB contamination of Inuit women's milk, stating the toxins are carried north from the Great Lakes and other southern pollution sources through the atmosphere, descending with rain and snow.

Another season is passing with entry into out towns of trucks bearing toxic chemicals and pesticides (herbicides, insecticides and fungicides); and sometimes reportedly the trucks come in while the town is still sleeping, without vigil.

Individuals have a right to life and health, not by using medicine, but by drinking pure water and breathing clean air.

Why should our provincial government pass laws to permit these chemicals in our neighborhoods, on lawns, trees and houses?

How do you tell a child he can't go out to play today?

When our federal External Affairs minister, Joe Clark, appealed to all countries to ban all chemical weapons earlier this year he is ignoring the problem at home?

When is this chemical warfare in our neighborhoods—this spreading and sprayings on lawns, trees and homes—going to stop?

Ottawa is pouring money into the war on drugs, and Canadians have an obligation to break this illegal drug habit.

Those who are not malicious nor looking for personal kicks and have no interest in illegal drugs, are forced to endure the toxic chemicals in the community.

Why don't people have access to the laboratories—the laboratories which are already measuring cocaine in drug users, or illegal chemicals in athletes?

Indeed it would seem just as important, if not more to measure blood content of the harmful chemical contained in the spreading and sprayings, thus giving knowledge of the person's health with a view to prevention and reducing health costs.

Through various scientific publications and communications, it is understood by the authorities that the chemicals in the fertilizer and pesticide applications can harm health and can enter our bodies.

According to my own studies, done in U.W. laboratories, some people, including our youth, have had pesticides detected in their blood.

To quote David Carter of the Oklahoma Agent Orange Foundation, May 12, 1988, "There is no normal level of a synthetic chemical in a human being."

Just as for the victims, born without limbs because their mothers took thalidomide during pregnancy, will our provincial and federal governments compensate the victims of this chemical pesticide use in our communities?
