TO SUPPORT A PROVINCE-WIDE BAN on pesticides for cosmetic use.

The majority of the committee SUPPORTS USING SCIENCE-BASED EVIDENCE and WILL NOT RESTRICT ACCESS TO PROD-UCTS THAT ARE APPROVED FOR SAFE USE IN CANADA. >>

« Your Honour », the lawyer could well surmise, « politicians will never let the facts get in the way of a good ban ».

Another quote, from PAGE 47 of the report by British Columbia's Special Committee On Cosmetic Pesticides —

<< From our perspective, the scientific evidence DOES NOT, at this time, warrant preventing British Columbians from buying and using approved domestic-class pesticides for lawn and garden care.

In other words, we are not prepared to say to consumers, « You can no longer go into any store, under any circumstances, and buy 2,4-D » >>.



Criminal Chemical

The 2,4-D referred to, of course, is the herbicide dichlorophenoxyacetic acid, the superstar/chief villain of the domestic pest control products controversy.

The suburbanite's lawyer will face a tougher task if his/her client has a jury trial.

Pest control products are SCIENTIFICALLY-SAFE, and PROHIBITIONS have been further IRREFUTABLY INVALIDATED by Province of Alberta.

The Province of Alberta STOPPED the trend towards NEEDLESS, SENSE-LESS, and MALICIOUS PROHIBITION.



On August 9th, 2011, the Government of Alberta stated that it WILL NOT CREATE RESTRICTIONS OR LAWS THAT CONFLICT WITH THE FEDERAL GOVERNMENT, that is relied upon for health and safety assessments.

Consequently, the Government of Alberta has indicated that is has NO INTENT TO PROHIBIT THE SALE OF ANY PEST CONTROL PRODUCT.

Alberta has monitored Anti-Pesticide PROHIBITIONS over the past few years and the approaches taken by other jurisdictions, and has found THE BASIS FOR ACTION CONFUSING AND INCONSISTENT.

Additionally, pest control products are SCIENTIFICALLY-SAFE, and PRO-HIBITIONS have been IRREFUTABLY INVALIDATED by Province of Quebec.

On May 25th, 2011, Dow AgroSciences, the manufacturer of the pest control product 2,4-D, SETTLED THE NAFTA CHALLENGE CASE with the Canadian government.



The North American Free Trade Agreement, or NAFTA, is an agreement signed by the governments of Canada, Mexico, and the United States, creating a tri-lateral trade block in North America.

As part of the agreement, a VICTORY for the company, the Government of Quebec was HUMILIATED into making a STATEMENT saying that ...

Quebec was the first province to declare weed control products containing 2,4-D as POSSIBLY carcinogenic, which has now been DEEMED AS FALSE.

On that basis, municipalities in Quebec instituted NEEDLESS, SENSELESS, and MALICIOUS PROHIBITIONS against 2,4-D use as a lawn pest control product.

Other jurisdictions outside of Quebec also CONSPIRED to IMPOSE the Anti-Pesticide PROHIBITIONS against 2,4-D under the PRETEXT that it was a so-called carcinogen — this ALLEGATION is now REFUTED.



In fact, ABSOLUTELY NO regulatory body in the world classifies 2,4-D as a human carcinogen — 2,4-D is probably the MOST STUDIED and BEST UNDERSTOOD of ANY chemical — not just pesticide — in existence.

2,4-D DOES NOT POSE AN UNACCEPTABLE RISK to human health or the environment.

Conclusion

Pest control products are SCIENTIFICALLY-SAFE, and PROHIBITIONS are now IRREFUTABLY INVALIDATED.

Even so, the law is the law — you spray, you pay.

Pesticides Cause No Harm

Pest control products CAUSE NO HARM and are SCIENTIFICALLY-SAFE.

Not surprisingly, the BC Special Committee on Cosmetic Pesticides AGREED — and deserves CONGRATULATION.

It is COMMON KNOWLEDGE that there are NO pest control products that are known or probable carcinogens.

Legacy — Mr. Gathercole and his colleagues ... designed and implemented strategies that reined anti pesticide activists to provide peace and prosperity for the entire modern green space industry across Canada • orchestrated legal action against anti pesticide activists in the town of Hudson, Quebec • launched the largest founding professional lawn care business in Canada • quadrupled the business revenues of one of the largest suppliers in Canada

Mr. Gathercole is now retired, although his name continues to appear as founder of FORCE OF NATURE and A LOOK AT reports.
