

#### The Necessary Steps For DESTROYING David Suzuki

WILLIAM H GATHERCOLE AND NORAH G write blogs and reports for Force Of Nature and they have responded many times standing up for the rights of the golf superintendents and their facilities.

David Suzuki and his operatives are affectionately called « fanatics » because we need to make a distinction between how the so-called environmentalists behave now, and what the original definition of environmentalist was.

What Trade Associations Need To Do - How To DESTROY David Suzuki

#### 1. Frame Suzuki As Unfit To Provide Any Advice

Is Suzuki Incompetent ?!?!

David Takayoshi Suzuki has NO competent expertise, NO recognized training, and NO successful background in matters concerning environmental issues and pest control products.

Actually, he is a mere expert on fruit flies.

His educational background is clearly inadequate for dealing with environmental issues — B.A. Honours in Biology and a mere Ph.D. in Zoology.

David Suzuki's personal background is also inadequate, with vested interests with anti-pesticide & environmental-terrorist organizations that illegally interfere in partisan politics & public policy concerning pest control products —

- chairman (until 2011) & co-founder (1991), David Suzuki Foundation
- honorary board member, Ecojustice Canada
- honorary board member, Environmental Defence Canada.

Serving on all of these boards of directors DOES NOT make Suzuki competent.

Suzuki is NOT a scientist and NOT a researcher.

He is NOT competent to provide any advice.

Suzuki compensates for his incompetence by becoming a lying sack of crwp.

David Suzuki has huge vested interests in perpetuating lunatic-lies, imaginary-dangers, & politicized-doctrines because he is paid to do so.

And so are his fanatical-operatives.

These fanatics know nothing about pest control products and golf course maintenance.

We need a better David Suzuki, and NOT the Suzuki, with his fanaticaloperatives, who are unfit to give advice because of their personal incompetence! \_\_\_\_\_\_

#### 2. Exploit Suzuki's Greatest Weakness

### Suzuki's Illegal Activities Are Under Investigation

In anticipation of an unfavourable & imminent audit by Canada Revenue Agency, David Suzuki himself was forced to resign from his own foundation for fear that his outspoken political views and interference in partisan politics would compromise the foundation's charity tax exempt status.

Poor li'l enviro-terrorist charity!

Although David Suzuki was forced to quietly step down from the Board of Directors of David Suzuki Foundation during summer of 2011, his resignation was NOT officially announced until 2012.

On April 13th, 2012, Suzuki officially announced he had stepped down from the board of directors of his organization, alleging that he wanted to shield it from partisan attacks [?!?!] —

I want to speak freely without fear that my words will be deemed too political, and harm the organization of which I am so proud.

I am keenly aware that some governments, industries and special interest groups are working hard to silence us.

They use threats to the Foundation's charitable status in attempts to mute its powerful voice on issues that matter deeply to you and many other Canadians.

Suzuki's decision followed the Government of Canada's decision to investigate environmental terrorist organizations and their illegal interference in partisan politics & public policy.

Canada Revenue Agency was allocated 13.4 million dollars to ensure that no more than 10 per cent of monetary resources was being spent by organizations like Suzuki while interfering on these issues.

Demands are now being made for David Suzuki to step down as host of television programs produced by Canadian Broadcasting Corporation, including The Nature Of Things.

We need a better David Suzuki, and NOT the Suzuki that exists only to make money through illegal activities!

### 3. Shine A Spotlight On The REAL Suzuki With Its Vested Interests

### Suzuki's Multi-Million Dollar Money-Making Foundation

David Suzuki Foundation is an anti-pesticide, golf-hating, & environmental-terrorist organization that conspires to impose reckless and arbitrary prohibition against pest control products across the nation.

It operates across Canada and the United States, but its business headquarters, with over fifty fanatical-employees, is located in Vancouver, British Columbia.

It has branch offices in Ottawa and Montreal.

David Suzuki Foundation uses junk science to coerce, intimidate, and alarm the public with lunatic-lies, imaginary-dangers, & politicized-doctrines to conserve nature and to help achieve sustainability within a generation.

It claims that ...

The David Suzuki Foundation works through science and education to protect the diversity of nature and our quality of life, now and for the future. [?!?!]

In fact, Suzuki's main objective is profit through donations, by scamming the public with the concoction of fraudulent lunatic-lies, imaginary-dangers, & politicized-doctrines about pest control products and other environmental issues.

More lies means more profit for Suzuki.

It is a mere fund-raising, profit-seeking, and lobbying organization, and it is NOT a science, NOT a research, and NOT a health organization.

It claims to be funded by more than forty-thousand donors from around the world (including eighteen-thousand in Ontario), as well as over fifty corporations and foundations.

Not surprisingly, Suzuki is presently under investigation for illegally interfering in partisan politics & public policy.

Its operating budget is close to five-million-dollars per year. Suzuki avoids government grants, although it does accept money from organizations funded by the government.

Moreover, in 2010, Suzuki DID accept grants from Ontario Trillium Foundation, ranging from 100,000 to 250,000 dollars, ostensibly for his political interference in a provincial election.

From at least five of its principal private donors alone, Suzuki has obtained over five-million-dollars since its creation in 1991.

Researcher Ms Vivian Krause has estimated that millions of dollars have been provided indirectly to David Suzuki Foundation from American foundations, through Tides Canada or Tides USA.

In at least one instance, the Vancouver address for Tides USA, as reported to the U.S. Internal Revenue Service by the Hewlett Foundation, was EXACTLY THE SAME AS THE ADDRESS of the David Suzuki Foundation — 2211 West Fourth Avenue, Suite 219.

This demonstrated that Tides Canada operates as the financial shield for David Suzuki Foundation.

We need a better David Suzuki, and NOT the David Suzuki that is just a large multi-million dollar money-making machine!

#### 4. Emphasize Suzuki's Failed-Legacy Through Politicized-Doctrines

#### 7. Scrutinize Suzuki's Interference Campaigns

### Suzuki's Interference In Partisan Politics & Public Policy!

David Suzuki Foundation promotes itself as a nation-wide, non-partisan, non-profit, registered-charity, tax-exempt environmental organization.

The rules at the Canada Revenue Agency seem clear.

A registered charity « cannot be involved in partisan political activities».

Unless, apparently, you are David Suzuki and the David Suzuki Foundation.

Here is how Canada Revenue Agency defines what is prohibited to David Suzuki Foundation —

A political activity is considered partisan if it involves direct or indirect support of, or opposition to, a political party or candidate for public office.

Charities can promote the policies of political parties and candidates they agree with, but must NOT directly or indirectly support the political party or candidate for public office.

### **Example Of Suzuki's Subversive Interference With Partisan Politics!**

On July 21st, 2011, the Toronto Star reported David Suzuki, in an interview, urged Ontarians to re-elect Liberal Premier Dalton McGuinty on October 6th, 2011 —

I'm offering an endorsement of what Mr McGuinty has done, absolutely.

### Example Of Suzuki's Subversive Interference With Partisan Politics!

Suzuki was a principal partisan architect with the Ontario McGuinty Government in conspiring to prohibit pest control products used in the urban landscape.

Suzuki described the environmental policies of McGuinty's Conservative opposition rival, Mr Tim Hudak, as « absolute insanity». [?!?!]

### Example Of Suzuki's Subversive Interference With Partisan Politics!

In a speech at McGill University, David Suzuki suggested Conservative Prime Minister Stephen Harper and Conservative Alberta Premier Ed Stelmach, should be jailed for « *inter-generational* » climate crimes. [?!?!]

A spokesman for the Suzuki foundation later said Suzuki was NOT speaking literally about so-called climate crimes.

This is Suzuki's bogus excuse to remain in compliance with taxation laws.

### **Example Of Suzuki's Subversive Interference With Partisan Politics!**

In Calgary, Suzuki told an audience of school children, as he accepted 835 dollars they raised for his foundation —

The only thing (Prime Minister Stephen Harper) cares about is getting re-elected with a majority government.

### Example Of Suzuki's Subversive Interference With Partisan Politics!

In 2017, Suzuki himself hosted a television documentary that exploited the supposed death of a golfer as a weapon of coercion and environmental terror against products that have been clearly shown to be LESS TOXIC THAN Aspirin, baking soda, caffeine, cannabis, nicotine, table salt, and Tylenol.

This was truly a cheap shot, merely designed to alarm and infuriate the public against the golf industry, and interfere with public policy against the use of pest control products.

Suzuki had NO real evidence concerning the death, just politicized-doctrines intended to harm the golf industry.

### Example Of Suzuki's Illegal Violation Of Taxation Laws!

Here are more of Suzuki's bogus excuses to remain in compliance with taxation laws.

Regarding his partisan comments, he has said that they are « my personal opinion » and « nothing to do with my foundation ».
