Named in the action are the Minister of the Environment, **John Gerretsen**, Gerretsen's senior staff, and LEADING ACTIVISTS in the Ontario campaign to ban Health Canada APPROVED PESTICIDES.

Jeffrey Lowes, Director of Government Relations for M-REP Communications, has today crossed another milestone in the proceedings for charges under ...



- the Federal Pest Control Products Act ( 2002, C 28 ),
- the Federal Competition Act ( R.S., 1985, C. C-34 ), and
- the Criminal Code ( R.S., 1985, C. C-46 ).

At this point, Mr. Lowes stated —

*<< We have no comment on the proceedings until all the summons are issued. Due to the amount of evidence surrounding the charges, we will be requiring additional court dates to present additional evidence. There may be **additional charges** at this point as new information was given to M-REP two weeks ago. When this process is completed we will continue with our actions in respect to the municipal councillors. >>*

*<< I will be in **London** on Thursday [ February 18<sup>th</sup> ] to review information with lawyers before deciding on which municipality to start proceedings against councillors. Our first round will focus on the actions of councillors in **Kingston, London, and Owen Sound**. >>*

*<< We will then be taking on additional staff when we pursue the issue in **Toronto**. Our initial findings in **To-  
ronto** might be better handled in conjunction with a law enforcement agency. >>*

Other Provinces have been closely following these developments, since M-REP Communications has been working with the industry across Canada, and Mr. Lowes just spent over a week in BC [ British Columbia ] and Alberta meeting with members of the industry.

They [ provinces outside of Ontario ] are no doubt aware of the Federal Government's warning to Ontario about that Province's regulatory methodology.

**Jeffrey Lowes** has also previously warned Ontario's Minister of the Environment, the Minister's senior staff, and the organizations that presented the FALSE AND MISLEADING INFORMATION — which resulted in the ban — that the industry would « *exercise every possible legal option* ».



The industry's losses have now **exceeded over four hundred million dollars** in the 2009 season and are expected to **DOUBLE** in the 2010 season.

---

Mr. Lowes has been assigned TWO CROWN COUNSELS, one from the Ministry of the Attorney General ( Ontario ) and one from the Public Prosecution Service of Canada ( PPSC, Federal ).

[ THE TERM CROWN COUNSELS REFERS TO PROSECUTORS ATTACHED TO THE CROWN ATTORNEY'S OFFICE UNDER THE JURISDICTION OF THE PROVINCE OF ONTARIO AND THE FEDERAL GOVERNMENT OF CANADA. ]

The VIDEO EVIDENCE, as well as a majority of DOCUMENTS, will take a few days for the CROWNS to digest. So, at this point, the entire 133 charges have not been heard.



There has been some concern that the PROVINCIAL CROWN would STAY the charges [ A SUSPENSION OR POSTPONEMENT OF LEGAL ACTION ].

At this point, it is HIGHLY UNLIKELY, but in the event that direction is given to the PROVINCIAL CROWN, we will issue a « writ of mandamus », and have a NEW CROWN appointed from OUTSIDE THE PROVINCE. Again we do not see this happening, unlike the « Fantino » case, which was based on a few e-mails.

OUR INFORMATION IS BASED ON THREE YEARS OF WORK.

( February 6<sup>th</sup> was the third year anniversary of our involvement. ).

In private prosecution cases, ...

<< [ ... ] if a summons or warrant is issued and the case involves an indictable offence, the Crown is required to take over the prosecution. So, a private citizen's right to swear an information is always subject to the Crown's right to intervene and take over the prosecution. >>

## SUBJECT : WITNESSES

---

Individuals that have determined NOT TO TAKE THEIR CHANCES IN COURT, and are willing to provide corroboration to statements or other material evidence, should approach M-REP through a lawyer.

If the information is relevant and they are able to articulate the information clearly, we will take it under consideration and shared with the CROWN.

Those individuals could AVOID THE FUTURE CIVIL LITIGATION for themselves and their organization by coming forward.

If they are a MUNICIPAL COUNCILOR, there is a very strict threshold to be crossed.

MEMBERS OF THE INDUSTRY that wish to testify to the financial losses and the bias of municipal and provincial governments are welcome to submit written statements or affidavits.

All statements will be handled in camera during the proceedings.

Only consider this if you are willing to make the statements in open court when we go to trial.

### About the Public Prosecution Service of Canada

The Public Prosecution Service of Canada ( PPSC ) is a federal government organization, created on December 12, 2006, when the Director of Public Prosecutions Act, Part 3 of the Federal Accountability Act, came into force.

The PPSC fulfills the responsibilities of the Attorney General of Canada in the discharge of his criminal law mandate by prosecuting criminal offences under federal jurisdiction and by contributing to strengthening the criminal justice system.

The PPSC is responsible for prosecuting offences under more than 50 federal statutes and for providing prosecution-related legal advice to law enforcement agencies. Cases prosecuted by the PPSC include those involving drugs, organized crime, terrorism, tax law, money laundering and proceeds of crime, crimes against humanity and war crimes, *Criminal Code* offences in the territories, and a large number of federal regulatory offences.

The creation of the PPSC reflects the decision to make transparent the principle of prosecutorial independence, free from any improper influence.

The mandate of the PPSC is set out in the Director of Public Prosecutions Act. The Act calls on the PPSC to provide prosecutorial advice to law enforcement agencies, and to act as prosecutor in matters prosecuted by the Attorney General of Canada on behalf of the Crown.

In addition, the mandate includes initiating and conducting prosecutions on behalf of the Crown with respect to offences under the *Canada Elections Act*.

## Powers, Duties, and Functions of the Director

The core powers, duties, and functions of the Director of Public Prosecutions are set out in subsection 3(3) of the Director of Public Prosecutions Act. These responsibilities include :

- initiating and conducting federal prosecutions;
- intervening in proceedings that raise a question of public interest that may affect the conduct of prosecutions or related investigations;
- issuing guidelines to federal prosecutors;
- advising law enforcement agencies or investigative bodies on general matters relating to prosecutions and on particular investigations that may lead to prosecution;
- communicating with the media and the public on all matters respecting the initiation and conduct of prosecutions;
- exercising the authority of the Attorney General of Canada in respect of private prosecutions; and
- exercising any other power or carrying out any other duty or function assigned by the Attorney General that is compatible with the office of the Director.

When carrying out these statutory responsibilities, the Director is the Deputy Attorney General of Canada. Unless otherwise directed in writing by the Attorney General, the Director has the power to make binding and final decisions to prosecute offences under federal statutes.

A complaint was filed by Industry Task Force II on 2,4-D Research Data.

#### OCFP pesticide study triggered by complaint

The Ontario College of Family Physicians' conclusion that there are no safe pesticide exposure levels, which garnered unprecedented national coverage, was sparked by a pesticide industry lobby group's insistence that there is not enough evidence to support such warnings.

The OCFP launched an extensive review of pesticide literature more than 18 months ago after Industry Task Force II on 2,4-D Research Data, a US-based group, complained that warnings of harmful effects of pesticides included in an OCFP information pamphlet were inaccurate. (2,4-D is the most common active ingredient in lawn care herbicides.)

The complaint was a repeat of the usual arguments in the ongoing debate on pesticides, which the head of the OCFP describes as "an exercise in finger point-

ing," where one group cites a report warning of health effects and the other side cites another report indicating the results are inconclusive. The OCFP study was aimed at ending such discourse.

The study ([www.ocfp.on.ca](http://www.ocfp.on.ca)), funded by the non-profit Laidlaw Foundation, was not peer-reviewed or published. This is the first time a Canadian medical association has attempted to review the literature. Researchers examined 12 000 studies on the health effects of pesticides and drew conclusions from the 250 studies deemed to have the most solid methodology.

The review found "consistent evidence" of serious health risks, including brain, kidney, and prostate cancer, and reproductive and nervous system effects. For example, 3%–7.7% of cases of non-Hodgkin's lymphoma are attributable to exposure to phe-

noxyacetic acids and chlorophenols.

In addition, there was no evidence that some pesticides are less damaging than others. Rather, what differed were the effects and the time it took for them to appear.

"Our study showed that family doctors are right in advising patients to avoid exposures," says Jan Kasperski, CEO of the OCFP.

But Donald Page, Executive Director of the Industry Task Force II, attacked the findings in the media and online, charging that the conclusions are based on a "biased review" with unclear criteria for study selection. — *Pauline Comeau*, Ottawa

FORCE OF NATURE IS THE INSTRUMENT OF NATIONAL ORGANIZATION RESPONDING AGAINST HUJE THAT HARM THE GREEN SPACE INDUSTRY ( **NORAHG** ) BY CONCOCTING STATEMENTS AND ACTIVITIES SEEKING TO PROHIBIT FEDERALLY LEGAL, SCIENTIFICALLY SAFE, TOTALLY IRREPLACEABLE, AND ABSOLUTELY INDISPENSABLE CONVENTIONAL PEST CONTROL PRODUCTS. ENVIRO-MANIACS ARE IDENTIFIED ON THE BASIS OF THEIR STATEMENTS, ACTIVITIES, AFFILIATIONS, AND WHEREABOUTS.
