“Anthony Fauci, director of the National Institute of Allergy and Infectious Diseases, has been discovered to have granted the majority of the federal funds awarded to the University of Pittsburgh by the National Institute of Health for research involving aborted fetuses.”

“David Daleiden, project lead and founder of The Center for Medical Progress, told Townhall that, in 2019 alone, Fauci’s office awarded the University of Pittsburgh \$61 million of the \$109 million that they received from the NIH for research
